INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of Metalcraft, Inc. Employees' Profit Sharing and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(c) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(c), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(c).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the Metalcraft, Inc. Employees' Profit Sharing and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of Metalcraft, Inc. (the Company or Plan Administrator) who have one year of service and are age 18 or older. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Company has contracted with Principal Trust Company (Principal) to hold the Plan's assets, execute investment transactions, perform allocations of contributions and investment earnings, and make benefit payments.

Contributions

The Plan allows for employee contributions up to 50% of eligible compensation, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans (rollover). The Plan includes an automatic-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically-enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participant deferral rates are automatically increased 1% annually to a maximum of 10%. Additionally, the Plan provides for matching Company contributions equal to 25% of the participants' first 6% of contributions. Additional discretionary contributions may be made by the Company from time to time.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is increased or decreased by the participant's contributions, withdrawals and an allocation of Plan earnings, net of administrative expenses and an allocation of the Company's contributions. Allocations to participants are based on the funds selected by the participant, as defined in the agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon, Company matching, and discretionary contributions.

Notes Receivable, Participants

Participants are permitted to borrow from their account a minimum of \$500 up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. Outstanding loans are limited to two per participant at any given time, are secured by the balance in the participant's account, and bear a reasonable fixed interest rate, as determined by the loan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants may withdraw account balances related to their elective contributions and rollover contributions at any time. Account balances related to Company contributions may be withdrawn upon termination, unless noted below. A participant may withdraw a portion of his or her vested interest upon attaining age 55 while still employed by the Company. In addition, hardship distributions are permitted if certain criteria are met.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accrued benefits of all participants shall be distributed to participants as provided in the agreement.

Plan Transfers

Along with the Plan, the Company also sponsors a defined contribution employee stock ownership plan. Participants meeting certain eligibility requirements of the employee stock ownership plan may elect to diversify their account balance and transfer amounts into the Plan. For the year ended September 30, 2023, there were transfers to the Plan of \$63,147. There were no transfers for the year ended September 30, 2024.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the financial statements in accordance GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable, Participants

Notes receivable from participants are measured at the unpaid principal balance, plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023.

Contributions

Contributions from the Plan participants and the matching contributions from the Company are recorded in the year in which the participant's contributions are withheld from compensation.

Administrative Expenses

The cost of administering the Plan is paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Participants are responsible for certain transaction-related expenses. Certain investment-related expenses are included as a reduction of net appreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

NOTE 4 — FAIR VALUE MEASUREMENTS

GAAP establishes a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority): Level 1, defined as observable inputs such as quoted prices in active markets for identical assets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring the Plan to develop its own assumptions. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual funds: Valued based on quoted prices of identical assets in active markets.

Pooled separate accounts and stable value fund: The fair value of units held in pooled separate accounts and stable value fund are valued based on quoted redemption values, also known as net asset value (NAV), determined by using available market information and appropriate valuation methods, as provided by Principal and represent the value at which the Plan (or the participant) could initiate a transaction with Principal. There are no imposed redemption restrictions on participants, except for certain short-term trading restrictions, which prohibit participants from reinvesting into the same account within 30 days. Other than the U.S. Property Separate Account, there are no limitations on redemptions.

NOTE 4 — FAIR VALUE MEASUREMENTS (Continued)

The NAV of the Principal U.S. Property Separate Account is based on the underlying real estate assets, which are valued using discounted cash flow valuation models that utilize public real estate market data such as: transaction prices, market rents, vacancy levels, leasing absorption, market cap rates and discount rates. In addition, each property is appraised annually by an independent appraiser. Principal has the ability to apply a contractual limitation, which delays the payment of withdrawal requests (Withdrawal Limitation). At September 30, 2024 and 2023, the Withdrawal Limitation was in effect, and the Plan had \$127,194 and \$105,688 in outstanding distribution requests, respectively.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(a) Due to the Withdrawal Limitation applied on July 1, 2022, the Principal U.S. Property Separate Account utilized the NAV as a practical expedient to estimate fair value at September 30, 2024 and 2023. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. The Principal U.S. Property Separate Account has no unfunded commitments, allows daily redemptions when Withdrawal Limitation is not in effect, and has no required redemption notice period.

NOTE 5 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Principal. Principal is the recordkeeper and custodian for the Plan and provides investment advice to the Company as to the selection of investment options. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Therefore, these transactions with Principal qualify as party-in-interest transactions. A participant who acquires a participant loan is also a party-in-interest. However, all such transactions are exempt and are not prohibited by ERISA.

NOTE 7 — INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by Principal. Principal received a letter from the IRS, dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan and has concluded that as of September 30, 2024 and 2023, there have been no uncertain positions taken.

NOTE 8 — PROHIBITED TRANSACTIONS

During the years ended September 30, 2024 and 2023, the Company inadvertently failed to deposit participant deferrals and loan payments of \$47,573 and \$115,905, respectively, within the required timeframe as stated by the DOL. The DOL considers late deposits to be prohibited transactions. The Company made deposits into the Plan for lost earnings attributable to the delinquent contributions and loan payments to fully correct the prohibited transactions.

NOTE 9 — SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through July 14, 2025, the date the financial statements were available to be issued.
