- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about United Furniture Workers Insurance Fund's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of asset held for investment purposes and reportable transactions as of and for the year ended September 30, 2024 are presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following brief description of the United Furniture Workers Insurance Fund (the "Plan" or "UFW Insurance Fund") is provided for general information purposes only. Reference to the Plan document should be made for more complete information.

General - The Plan is a multiemployer plan which provides health, dental, death, and post-retirement benefits covering eligible participants under collective bargaining agreement (CBA) negotiated by local unions (Locals) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Administration of the Plan is the responsibility of the Board of Trustees and is governed by a joint board consisting of representation from the participating employers and the Union.

Eligibility. To become initially eligible for benefits, a participant must satisfy the initial employment requirement outline in the CBA with the participating employer, which also includes the requirement for employer contributions to the Plan. Once the eligibility requirements are met, certain eligible dependents are also covered under the Plan upon submission of the applicable enrollment form and supporting documents to the Plan Administrator.

Contributions - Employer contributions are made in accordance with the provisions of agreements entered into by the Plan and participating employers. Participant contribution rates are determined by the Plan's actuary. Participant contributions are allowed to provide Consolidated Omnibus Budget Reconciliation Act (COBRA) benefits, and participants pay the full cost of such benefits.

Benefits - The Plan provides health benefits (medical, vision, dental and prescription drugs), to participants and dependents as well as disability and death benefits for eligible participants. Eligible retired employees are entitled to similar health benefits (in excess of Medicare coverage). Additionally, the Plan provides similar benefits during periods of unemployment (accumulated eligibility credits), disability, or upon termination of employment through COBRA.

Insured Benefits. The Plan fully insures medical and dental for some selected Locals. The Plan purchases annual insurance contracts for these insured benefits.

Self-Insured Benefits. The majority of the medical benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Ultimate responsibility for payments to providers and participants is retained by the Plan. The Plan uses a pharmacy benefit manager (PBM), which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. For participants in selected Locals, self-insured claims are processed by the Plan.

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits.

Any postretirement benefit obligation is funded by employer contributions on a pay-as-you-go basis.

Note 2. Summary of Accounting Policies

Basis of Accounting and Use of Estimates - The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits – Premiums paid are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Claims paid by the claims processor prior to year-end or claim payments submitted to the Plan by the third-party claims processor that are not yet paid are recorded as an amount currently payable in the accompanying statements of benefit obligations. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

Refunds and Rebates - Prescription refunds due from the Plan's PBM are recorded when earned. Refunds due at year-end are recorded as a receivable on the statements of net assets available for benefits, with the offset being netted with claims paid. Prescription rebates totaling \$1,862,563 and \$1,580,019 have been netted against claims paid in the accompanying statement of changes in net assets available for benefits.

Stop Loss - Claims that were already paid from the Plan that exceeded the stop-loss coverage and are due to the Plan at year-end are recorded as a receivable. Premiums for stop-loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop-loss refunds totaling \$461,977 and \$2,543,928 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Employer Contributions and Related Receivable – Contributions receivable are reported at their outstanding balances net of an estimated reserve for doubtful accounts and are primarily composed of balances due from employers. The Plan estimates doubtful accounts based on historical bad debts, factors related to specific employers' or groups of participants' ability to pay, and current economic trends and conditions.

Cash and Cash Equivalents - The Plan considers all highly liquid investments available for current use with an initial maturity of three months or less to be cash and cash equivalents.

Investments Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's board of trustees determines the Plan's valuation policies and procedures. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Summary of Accounting Policies (continued)

Property and Equipment - Property and equipment, which is predominately used in operations, is stated at cost, less accumulated depreciation or amortization. Depreciable assets are depreciated principally by the straight-line basis over the estimated useful lives ranging from three to seven years. Expenditures for maintenance and repairs are expensed as incurred, whereas additions and improvements that extend the life of the asset are capitalized.

Fees and Other Expenses - The Plan shares certain administrative expenses with related entities. In computing these allocated costs, various factors were considered, including the time spent, space used, costs incurred, and volume of transactions relating to the Plan in relation to the various other entities administered by the Plan Administrator. (See Note 10.) These expenses are reported in administrative expenses on the statement of changes in net assets available for benefits. The Plan also pays administrative fees to third-party claims administrators. These expenses are recorded when incurred and reported in claims processing and other fees on the statement of changes in net assets available for benefits. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events - The Plan has evaluated events and transactions that occurred through July 14, 2025, the date the financial statements were available to be issued.

New Accounting Pronouncements Adopted - In February 2016, the Financial Accounting Standards Board (FASB) issued Accounting Standard Update (ASU) No. 2016-02, *Leases* (Topic 842). This guidance is intended to increase transparency and comparability among organizations by recognizing lease assets and lease liabilities on the statement of net assets available for benefits and disclosing key information about leasing arrangements. This standard requires lessees to report a right-of-use (“ROU”) asset along with a lease liability. The standard and related provisions were adopted by the Plan beginning October 1, 2022.

Effective January 1, 2023, the Plan adopted ASU No. 2016-13, *Financial Instruments – Credit Losses* (Topic 326): Measurement of Credit Losses on Financial Instruments. This ASU provides financial statement users with more decision-useful information about the expected credit losses on financial instruments and other documents to extend credit held by a reporting entity.

Upon evaluation, the management has determined that these standards have no impact on its financial statements.

Note 3. Postretirement, Accumulated Eligibility Credits and Postemployment Benefit Obligations

The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered to September 30, 2024 and 2023, respectively. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and (2) active employees after retirement from service with the participating employers. Prior to an active employee's full eligibility date, postretirement benefit obligations is the portion of the expected postretirement benefit obligations that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligations is determined by the Plan's actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claim costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The following were other significant assumptions used in the valuations as of the Plan years ended September 30, 2024 and 2023.

The weighted-average health care cost-trend assumption has a significant effect on the amounts reported as postretirement benefit obligations. If the assumed rates increased by one percentage point, it would increase the obligation by \$2,640,000 and \$2,396,000 as of September 30, 2024 and 2023, respectively.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The postemployment benefit obligation has been recognized for health benefits for individuals currently on COBRA. The obligation for these benefits is estimated by an actuary based on the actual number of members utilizing COBRA benefits as of the measurement date and claim payment history and includes an estimate for claims incurred by COBRA participants that have not been reported.

Note 4. Claims Incurred But Not Reported

Benefit obligations other than postretirement and postemployment benefit obligations include health claims currently payable, health claims incurred but not yet reported, and premiums payable. Claims paid by the claims processor prior to the year-end that are not reimbursed by the Plan as of year-end are recorded as claims payable and included in claims payable and claims incurred but not reported on the statements of benefit obligations. Premiums not yet paid by the Plan related to coverage at or before year-end are included in premiums due to insurers in the statement of benefit obligations.

Claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by Plan's third-party claims administrators. These claims are paid by the Plan only if claims are submitted and approved for payment.

Note 5. Fair Value Measurements

The framework for measuring fair values provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the value of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 7. Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2023 for unrelated business taxable income. The Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the appropriate taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Priorities Upon Termination of the Plan

Although the board of trustees has not expressed intent to discontinue the Plan, they may do so at any time subject to the provisions of ERISA and the terms of the CBA. In the event of termination of the Plan, the assets of the Plan would continue to be used to pay reasonable administrative expenses and to distribute and apply remaining surplus as the trustees so determine, until no assets remain.

Note 9. Plan Amendments

There were no significant plan amendments during the years ended 2024 and 2023.

Note 10. Related Party and Parties-In-Interest Transactions

The Plan reimburses various locals for Insurance Fund related administrative expenses pursuant to guidelines established by the Department of Labor. This amounted to \$331,256 and \$328,567 for the years ended September 30, 2024 and 2023, respectively.

The Plan has the following related entities:

- United Furniture Workers Pension Fund A
- United Furniture Workers Successor Pension Fund
- Pension Plan for Employees of the United Furniture Workers of America
- United Furniture Workers of America, AFL-CIO Building Corporation (“UFW Building Corp.”)

All of the above entities qualify as tax-exempt organizations. The entities listed above share some common trustees with the Plan as well as facilities and staff.

The Plan and other related entities occupy space in the building owned by the UFW Building Corp. Each tenant bears its own pro rata share of the operating costs of said building.

Rent and related expense allocated to the Plan by the UFW Building Corp. amounted to \$199,568 and \$185,329 for the years ended September 30, 2024 and 2023, respectively.

The Plan and other related entities share administrative staff. The payroll expenses allocated to the Plan as per their share amounted to \$11,548 and \$21,323 for the years ended September 30, 2024 and 2023, respectively.

Fees paid during the years ended September 30, 2024 and 2023 for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 11. Participation in Multiemployer Plans

United Furniture Workers Insurance Fund contributes to two multiemployer defined benefit pension plans, under the terms of a collective-bargaining agreements that cover its union-represented employees. The risks of participating in these multiemployer plans are different from single-employer plans in the following aspects:

- Assets contributed to the multiemployer plan by one employer may be used to provide benefits to employees of other participating employers.
- If a participating employer stops contributing to the plan, the unfunded obligations of the plan may be borne by the remaining participating employers.
- If United Furniture Workers Insurance Fund chooses to stop participating in either multiemployer plan, United Furniture Workers Insurance Fund may be required to pay the multiemployer plan an amount based on the underfunded status of the multiemployer plan, referred to as a withdrawal liability.

United Furniture Workers Insurance Fund's participation in the multiemployer plans for the year ended September 30, 2024 and 2023 is outlined in the table below. The "EIN/Pension Plan Number" column provides the Employer Identification Number and the three-digit plan number, if applicable. Unless otherwise noted, the most recent Pension Protection Act (PPA) zone status available in 2024 and 2023 is for the Plan's year ended at September 30, 2024 and 2023, respectively. The zone status is based on information that United Furniture Workers Insurance Fund received from each multiemployer plan and is certified by each plan's actuary. Among other factors, plans in the red zone are generally less than 65 percent funded, plans in the yellow zone are less than 80 percent funded, and plans in the green zone are at least 80 percent funded. The "FIP/RP Status" column indicates plans for which a financial improvement plan ("FIP") or a rehabilitation plan ("RP") is either pending or has been implemented. The last column lists the expiration date of the collective-bargaining agreement to which the plans are subject. Finally, the number of employees covered by United Furniture Workers Insurance Fund's multiemployer plans decreased.

Note 12. BlueCross BlueShield of Tennessee

The Plan entered into an administrative service agreement with BlueCross BlueShield of Tennessee, Inc. (the “Blues”) which allowed the membership of the Plan to use the Blues network of medical providers. The Plan paid \$1,531,360 and \$1,672,833 for the years ended September 30, 2024 and 2023, respectively, for these services.

Note 13. Risks and Uncertainties

Investments

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The majority of the Plan’s net assets are invested in Mutual Funds (“MFs”). At September 30, 2024 and 2023, approximately 90% and 86% of the Plan’s net assets available for benefits are investments in MFs, which amounted to \$33,269,360 and \$30,627,656, respectively.

Benefit Obligations

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Concentration of Cash

Cash consists of monies held in noninterest bearing accounts. The Plan places its cash with a financial institution deemed to be creditworthy. Balances are insured by the Federal Deposit Insurance Corporation up to \$250,000. At September 30, 2024 and 2023, the Plan’s cash exceeded federally insured limits by approximately \$3,589,172 and \$4,755,000, respectively. The management performs ongoing evaluations of the commercial banks to limit its concentration of risk exposure. The Plan has not experienced any loss in such accounts. Management believes that the Plan is not exposed to any significant risk on its cash.

Significant Participating Employers

Contributions received from two employers approximates 30% and 31% of the total contributions for the years ended September 30, 2024 and 2023, respectively. In the event these employers were to suspend contributions, the Plan would retain the risk of meeting its current obligations until the appropriate adjustments were made

Note 14. U.S. Department of Labor Audit

The United States Department of Labor is conducting an audit of the UFW Insurance Fund's compliance with Part 4 and Part 7 of Title I of ERISA.

With respect to the Part 4 aspect of its audit, the DOL notified the Fund of certain potential violations. The Fund responded to the various questions and concerns identified by the DOL. The Fund is waiting for any additional official or formal notice relating to this aspect of DOL's investigation.

With respect to the Part 7 aspect of its audit, the DOL audit is ongoing and no potential violations have been identified to date.
