INDEPENDENT AUDITORS' REPORT

To the Board of Directors

Opinion

We have audited the accompanying financial statements of Alabama Farmers Cooperative, Inc. Employees' Welfare Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in benefit obligations and net assets available for benefits the year ended September 30, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the statements of benefit obligations and net assets available for benefits of Alabama Farmers Cooperative, Inc. Employees' Welfare Benefit Plan as of September 30, 2024 and 2023, and the statement of changes in benefit obligations and net assets available for benefits for the year ended September 30, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of Alabama Farmers Cooperative, Inc. Responsibilities of Management for the Financial Statements

1. DESCRIPTION OF THE PLAN

The following description of the Alabama Farmers Cooperative, Inc. Employees' Welfare Benefit Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan and related trust were established on October 1, 1981, to provide health and other benefits to substantially all employees and dependents of Alabama Farmers Cooperative, Inc. and its affiliates (the Sponsor) and former employees electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions. Blue Cross and Blue Shield of Alabama (the Claims Administrator) controls and manages the operations and claims administration of the Plan. Effective January 1, 2021, the Plan became fully insured for medical benefits through Blue Cross Blue Shield of Alabama. Dental claims are self-insured.

The Plan covers all regular, full-time and part-time employees who have completed a 30-day service requirement and are age 17 or older.

Benefits

The Plan provides hospital, dental, surgical and major medical benefits, basic group term life, accidental death and dismemberment, short-term and long-term disability insurance to covered employees, their beneficiaries or covered dependents. Hospital, surgical and major medical benefits are fully insured and offer Plan participants coverage under three programs offered by the Claims Administrator. The Plan is self-insured for dental claims and offers Plan participants two programs to elect from. Dental claims are processed and paid by the Claims Administrator and then reimbursed by the Plan. Basic group term life, accidental death and dismemberment, short-term and long-term disability benefits are fully insured through Life Insurance Company of North America.

Contributions

The Plan is an employer/employee shared cost plan. The Plan Agreement authorizes the Sponsor to make monthly medical and dental contributions to the Plan as determined by the Sponsor's Board of Directors annually. Participating employees will pay a weekly or bi-weekly contribution for health and dental coverage. The Sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates that affect the reported amounts of assets and liabilities, benefit obligations and changes

therein, claims payable and claims incurred but not reported, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Sponsor determines the Plan's valuation policies utilizing information provided by the custodian of the Plan. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Premiums paid by either the Sponsor or trust are recorded as premium payments in the accompanying statement of changes in benefit obligations and net assets available for benefits. Payments for claims and premiums are recorded when paid.

Expenses of the Plan

Claims service fees are paid directly from the Plan to the Claims Administrator. Certain professional fees are also paid by the Plan while substantially all of the Plan's other administrative expenses are paid on behalf of the participants by the Sponsor and are not reflected in the accompanying financial statements.

Income Taxes

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by its taxing jurisdiction; however, there are currently no audits from any tax periods in progress.

Concentration of Credit Risk

The Plan places its temporary cash investments with federally insured financial institutions. At various times throughout the year ended September 30, 2024, temporary cash investment balances held at financial institutions were in excess of federally insured limits. However, the Plan has not experienced any losses in such accounts, and management believes the Plan is not exposed to any significant credit risk on these accounts.

Subsequent Events

The Plan administrator has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the accounting standards are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan's assets measured at fair value consist of interest-bearing cash and are valued based on cost, which approximates fair value. There have been no changes in the methodology used at September 30, 2024 and 2023.

4. TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the trust's net investment income is exempt from income taxes. The trust has obtained a favorable tax determination letter from the Internal Revenue Service dated May 17, 1990, and the Sponsor believes that the trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the IRC as designed. Management evaluated the Plan's tax position and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income tax has been included in the financial statements.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

6. PARTY-IN-INTEREST TRANSACTIONS

As described in Note 2, the Plan pays various fees for claims processing associated with the administration of the Plan. These fees are considered party-in-interest transactions and are reflected in the financial statements as administrative expenses.
