**NOTE A – SUMMARY DESCRIPTION OF PLAN**

The following description of the Provost & Pritchard, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution 401(k) Profit Sharing Plan covering substantially all full-time employees of Provost & Pritchard, Inc., who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

***Contributions***

Each year, participants may contribute a portion of pre-tax compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement Plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company makes a safe harbor nonelective contribution of 3 percent of eligible compensation. The Company may also make discretionary matching, discretionary nonelective, and qualified nonelective contributions. Discretionary matching contributions, if any, are limited to 4 percent of eligible compensation contributed to the Plan. Participants must complete at least 1,000 hours of service during the plan year and be employed as of the last day of the Plan year to be eligible to receive any discretionary nonelective contributions that may be made for the Plan year. The Company made a safe harbor nonelective contribution of \$896,116 and a discretionary nonelective (profit sharing) contribution of \$290,000 for the year ended September 30, 2024. Contributions are subject to certain IRS limitations.

***Investment Options***

Plan participants direct the investment of their account balances into various investment options offered by the Plan. Participants can change their investments at any time. The Plan currently offers various registered investment companies and money market accounts as investment options for participants.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company safe harbor contribution, as well as allocations of the Company's discretionary matching contributions (if any), and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are vested immediately in their contributions, Company safe harbor nonelective contributions and qualified nonelective contributions plus actual earnings thereon. Vesting in the Company discretionary matching and nonelective (profit sharing) contributions are based on years of continuous service. A participant is 100 percent vested after six years of credited service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% as determined periodically by the Plan administrator. Principal and interest is paid ratably through payroll deductions on at least a quarterly basis. Generally, the term of the loan may not exceed five years.

***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant will receive a lump sum amount equal to the value of the participant's vested interest in their account. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution. Assets allocated to participants who have terminated but have not withdrawn from the Plan as of September 30, 2024 total \$5,244,554.

***Forfeited Accounts***

At September 30, 2024 and 2023, forfeited non-vested accounts totaled \$88 and \$47, respectively. These accounts may be used to pay the administrative expenses of the Plan or to reduce future employer contributions. In 2024, employer safe harbor and discretionary nonelective contributions were reduced by \$25,720 from forfeited nonvested accounts.

***Basis of Accounting***

The financial statements of Provost & Pritchard, Inc. 401(k) Profit Sharing Plan are prepared on the accrual basis of accounting.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by Fidelity Management Trust Company. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of September 30, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

***Payment of Benefits***

Benefits are recorded when paid.

***Administration Expenses***

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the independent advisors and administration of notes receivable from participants are included in administrative expenses and charged directly to the participant’s account. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

***Management’s Review of Subsequent Events***

Management has evaluated subsequent events through July 15, 2025, the date the financial statements were available to be issued.

**NOTE C – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The following information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule of assets held at end of year was obtained or derived from information supplied to the Plan administrator and certified to as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

**NOTE D – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued at cost, which approximates fair value.

**NOTE E – FULLY BENEFIT-RESPONSIVE INVESTMENT**

The Plan offers a fully-benefit responsive stable value fund investment through Managed Income Portfolio II (MIP2), with custodial services provided by Fidelity Management Trust Company (FMTC). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be adjusted to less than zero.

**NOTE E – FULLY BENEFIT-RESPONSIVE INVESTMENT – (Continued)**

The stable value fund meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by FMTC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the Plan's ability to transact at contract value with MIP2. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (a) an uncured violation of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a breach of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**NOTE F – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to a third-party investment advisor for Plan advisory services totaling \$9,041 and to Fidelity Management Trust Company totaling \$2,837, which was offset by \$5,500 of revenue sharing.

All these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE G – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE H – TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and believes that as of September 30, 2024 and 2023 there are no significant uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by federal taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE I – RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.
