Opinion

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the GSA-ILA Container Royalty Trust provides only general information. Participants should refer to the Trust Agreement for a more complete description of the provisions thereunder.

General

The Trust was formed pursuant to the Collective Bargaining Agreement between certain employers and Local 1303 ILA of Gulfport, Mississippi. Employees of an Employer working in the deep-sea longshore and related crafts who worked no less than 700 hours in the contract year immediately prior to the payment are eligible under the terms of the Trust and in accordance with the Master Contract. Applicable provisions of the Master Contract and Collective Bargaining Agreement for the Port of Gulfport, Mississippi are incorporated in the Trust Agreement.

Royalty Contributions

Contributions shall be remitted and paid in such amounts to the Trust in accordance with the Collective Bargaining Agreement and the Master Contract in such intervals as prescribed thereunder. The obligation to make Contributions to the Trust shall continue for the entire term of the applicable Collective Bargaining Agreement and Master Contract. In accordance with the Master Contract, contributions are collected and remitted to the Trust by the Container Royalty Centralized Collection Fund, as agent of the Trust, in accordance with the terms thereunder. Delinquencies and interest thereon shall be pursued by Container Royalty Centralized Collection Fund, as agent for the Trust.

In accordance with the Master Contract, one-third of all Plan royalty contributions are to be used exclusively for the purposes of funding related healthcare programs. Accordingly, transfers in accordance with the terms of the Collective Bargaining Agreement will be made at such intervals as prescribed after all administrative expenses incurred have been paid to the GSC-ILA Welfare Plan.

Contributions and Royalty Payments to Eligible Employees

Each Fiscal Year, the Trustees disburse royalty payments to Eligible Employees in accordance with the terms of the Collective Bargaining Agreement at such intervals as prescribed thereunder after all administrative expenses incurred have been paid.

Plan Termination and Discontinuance

The Trustees reserve the right to terminate the Trust as permitted under the applicable Collective Bargaining Agreement or Master Contract, upon majority consent and written instrument executed by the Trustees, at any time and for any reason permitted by law. In the event of termination, the Trustees shall notify the Association, Employers, Union, Eligible Employees and all other applicable interested parties.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates

The presentation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and disclosures of assets and at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results may differ from those estimates.

Allowance for doubtful accounts

The Plan's receivables consist primarily of royalty contributions which are normally collected within thirty days of invoicing. When a receivable's collectability is impaired, the Plan reserves the receivable until payment is received or charged-off. The Board of Trustees believes that all receivables are collectible; thus, there is no allowance for doubtful accounts recorded at September 30, 2024 and 2023.

Administrative expenses

Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Subsequent events

The Plan has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued.

NOTE 3 – TAX STATUS

The Internal Revenue Service issued a determination letter dated March 9, 1979 that the Trust established to hold assets of is designed as a tax-exempt under Section 501(c)(9) of the Internal Revenue Code. The Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not sustain upon examination by the Internal Revenue Service. The Board of Trustees and the Administrative Manager have analyzed the tax positions taken by the Plan and have determined that the Plan had no uncertain tax positions requiring financial statement recognition or disclosure for the years ended September 30, 2024 and 2023. The plan is subject to audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Board of Trustees and the Administrative Manager believe it is no longer subject to income tax examinations prior to September 30, 2021.

NOTE 4 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan is affiliated with the GSC-ILA Pension Plan, Welfare Plan, Vacation Plan, and Defined Contribution Plan. All Plans are administered by the same Administrative Manager, and the Boards have common trustees. During the years ended September 30, 2024 and 2023, the Plan contributed member benefits for manhours worked by container inspectors of \$68,078 and \$68,078, respectively, to the Pension, Welfare and Vacation Plans.

Container inspector benefits balances due to the Welfare, Vacation, and Defined Contribution Plans at September 30, 2024 and 2023 totaled \$101,949 and \$50,885, respectively. Additionally, the Plan was owed \$26,501 and \$32,779 by the GSC-ILA Pension Plan at September 30, 2024 and 2023, respectively.
