INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan of Community Living Options, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan of Community Living Options and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan of Community Living Options' ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

1. DESCRIPTION OF PLAN:

The following description of 403(b) Thrift Plan of Community Living Options (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan covering all associates, subject to certain exclusions as defined, of Community Living Options (the Employer, or the Company). Entrance dates for newly eligible employees in the Plan is the first pay period after their hire date. For Employer contributions, participants must be at least eighteen years of age and the entrance dates for new participants is the first day of the month coinciding with or immediately following the employee meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 100% of their base pay subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). Participants may also contribute Roth elective deferrals and amounts representing distributions from other qualified retirement plans (rollover contributions). Participants who have attained age 50 can make catch-up contributions. Participants with fifteen years of service can make special Code 403(b) catch-up contributions.

The Plan provides for a discretionary Employer matching contribution and an annual discretionary contribution to the Plan. For the years ended September 30, 2024 and 2023, the Employer made a discretionary Employer matching contribution equal to 50% of the participant's deferral that did not exceed 6% of the participant's eligible compensation. Additionally, the Employer elected to make annual discretionary contributions of \$150,420 and \$134,103 for the years ended September 30, 2024 and 2023, respectively.

Participant accounts

Individual account balances are maintained for each participant. Each participant's account is credited with the participant's contributions, related Employer matching contributions, and an allocation of the Employer's annual discretionary contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan's investments are participant-directed.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer discretionary matching and annual discretionary contribution portion of their accounts plus actual earnings thereon is as follows:

Forfeitures

Forfeitures may be used to pay certain Plan expenses or to reduce future Employer contributions to the Plan. If a participant terminates employment and subsequently is re-employed, the forfeited account will be restored if the break in service did not exceed five years. For the years ended September 30, 2024 and 2023, forfeitures of \$5,116 and \$11,556, respectively, were used to reduce Employer contributions. Forfeited non-vested accounts totaled \$0 at September 30, 2024 and 2023.

Payment of benefits

Upon termination of service, death, disability, or retirement, or reaching age 59 1/2, distributions may be made to the participant or beneficiary in a single lump sum payment or any other method of payment permitted by the Plan. Normal retirement is at age 65; however, the Plan also provides for early retirement upon attaining age 55. A participant may also elect to withdraw before tax contributions in the event of financial hardship, as defined by the Plan.

Plan loans

A participant may borrow from their account up to limits as defined in the Plan document. Loans are collateralized by the participant's account balance and bear interest at market rates at the time the loan is taken out. Such loans are obtained directly from Mutual of America and are collateralized by a portion of the participant's account balance. Upon the execution of the plan loan agreement, a portion of the participant's account balance is transferred to into the guaranteed interest contract offered by Mutual of America. Loan repayments are made by the participant directly to Mutual of America. As loan payments are received by Mutual of America, a portion of the funds held as collateral are released.

Defaults are determined in accordance with the terms of the plan loan agreement between Mutual of America and the participant. Upon default, the Plan loan becomes taxable to the participant; however, the collateral remains in the participant's account until the participant reaches a distributable event such as retirement or termination. Plan loans outstanding at September 30, 2024 and 2023 were \$13,963 and \$26,096 respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements are prepared on the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment value and recognition

The Plan's investments are valued at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to administration of distributions are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in net appreciation in fair value of investments.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN:

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company (MOA), the custodian, has certified to the completeness and accuracy of all investments reflected on the accompany statements of net assets available for benefits as of September 30, 2024 and 2023 and the supplemental schedule of assets (held at end of year) as of September 30, 2024 and the related investment activity reflected in the statements of changes in net assets available for the years ended September 30, 2024 and 2023.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT:

The Plan has a fully benefit-responsive group annuity investment contract issued by MOA. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan.

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MOA, represents contributions made under the contract, plus earnings at the guaranteed interest rates, less participant withdrawals, transfers and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

By definition, this guaranteed investment contract is an insurance contract. As a result, the Plan may transact according to the terms defined in the contract at any time, however, certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the early termination of the contract prior to MOA's recovery of start-up costs. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The investment contract can be terminated prior to the scheduled maturity by the Employer or MOA as long as notice given thirty days in advance with written notification. MOA can only discontinue if the Employer fails to remit payment of administrative charges, fails to meet the requirements of the contract, the class of group annuity contracts to which the contract belongs is discontinued or the parties elect to not utilize appropriate media to transmit and receive information and data with respect to this contract.

5. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in methodology used at September 30, 2024 and 2023.

Pooled separate accounts: The pooled separate accounts are invested in investments such as stocks, mutual funds, short-term investments, bonds, etc. MOA owns the underlying investments in the separate accounts. The net asset value of the pooled separate accounts is determined based on the quoted prices of underlying investments and is published daily. Accordingly, the fair values of the referenced accounts are reported at Level 2. The investment strategies for the pooled separate accounts are focused on capital appreciation and long-term growth.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value, as of September 30, 2024 and 2023. 6. RELATED PARTY AND PARTY-IN-TRANSACTIONS:

Certain Plan investments are managed by the custodian, as defined in the Plan, and therefore these transactions qualify as party-in-interest transactions.

7. RISKS AND UNCERTAINTIES:

The Plan provides for various investment options in any combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Employer contributions.

9. INCOME TAX STATUS:

The Plan adopted a volume submitter plan which received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. While the Company has not obtained its own determination letter on the Plan and although the Plan has been amended since receiving the opinion letter, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

11. PLAN AMENDMENT – CARES ACT:

On March 27, 2020, the U.S. Congress passed the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provided temporary relief for retirement plan sponsors and their participants with respect to distributions and participant loans during 2020. The provisions of the CARES Act could be effective and operationalized immediately, prior to amending the plan document. The Plan Administrator has adopted the distribution relief provisions included in the CARES Act which permitted qualified individuals to request a pre-approved distribution, through participant self-certification of eligibility. The maximum dollar amount that could be requested per participant was \$100,000 up through December 30, 2020. The Organization intends to formally amend the Plan before the end of the applicable remedial amendment period to reflect such provisions.

12. SUBSEQUENT EVENTS:

The Plan has evaluated subsequent events through July 15, 2025, which is the date the financial statements were available to be issued.
