Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of F.L. Crane & Sons, Inc. 401K Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of F.L. Crane & Sons, Inc. 401K Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the F.L. Crane & Sons, Inc. 401(K) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of F.L. Crane & Sons, Inc. who have met certain service and eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute up to 15% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company determines its matching percentage at the beginning of each plan year. Currently, the Company matches 100% of the first 3% and 50% of the next 2% of the participant's compensation. For years prior to October 1, 2008, the matching contribution was invested 100% in Company stock. Effective October 1, 2008, the matching contribution was changed to a cash match that is allocated among the investment options according to each participant's instructions. Additional amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Loans

Loans to participants are not permitted under the Plan.

Payment of Benefits

On termination of service due to death, disability, or retirement a participant may elect to receive a single lump-sum amount equal to the value of the participant's vested interest in his or her account, purchase an annuity, or installments over a period of not more than their assumed life expectancy (or their and their beneficiaries assumed life expectancies) determined at the time of distribution.

Forfeited Accounts

Forfeited excess match and nonvested accounts may be used to reduce future employer contributions. At September 30, 2024 and 2023, forfeited excess Safe Harbor Match amounts totaled \$5,100 and \$4,873, respectively. These accounts will be used to reduce future employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

All Plan investments as of September 30, 2024 and 2023 are held by the Trustee and reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued at quoted market prices that represent the value of shares held by the Plan at year end. Common collective trust funds are reported at fair value using net asset value per share (or its equivalent) as a practical expedient. Plan management determines the Plan's valuation policies. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Administrative expenses consist primarily of accounting and legal fees and the custodial costs of servicing the Plan. During the years ended September 30, 2024 and 2023, significant administrative costs were also absorbed by the Company.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at September 30, 2024 and 2023.

Mutual funds – Valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trust funds – Reported at fair value using net asset value per share (or its equivalent) as a practical expedient and not classified in the fair value hierarchy in accordance with ASC Subtopic 820-10. The fair values presented in the hierarchy tables are intended to permit reconciliation of the fair value hierarchy to the investments at fair value as presented in the Statements of Net Assets Available for Benefits.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 3 – FAIR VALUE MEASUREMENTS - continued

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended September 30, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3. There were no assets valued at fair value using level 3 at September 30, 2024 and 2023.

NOTE 4 - PLAN REESTABLISHMENT

The Company transferred all of the assets of the Plan on November 8, 2000 to a multi-employer plan under the provisions of ERISA. Effective August of 2002, the Company transferred all assets from the multi-employer plan back into the F.L. Crane & Sons, Inc. 401(k) Plan.

NOTE 5 – INVESTMENT CONTRACT

As of September 30, 2024 and 2023, the Plan maintained one GIC related investment, the Ameritas Guaranteed Investment Account issued by Ameritas Life Insurance Corporation (a party-in-interest). The contract underlying this investment option is considered to be fully-benefit responsive in accordance with ASC Topic 962. As of September 30, 2024 and 2023, the contract value of the investment in the Ameritas Guaranteed Investment Account was \$1,310,490 and \$1,042,530, respectively.

The average yield based on actual interest credited to participants for the contract year ended September 30, 2024 and 2023 was 3.63% and 2.89%, respectively. The crediting interest rates to participants for the contract as of September 30, 2024 and 2023 was 3.75% and 3.50%, respectively. The guaranteed minimum crediting interest rates for the contract for the year ended September 30, 2024 and 2023 was 4.25% and 4.80%. Ameritas Life Insurance Corporation makes this guarantee, and although Ameritas Life Insurance Corporation may credit a higher interest rate, the credited rate will not fall below the lifetime guarantee minimum of 4.25% and 4.80%.

Ameritas Life Insurance Corporation's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market valuation adjustment may apply to amounts withdrawn at the request of the contract holder.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include changes to plan provisions and changes to the Plan's prohibition on competing investment or equity wash provisions. The Plan Administrator does not believe that the occurrence of any such event which would limit the Plan's ability to transact at contract value with participants is probable.

The Ameritas Life Insurance Corporation has the option to payout the current value of the contract only after the completion of five contract years.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 - TAX STATUS

The plan obtained its latest determination letter on November 19, 2001, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan has been amended since receiving the determination letter. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the plan's financial statements. The Plan's open tax years for the prior three years are subject to examination by the Internal Revenue Service.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN OF THE PLAN

The following information included in the accompanying financial statements was obtained from data that has been prepared and certified to as complete and accurate by the custodian of the Plan.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 - RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Plan investments include units of funds managed by Ameritas Life Insurance Corporation. Ameritas is the Plan asset custodian; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$63,736 and \$48,919 for the years ended September 30, 2024 and 2023, respectively.
