The liability under the unit credit cost method is the value of the accrued pension benefit using service and pay as of the valuation date. The sum of the present value of the accrued benefits for all participants is the ERISA funding target. The normal cost is the present value of the benefits earned during the year. The target normal cost is the sum of the normal costs for all participants and the assumed administrative expenses.

Changes in Method from Prior Year and Rationale for Changes

There was a change both in the enrolled actuary for the plan and in the business organization providing actuarial services to the plan. The conditions for automatic approval, as outlined in Revenue Procedure 2017-56, were satisfied.

There was a change in the valuation date used between 2023 and 2024. The date was changed from the beginning of year to the end of year, December 31, 2024. The conditions for automatic approval, as outlined in Treasury regulation section 1.430(a)-1(b)(5), were satisfied.
