Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the StriVectin Operating Company Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. - the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Plan Merger and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Plan sponsor approved a plan of merger on September 29, 2023. Management determined liquidation was imminent. As a result, the Plan used the liquidation basis of accounting to present the 2024 and the 2023 financial statements. Our opinion is not modified with respect to this matter. The merger is complete.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1 - DESCRIPTION OF PLAN

StriVectin Operating Company and its affiliate Niadyne, Inc. (collectively, the Company) established the StriVectin Operating Company Inc. 401(k) Profit Sharing Plan and Trust (the Plan) on January 1, 2010. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Merger

The governing body of the Plan approved a plan of liquidation on September 29, 2023. As a result, the net assets of the Plan were transferred to the Crown Laboratories, Inc. 401(k) Profit Sharing Plan on September 18, 2024. From September 16, 2024 to September 30, 2024, there was a blackout period for the Plan. The Plan was formally terminated on September 30, 2024. As such, the liquidation basis was used for both periods presented.

General

The Plan was a defined contribution plan covering all employees of the Company who have reached the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants could contribute up to 92% of pre-tax annual compensation, as defined in the Plan, and in accordance with applicable sections of the Internal Revenue Code. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered a fixed account and several mutual funds as investment options for participants.

Participants who completed six months of service received an employer matching contribution up to 4% of eligible compensation. The Company, at its discretion, made employer discretionary contributions. The Company did not make any discretionary contributions during the nine months ended September 30, 2024, or the year ended December 31, 2023. Contributions were subject to certain limitations.

Participant Accounts

Each participant's account was credited with the participant's contribution, the Company's contribution match and a pro rata share of all income earned by the participant's investments. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Vesting

Participants were vested immediately in their own contributions and any actual earnings thereon. Participants are 100% vested in employer matching contributions and any employer discretionary contributions after two years of service (with a minimum of 1,000 hours of service each year). There were no discretionary contributions made as of September 30, 2024 or December 31, 2023.

Forfeitures

Forfeitures may be used to reduce the Company's contributions or to pay administrative expenses of the Plan. Unallocated forfeitures were \$0 and \$14,503 as of September 30, 2024 and December 31, 2023. During 2024 and 2023, \$0 of forfeitures were used to reduce the Company's contributions, respectively.

Notes Receivable from Participants

Participants could borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, with a \$1,000 minimum. Loan terms range from one to ten years; however, terms for loans used for the purchase of a home may be extended, subject to certain limitations. The loans were secured by the balance in the participant's account and bore interest at rates of 4.25% to 9.50%. Delinquent loans were reclassified as distributions in accordance with the Plan document.

Payment of Benefits

On termination of service due to termination, death, disability, or retirement, a participant could elect to receive a lump-sum amount, or a rollover amount equal to the value of the participant's vested interest in his or her account. Participants who had met certain age requirements could receive benefits while still employed. Additionally, hardship distributions were permitted if the participant met certain hardship criteria.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value, except for the Key Guaranteed Portfolio Fund, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Contract value was the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to a benefit-responsive investment contract because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for a discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Operating Expenses

Administrative expenses were paid by either the Plan or the Plan's Sponsor, as provided by the Plan document.

NOTE 3 - FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets.

Level 2

Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the reporting periods.

Mutual Funds: Fair value is based on unadjusted quoted prices in active markets. Mutual funds held by the Plan are open-end funds registered with the Securities and Exchange Commission. These funds report their net asset value (NAV) at the close of each business day.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan offers a guaranteed interest account as an investment option. This account is a traditional fully benefit-responsive investment contract provided through a group annuity contract between the Plan and Great-West Life & Annuity Insurance Company (Empower). Empower maintains the contributions in a general account.

Because the guaranteed account with Empower is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributed to the guaranteed account. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus credited interest, less participant withdrawals and administrative fees. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

Under this group annuity contract with Empower, a crediting rate is established for a specified period of time and contributions invested in the guaranteed account are credited with that rate. Empower typically reestablishes the guaranteed rate semiannually.

Certain events may limit the ability for the Plan to transact at contract value with the contract issuers, such as premature termination of the contracts and Plan termination or merger. In addition, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and participants. In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value, such as an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contracts, a material misrepresentation, and a material amendment to the agreements without the consent of the issuers.

NOTE 5 - RELATED-PARTY TRANSACTIONS

Certain Plan investments were managed by Empower Trust Company, LLC, the certifying entity of the Plan. These transactions qualify as party-in-interest transactions. During years 2024 and 2023, fees paid by the Plan for administrative services were \$41,111 and \$42,339, respectively.

NOTE 6 - TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - TRUSTEE CERTIFICATION

The following is a summary of the unaudited information included in the Plan's financial statements that were prepared or derived from information prepared by Empower Trust Company, LLC, the certifying entity, and furnished to the plan administrator. The plan administrator has obtained a certification from the certifying entity that such information is complete and accurate.

Statements of Net Assets Available for Benefits – all items and amounts, except for employer's contributions receivable.

Statements of Changes in Net Assets Available for Benefits – all items and amounts, except for contributions, benefits paid to participants, administrative expenses, and the transfer to other plan.

NOTE 8 - SUBSEQUENT EVENTS

The Company evaluated subsequent events through July 10, 2025, the date which the financial statements were available to be issued.
