Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 – DESCRIPTION OF PLAN

To-Ricos Employee Savings and Retirement Plan (the Plan) is a defined contribution plan adopted by To-Ricos, Ltd. (the Plan Sponsor) and affiliate: To-Rico Distribution Limited. (collectively, the Company). The Plan Sponsor is a wholly owned subsidiary of Pilgrim's Pride Corporation (Pilgrim's Pride). Pilgrim's Pride is majority owned by JBS USA Food Company Holdings. The Plan was originally established by the Company effective November 24, 2003, and was most recently restated effective January 1, 2012. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Puerto Rico Internal Revenue Code.

The summary of significant provisions of the Plan presented below provides general information. Participants should refer to the terms of the plan document for a more complete description of the Plan's provisions.

Administration: The Plan is administered by the JBS Investment Committee (the Committee). The Committee is responsible for the operation and administration of the Plan and the management of the Plan's assets. Empower Trust Company, LLC (Empower) acts as custodian and recordkeeper for the Plan and Banco Popular de Puerto Rico (Banco) is the Plan's trustee.

Eligibility: Employees of the Company who are Puerto Rico residents are eligible to make elective deferrals upon the completion of 12 months of consecutive service and are age 18 years or older. Employees can enter the Plan the first day of the month following the satisfaction of eligibility requirements.

Contributions: A participant may elect to contribute, on a pre-tax basis, an amount not to exceed the amount established in Section 1081.01 of the Puerto Rico Internal Revenue Code of 2011. Participants who have attained or will attain age 50 by the end of the calendar year may make additional catch-up contributions. Participants may also contribute amounts representing distributions from other Puerto Rico qualified plans (rollovers).

The Company makes a matching contribution equal to 30 cents for each dollar of a participant's pre-tax contributions. The Company will not make a contribution above 6% of the employee's compensation.

The Company may also make a profit sharing contribution in one or more installments out of the Company's net profits. In order to receive the profit sharing contribution, the participant must be employed on the last day of the year. For 2024, the Company did not make a profit sharing contribution to the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions, an allocation of the Company's contributions, Plan earnings and losses and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are vested immediately in their elective deferrals, including catch-up contributions, qualified nonelective contributions, and rollover contributions, plus actual earnings or losses thereon. Matching and profit sharing contributions and associated earnings are 100% vested after six years of service. Participants become fully vested in all accounts in the event of death, disability, or attainment of normal retirement age while actively employed.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may redirect future contributions or exchange existing balances among available investment securities at any time.

Effective June 1, 2008, contributions are no longer allowed to be invested into Pilgrim's Pride common stock (Pilgrim's Stock); however, any existing contributions invested in Pilgrim's Stock may remain until the participant elects to either sell and reinvest the funds in a different investment option or sell and take a distribution. Any cash dividends earned or proceeds received from the sale of the investment in Pilgrim's Stock may not be reinvested in Pilgrim's Stock.

Notes Receivable From Participants: Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, or longer if the loan is for the purchase of a principal residence. The loans are secured by the balance in the participants' account and bear an interest rate equal to 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: Participants who separate from service before retirement, death, or disability, may request early payment of their vested benefit by submitting a written request to the Plan administrator. Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive the value of vested interest in his or her account as a lump sum distribution. Participants may receive an in-service withdrawal prior to termination of employment with the Company if they have attained age 59 ½ or incurred a financial hardship.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and distributions will be made as soon as administratively practicable after the Plan terminates.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Forfeited Accounts: Forfeitures are retained in the Plan and may be allocated to participant's accounts based on methods described within the plan document, used to pay administrative expenses, or used to reduce future employer contributions payable under the Plan.

Subsequent Events: The Plan has evaluated subsequent events through July 8, 2025, the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from those estimates.

Benefits Paid: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments other than the fully benefit responsive investment contract are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest and other income are recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the Plan year.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balances. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024 and 2023, the Plan included deemed distributed loans totaling \$161,521 and \$124,275, respectively. These amounts are included in notes receivable on the statements of net assets available for benefits.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and global event risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Banco Popular de Puerto Rico, Empower Trust Company, LLC and Empower Annuity Insurance Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- *Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability as a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3* - Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Common Stock: The fair values of Pilgrim’s Pride common stock are determined by obtaining quoted prices from a nationally recognized exchange (Level 1 inputs).

NOTE 5 – GUARANTEED INTEREST FUND

The Plan holds a fully benefit-responsive guaranteed investment contract, Key Guaranteed Portfolio Fund, with Empower Annuity Insurance Company of America (EAICA). EAICA maintains the contributions in a general account. The account is credited with earnings or losses on the underlying investments and charged for participant withdrawals and administrative expenses. EAICA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting rate is reviewed on a quarterly basis for resetting. The average yield earned by the Plan was 1.41% for 2024 and 1.23% for 2023.

The contract meets the fully benefit-responsive traditional investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on EAICA's ability to meet its financial obligations. EAICA's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with EAICA. These events may be different under each contract. Examples of such events include but are not limited to premature termination of the contract; Plan termination or merger; changes to the Plan's prohibition on competing investment options; bankruptcy of the Plan Sponsor or other events that significantly affect the Plan's normal operations. The Company believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with EAICA and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow EAICA to terminate the contract with the Plan and settle at an amount different from contract value. Examples of circumstances which would allow EAICA to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. The Company believes that any events allowing EAICA to terminate the contract and settle at an amount different from contract value are not probable of occurring.

NOTE 6 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Banco, Empower and EAICA are service providers of the Plan, and, therefore, the Plan's payment of fees to these service providers qualifies as party-in-interest transactions. Investments in the Pilgrim's Stock and notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 – TAX STATUS

Effective January 1, 2012, the Plan adopted the Popular Master Plan Defined Contribution Retirement Plan (Popular Master Plan). The Popular Master Plan has received an opinion letter dated May 22, 2012, from the Puerto Rico Department of Treasury as to the Popular Master Plan’s qualified status. The Puerto Rico Department of Treasury has informed the Plan Sponsor, by an opinion letter dated May 13, 2013, that the Plan may adopt the Popular Master Plan. The opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
