In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate that raise substantial doubt about Quality Custom Cabinetry, Inc. Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Quality Custom Cabinetry, Inc. Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate that raise substantial doubt about the Quality Custom Cabinetry, Inc. Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of the Schedule of the Assets Held for Investment Purposes as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment

information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion –

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1 – Plan Description

The following description of the Quality Custom Cabinetry, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan with a 401(k) provision. The Plan covers all employees of Quality Custom Cabinetry, Inc. (the “Company”), who have completed one month of service and have attained the age of eighteen. Union, part-time, temporary, and seasonal employees and residents of Puerto Rico are excluded from eligibility in the Plan. Eligible employees are automatically enrolled in the Plan at a 4% deferral rate unless they choose to opt out. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Each year, participants may contribute up to the maximum amount allowable under the Internal Revenue Code. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as well as an insurance contract as investment options for participants. The Plan offers an employer match equal to 50% of a participant's contribution up to 4% of compensation. The Company can also contribute a discretionary profit-sharing contribution which is determined annually by the Company's Board of Directors. Employer matching contributions totaled \$116,136 and \$51,182 for the years ended December 31, 2024 and 2023, respectively. Other employer contributions totaled \$0 and \$1,438 for the years ended December 31, 2024 and 2023, respectively. There were no discretionary profit-sharing contributions for the years ended December 31, 2024 and 2023. The Company's matching and any discretionary profit-sharing contributions are invested in the same investment options as directed by the participant. Contributions are subject to certain limitations.

Participant Accounts – Each participant's account is credited with the participant's deferred compensation and corresponding employer match, and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested amounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are vested in employer matching and discretionary profit-sharing contributions plus actual earnings thereon based on years of continuous service. A participant is 100% vested after four years of credited service.

Payment of Benefits – Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account. Automatic distributions will be made to terminated participants with vested balances less than \$1,000. If a terminated participant's vested balance is in excess of \$1,000 but not greater than \$5,000, the Plan Administrator will rollover the distribution into an individual retirement account (IRA) absent a distribution direction from the participant. If a terminated participant's vested balance exceeds \$5,000, a written request from the participant is required before distribution. Hardship withdrawals are permitted from participants' pre-tax and Roth elective deferral and rollover accounts.

Note 1 – Plan Description – Continued

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loans must be fully repaid through payroll deductions within five years, unless the loan is used for the purchase of a primary residence, which must be repaid within a period no more than ten years. The loans are secured by the balance in the participant's account. The interest rate charged is based on the rate of interest charged on similar commercial loans by persons or institutions in the business of lending money in the same geographic area as the employer. The rate of interest on all outstanding loans ranged from 3.25% to 8.50% as of December 31, 2024.

Forfeitures – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,380 and \$308, respectively. Forfeitures may be used by the Plan to reduce discretionary and matching employer contributions as well as pay any administrative expenses of the Plan. In the event forfeitures are added to the employers' discretionary profit-sharing contribution, only participants who have completed a year of service during the Plan year and are actively employed on the last day of the Plan year will share in the allocation of forfeitures, unless termination of service occurred during the year as a result of death, disability or retirement. For the years ended December 31, 2024 and 2023, \$1,946 and \$1,523 were used to pay Plan expenses, respectively.

Note 2 – Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value as determined and certified by the Plan's Trustee. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Shares of a stable value investment contract are valued at the stated contract value which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – All administrative expenses will be paid by the Plan unless paid by the Company. Certain administrative expenses associated with the Plan were paid by the Plan.

Subsequent Events – Events that occurred subsequent to December 31, 2024 have been evaluated by the Plan's management through July 7, 2025, which is the date the financial statements were available to be issued.

Note 3 – New Accounting Standards

Pronouncements issued by the Financial Accounting Standards Board (FASB) with future effective dates are either not applicable or are not expected to be significant to the Plan's financial statements.

Note 4 – Investments

As of December 31, 2024 and 2023, the Plan's investments are held in a trust fund administered by Charles Schwab Bank. All investments are participant directed.

During the years ended December 31, 2024 and 2023, the Plan's investments in mutual funds and a stable value investment contract (including gains and losses on investments bought, sold and held during the year) appreciated in value by \$776,690 and \$1,277,612 respectively.

Note 5 – Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 5 – Fair Value Measurements – Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at quoted market prices which represent the net asset value (“NAV”) of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Investment in Insurance Contracts

The Plan has entered into a traditional group annuity contract with an insurance carrier. This contract, which is included in the Stable Asset Fund, is fully benefit-responsive and has no stated maturity date.

A fully benefit-responsive contract provides for a stated return on principal invested over a specified period and permits withdrawals at contract value for benefit payments or transfers. Contract value represents contributions made under the contract, plus earnings, less Plan withdrawals and administrative expenses. Investment contracts held by a defined contribution plan are required to be reported at fair value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Accordingly, the fully benefit-responsive group annuity contract is included in the financial statements at contract value, which approximates fair value.

Note 7 – Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination or partial Plan termination, affected participants will become 100 percent vested in their accounts.

Note 8 – Parties-In-Interest Transactions

Certain Plan investments are shares of a stable value investment contract managed by an affiliate of Standard Retirement Services, Inc. Standard Retirement Services, Inc. is the third-party administrator; therefore, these transactions qualify as party-in-interest transactions. The fair value of these investments was \$89,754 and \$97,850 at December 31, 2024 and 2023, respectively. In addition, fees paid by the Plan for investment management services amounted to \$63,934 and \$61,862 for the years ended December 31, 2024 and 2023, respectively.

Simon Lever LLC provided auditing services to the Plan. Fees paid by the Plan for these services amounted to \$17,500 and \$17,000 for the years ended December 31, 2024 and 2023, respectively.

The Plan has notes receivable from participants that are secured by participant account balances. All of these transactions qualify as party-in-interest transactions.

Note 9 – Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 – Information Prepared and Certified by Trustee

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Charles Schwab Bank, the Trustee.

Note 11 – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
