We have performed audits of the financial statements of Prairie Farms Dairy, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Note 1. Description of the Plan**

### ***General***

The following description of Prairie Farms Dairy, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan sponsored by Prairie Farms Dairy, Inc. (the “Company”) and other adopting affiliated companies (collectively the “Employers”) for the benefit of their union employees who have met certain eligibility requirements. Related employers who also participate in the Plan include Ice Cream Specialties, Inc., East Side Jersey Dairy, Inc., Hiland Dairy Foods Company LLC and Turner Holdings LLC. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Country Trust Bank is the trustee of the Plan and serves as Plan custodian. Newport Group, Inc. serves as the Plan recordkeeper.

### ***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Employers make annual contributions of up to 50 percent of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Employers make matching contributions as defined in collective bargaining agreements. Each year, the Employers also may contribute to the Plan amounts at the discretion of the respective Employers’ Board of Directors. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily subject to account trading restrictions.

### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution, the Employers’ contribution and plan earnings and is charged with an allocation of administrative expenses, unless not allowed by a collective bargaining agreement. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Employers’ contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of continuous service or at age 65, whichever is earlier. The nonvested balance is forfeited upon termination of service. Forfeitures are first used to reduce Employers’ contributions. Any remaining amounts will be used to pay Plan administrative expenses.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant’s account. The loan interest rate is set at 2 percent above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

***Payment of Benefits***

On termination of service, due to death, disability or retirement, an employee may elect to receive either a lump-sum amount equal to the value of the employee's vested interest in his or her account or equal installments at regular intervals determined at the time of distribution. For termination of service for other reasons, an employee may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Forfeited Accounts***

At September 30, 2024 and 2023 forfeited nonvested accounts totaled \$49,948 and \$117,145, respectively. These accounts will be used to reduce employer contributions or pay administrative expenses.

***Plan Termination***

Although they have not expressed an intention to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments in mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end as determined by the Trustee.

The Plan holds interests in a common collective trust fund, which invests in investments that pursue multiple strategies to exceed the performance of certain industrial averages. The fund may invest in securities or a combination of other collective funds. The NAV of the fund is determined as of the end of each month utilizing the values of the underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Tax Status***

The IRS has determined and informed the Company by a letter dated July 23, 2013, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Employers or the Plan, at the Employers' discretion.

**Note 3. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets

**Investments**

If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. The Plan has no Level 2 investments. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan has no Level 3 investments.

**Note 4. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Country Trust Bank, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of September 30, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the Statements of Changes in Net Assets Available for Benefits for the years ended September 30, 2024 and 2023.

**Note 5. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

The Plan incurs expenses related to general administration and record keeping. Certain of these expenses and accounting and auditing fees relating to the Plan are paid by the Employers.

**Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 7. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$6,414 and \$31,720 were not remitted within the required time period for the years ended September 30, 2020 and 2018. These contributions were subsequently corrected and a Form 5330, *Return of Excise Taxes Related to Employee Benefit Plans* was submitted.

**Note 8. Subsequent Events**

Subsequent events have been evaluated through July 10, 2025, which is the date the financial statements were available to be issued.
