Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Fremont Automotive Retailing Group, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 9, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended September 9, 2024, and the related notes to the financial statements (the "financial statements").

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of Plan

The following description of the Fremont Automotive Retailing Group, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on January 1, 2017, to provide retirement benefits for employees of Fremont Automotive Retailing Group, Inc. (the “Company”). The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Company is the Plan’s sponsor and serves as plan administrator. John Hancock Life Insurance Company (“John Hancock”) serves as the Plan’s recordkeeper and custodian.

Effective September 9, 2024, the Plan was fully merged into the Automotive 401(k) Plan, sponsored by California Automotive Retailing Group, Inc. (the “Successor Plan”), pursuant to a Merger and Transfer Agreement executed by the respective plan fiduciaries and trustees.

Under the terms of the agreement:

- All participant balances in the Plan, including both vested and non-vested amounts, were transferred and assigned directly to the Successor Plan.
- Each participant’s account balance in the Successor Plan was credited with an amount equal to their account balance in the Plan immediately prior to the transfer.
- The vested portion of each participant’s account as of September 9, 2024, was preserved in the Successor Plan.
- The transfer did not eliminate any protected benefits under Internal Revenue Code §411(d)(6).

As a result of the transfer, the Plan had no assets, liabilities or net assets available for benefits as of September 9, 2024, and is considered fully settled and closed as of that date.

All administrative procedures related to the merger, including participant communications and regulatory filings, were completed in accordance with the applicable Department of Labor and IRS requirements.

Eligibility

Employees are eligible to become participants in the plan after attaining the age of 18. Employees covered by a collective bargaining agreement, leased employees, or who are a non-resident alien or part-time employee, are not eligible to participate in the Plan, as defined in the plan document. Participants must complete one year of service to be eligible to receive any matching and/or profit-sharing contributions.

Contributions

Each year, participants may contribute compensation, as defined in the plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company, at its discretion, may make matching contributions equal to a discretionary percentage of participant's deferrals, determined by the Company's management. For the period ended September 9, 2024, the Company matched up to 25% of the first 4% of eligible compensation. The Company may, at its discretion, make profit sharing contributions to the Plan. The Company made discretionary profit-sharing contributions of approximately \$61,000 and matching contributions of approximately \$28,000 during the period ended September 9, 2024.

No contributions were made to the Plan after September 9, 2024, the effective date of the merger.

Participant Accounts

Each participant account is credited with the participant's contribution, the Company's contribution, and allocation of the Plan's earnings (losses) and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. No further allocations or transactions occurred in participant accounts after the merger date.

Vesting

Participants are 100.00% vested in all participant contributions plus actual earnings thereon at all times. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. The Company's contributions vest at a rate of 20% after the second year of vesting service and become fully vested after six years of credited service.

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan offers various pooled separate accounts as investment options for participants.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (1) 50.00% of the present value of the vested account balance, or (2) \$50,000, reduced by the excess (if any) of the highest outstanding loan balance of plan loans in the prior 12-month period ending on the day before the loan is made over the outstanding balance of plan loans on the date the loan is made. A participant may have only one loan outstanding at any time. The repayment terms of loans may not exceed five years, except for loans used to acquire the participant's principal residence, in which case the loan term may not exceed 30 years. The loans bear interest ranging at a market rate and are repaid ratably through payroll deductions. Outstanding loans were transferred to the Successor Plan as part of the merger.

Payment of Benefits

On termination, retirement, or prior to retirement in the case of death, disability or substantiated hardship, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with an account balance less than \$5,000 will receive their distribution in a lump-sum at the next distribution date following the termination or have the option to roll over their balance into another qualified plan. In-service distributions are available from fully vested sources after a participant reaches the age of 59½ years.

No distributions were made directly from the Plan in connection with the termination; all participant balances were transferred to the Successor Plan.

Forfeitures

During the 2024 plan year, forfeitures totaling \$4,521 were used to pay Plan administrative expenses. In accordance with Plan provisions, forfeitures may be used to reduce future employer contributions, pay Plan expenses, or be reallocated to eligible participants. Forfeited nonvested accounts totaled \$6,615 at December 31, 2023. No forfeiture balances remained as of September 9, 2024

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by the Plan unless paid directly by the Company, as provided by the plan document. Fees related to the administration of notes receivable from participants, participant distributions, and participant directed investment management are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Transfers

The Company has affiliates that also sponsor 401(k) plans for their employees. If employees are transferred between entities during the year, their account balances are transferred into or out of the related party's plan. For the period ended September 9, 2024, there were net routine transfers out of the plan of approximately \$28,000. In addition, on September 9, 2024, all remaining participant account balances were transferred to the Successor Plan in connection with the Plan's merger and termination. See Note 1.

Note 3. Fair Value Measurements

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 9, 2024 and December 31, 2023.

Pooled Separate Accounts

The Plan invests in pooled separate accounts for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value ("NAV") per share, as determined by John Hancock, as a practical expedient for estimating fair value. Because quoted prices in active markets for identical assets are not available, these prices are determined using observable market information such as quotes from less active markets and/or quoted prices of securities with similar characteristics. These investments are not classified within the fair value hierarchy but are disclosed separately.

The Plan held no investments within the fair value hierarchy as of September 9, 2024 and December 31, 2023.

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of September 9, 2024 and December 31, 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other mark participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 6. Related-Party and Party-In-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of pooled separate accounts managed by John Hancock, the Plan's recordkeeper and custodian. As such, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan for administrative services totaled \$44,908 for the period ended September 9, 2024. Loans to participants also qualify as party-in-interest transactions.

Note 7. Plan Termination

Effective September 9, 2024, the Plan was terminated and merged into the Automotive 401(k) Plan, sponsored by California Automotive Retailing Group, Inc. (See Note 1). As a result of the merger, all participant account balances, including both vested and non-vested amounts, were transferred to the successor plan. The Plan had no assets, liabilities, or net assets available for benefits as of the termination date and is considered fully settled and closed.

Note 8. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the Internal Revenue Code (the "IRC"). The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated September 22, 2021, that the prototype plan document was designed in accordance with applicable sections of the IRC.

The plan administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
