1. Description of Plan

The following description of the ASGCO Manufacturing, Inc. (“the Company”) 401(k) Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company. Prior to October 1, 2023, all employees of the Company who attained one year of service requirement, which required 1,000 hours of services, and attained eighteen years of age, as defined in the plan document, were eligible to participate. Effective October 1, 2023, the Plan was amended to change the service requirement to 3 months of employment, with no service hours requirement. Prior to October 1, 2023, upon meeting eligibility requirements, the employee entered the Plan on either the first day of the Plan Year or the first day of the seventh month of the Plan Year coinciding with or next following the date immediately following eligibility. Effective October 1, 2023, upon meeting eligibility requirements, the employee enters the Plan on the first day of the month following the attainment of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, subject to certain Internal Revenue Code limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Effective October 1, 2023, the Plan implemented an option for Roth deferral contributions, as well as an automatic-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching, safe harbor and profit-sharing contributions may be made each year at the option of the Company’s ownership and are invested as directed by the participants. In 2024, the Plan made matching contributions equal to 100% of the amount of eligible participants’ elective deferrals, up to 5% of the participants’ compensation. In 2023, the Company made matching contributions equal to 50% of the amount of the participants’ elective deferrals, up to 6% of the participants’ compensation. There were no safe harbor or profit-sharing contributions for the 2024 or 2023 plan years.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, allocations of Company’s contributions and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately and fully in all employee contributions plus actual earnings. Participants vest in employer matching contributions and profit-sharing contributions based on years of continuous service. Vesting schedules are dependent on both contribution type and plan year information, and is summarized on the following page:

Notes Receivable from Participants

The Plan does not allow participants to borrow from their Plan accounts.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a non-recurring partial payment or lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows participants to make in-service withdrawals upon attaining age 59 ½ and hardship withdrawals. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Terminated participants with balances of less than \$5,000 are automatically distributed from the Plan.

Forfeiture Accounts

Forfeited non-vested accounts totaled \$11,190 and \$4,350 at September 30, 2024 and 2023, respectively. The Plan utilized \$4,349 and \$16,701 of forfeitures during plan years ended September 30, 2024 and 2023, respectively, to reduce employer contributions.

2. Summary of Accounting Policies

Plan Amendments

During the year, the plan was amended to comply with the most recent IRS and DOL requirements. As part of this amendment, the Plan made changes to eligibility requirements, automatic enrollment provisions, added a Roth deferral option, and the changed employer matching contributions formula, effective for October 1, 2023. See “General” and “Contributions” section of Note 1 of the financial statements for a full description of the changes.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received upon sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan valuation policies utilizing information provided by the investment advisors and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on the investments bought and sold as well as held during the year.

Investment Fees

Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deductible prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense.

Payment of Benefits

Benefits are recorded when paid.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 and/or Level 2 inputs as components of the overall fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual Funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Insurance Company Investment Contract

The Plan offers a Stable Value investment option within the group annuity contract through John Hancock Life Insurance Company.

The John Hancock Stable Value Fund significantly invests in the John Hancock Stable Value Fund Collective Investment Trust. The Trust seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by John Hancock, represents contributions made under the contract, plus specified earnings, less participant withdrawals and administrative expenses. Generally, the contract issuer may not terminate the contract at any amount less than contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contracts have certain restrictions that impact the ability to collect the full contract value such as sponsor-initiated withdrawal or partial plan terminations. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The yield earned by the Fund at September 30, 2024 and 2023 was approximately 2.71% and 2.48%, respectively. This represents the annualized earnings of all investments in the Fund divided by the fair value of all investments in the Fund at September 30, 2024 and 2023.

5. Tax Status

The Company adopted a prototype non-standardized profit-sharing plan with a cash or deferred arrangement which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Company has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the plan, and had determined that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, generally for three years after the filing of the respective information returns; however, there are currently no audits for any tax periods in progress.

6. Information Certified by the Trustee

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at September 30, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends for the years ended September 30, 2024 and 2023, was obtained or derived from information supplied to the plan administrator who has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA, and certified as complete and accurate by John Hancock Life Insurance Company, the trustee of the Plan.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental Schedule of Assets (Held at End of Year).

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

8. Transactions with Parties in Interest

Certain administrative functions and expenses relating to the maintenance of employee eligibility records are incurred by the Sponsor. Other than as described above, the Plan has had no agreements or transactions with any parties in interest.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
