Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Goodwin Procter LLP Partnership Profit Sharing Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of September 30, 2024, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Goodwin Procter LLP Partnership Profit Sharing Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

Responsibilities of Management for the 2024 Financial Statements

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Goodwin Procter LLP Partnership Profit Sharing Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Schedules Required by ERISA

The supplemental Schedule H - Line 4i - Schedule of Assets (Held at End of Year) and Schedule H - Line 4a - Delinquent Participant Contributions as of September 30, 2024, are presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



NOTE 1. DESCRIPTION OF PLAN

The following description of the Goodwin Procter LLP Partnership Profit Sharing Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan created for the benefit of partners, associate lawyers, and employees of Goodwin Procter LLP (the "Firm"). The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of death or disability. Under Section 401(k) of the Internal Revenue Code (the "Code"), certain contributions to the Plan are not included in a participant's compensation for federal income tax purposes until distributed to the participant. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Fidelity Management Trust Company ("FMTC") acts as the trustee of the Plan. Fidelity Institutional Retirement Services Company ("FIRS") acts as custodian for the Plan. FMTC and FIRS are collectively referred to as "Fidelity." The Goodwin Procter LLP Partnership Profit Sharing Savings Plan split into two plans as of October 1, 2004. Effective October 1, 2020, the Plan document was amended and restated in order to incorporate the most recent amendments to the Plan since the last restatement effective October 2, 2014 which included new provisions and changes as required by the Code to be a qualified retirement plan.

Effective October 1, 2022, the Plan amended certain language within the Plan, including expanding eligibility to equity partners in the firm who are residents of Singapore. Effective October 1, 2023, the Plan amended certain language within the Plan as it relates to the location of residence and services performed by partners within the Firm, vesting, withdrawals and compensation.

Eligibility

Partners and certain eligible employees are eligible for membership in the Plan as of date of hire. Eligible classes are partners and non-partner attorneys as well as professional staff whose social security number ends in a number from 0 through 4.

Employee Contributions

The Plan allows participants to save up to 75% of their pretax annual salary through payroll deductions. Participants who are age 50 or older are permitted to make additional, catch-up contributions. Contributions are subject to certain Code limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan allows participants to make Roth 401(k) contributions subject to certain Code limitations.

Firm Contributions

The Firm contribution for eligible non-partner, non-attorney employees is 5% of total compensation for those with less than nine years of service and 6% of total compensation for those with nine or more years of service. A supplemental contribution of 3% of the excess of the eligible participant's compensation over 2/3 of the taxable wage base in effect at the beginning of the plan year is also made by the Firm. Non-partner attorneys who also have an administrative position are eligible for the Firm contribution.

Firm contributions for partners are based on age and compensation/earned income, as defined in the Plan document. Firm contributions for partners will be allocated and made to each partner's account in the Plan and in the Goodwin Procter LLP Partnership Profit Sharing Savings Plan II. The allocation is fifty percent (50%) to the Plan and fifty percent (50%) to the Goodwin Procter LLP Partnership Profit Sharing Savings Plan II. The Firm shall make the following contributions to the Plan on behalf of each participant who is a partner in an amount determined as follows:

- If the partner's age is 36 or older on September 30, fifty percent (50%) of the lesser of 14.5% of earned income or the defined contribution dollar limit reduced by Code Section 402(g) (without regard to catch-up contributions).
- If the partner's age is under 36 on September 30, fifty percent (50%) of the lesser of 6.75% of earned income or \$13,500.

Participants must be employed by the Firm on the last day of the Plan year, or have retired, become disabled, or died during the Plan year, to qualify for Firm contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Firm's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their contributions and Firm contributions into various investment options offered by the Plan. The Plan currently offers a money market fund, numerous mutual funds, self-directed brokerage accounts and common collective trusts. There is no minimum to establish a self-directed brokerage account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 3.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Vesting and Forfeitures

Participants are vested immediately in their contributions plus actual earnings thereon. For participants providing services to the firm prior to October 1, 2023, vesting of firm contributions, based on years of service, is as follows:

For participants providing services to the firm on or after October 1, 2023, participants shall have a one-hundred percent (100%) vested and nonforfeitable interest in their Tax-Deferred Account, Roth 401(k) Account, Rollover Account, In-Plan Roth Rollover Account, Voluntary Account, Firm Account and Retirement Account

Each participant becomes fully vested upon retirement age, death, or disability while employed by the Firm, regardless of years of service. All forfeitures of Firm contributions will be used to reduce future Firm contributions and/or for payment of Plan expenses. Forfeiture balances were \$137,883 and \$120,436 at September 30, 2024 and 2023, respectively. There were forfeitures of \$97,429 during the year ended September 30, 2024. Forfeitures used to reduce Firm contributions or expenses for the year ended September 30, 2024 totaled \$79,487.

Payment of Benefits

Upon normal retirement, death, disability or termination of employment, the participant's vested balances are paid to the participant or his or her beneficiary either in a lump sum, in installments or in the form of a purchased annuity, at the participant's election. In the absence of an election, benefits for non-legal participants hired on or before April 1, 1993, will be payable in a 50% joint and survivor annuity for a married participant and a life annuity for a single participant. For all other participants, in the absence of an election, benefits are payable in a lump sum. If the participant's account balance does not exceed \$1,000, the trustees shall distribute the account in the form of one lump sum payment.

Revenue Credit Program

Certain excess revenue received in connection with plan services that exceed agreed-upon compensation is credited to a revenue credit program account. The balance of the revenue credit program account is applied to reduce plan expenses and may be allocated to participant accounts. As of September 30, 2024 and 2023, the revenue credit program balance consisted of \$115,682 and \$46,326, respectively.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are held in various money market and mutual funds, and other available investment options, including common/collective trusts and self-directed brokerage accounts.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance companies.

The investments in the common/collective trusts are valued at the net asset value (the "NAV") per unit, as determined by the trustee at year end. The NAV is used as the practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

The Plan follows the guidance in Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements* which defines fair value, and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Categorization within the hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are as follows.

- Level 1 - Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

- Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as (1) Quoted prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of asset or liability.
- Level 3 – Unobservable inputs based on the Plan's assessment of the assumptions that market participants would use in pricing the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

- **Money Market Fund and Mutual Funds** – The fair value of the money market fund and mutual funds are valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end mutual funds and a money market fund that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and the money market fund held by the Plan are deemed to be actively traded and are classified as Level 1 investments.
- **Self-Directed Brokerage Accounts** – The fair value of investments in the self-directed accounts, including mutual funds and common stock, are determined by quoted active-market prices or net asset values where available, are deemed to be actively traded and are classified as Level 1 investments. Government bonds and corporate bonds in the self-directed accounts are valued using pricing models maximizing the use of observable inputs for similar securities and are classified as Level 2 investments.
- **Common Collective Trusts** – Common collective trusts consist of a stable value fund, a pooled contrafund and target date funds that are valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective trusts, the issuer reserves the right to require 12 months' notification in order to ensure that the securities liquidations will be carried out in an orderly business manner.

Fair Value Measurement (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of the certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023. If a participant ceases to make loan repayments and the loan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Firm and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Expense Offset Arrangements

Fees incurred by the Plan for the investment management services or recordkeeping are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Payment of Benefits

Benefits are recorded when paid.

Transfers

In addition to the Plan, the Firm also sponsors another defined contribution plan (Goodwin Procter LLP Partnership Profit Sharing Savings Plan II ("Plan II")). If participants' employment status changes during the year, their account balances are transferred into or out of the Plan, accordingly.

For the year ended September 30, 2024, net transfers from Plan II were \$394,399.

Subsequent Events

The Plan has evaluated all subsequent events through July 11, 2025, the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure under FASB ASC 855 *Subsequent Events*, other than what is noted in Note 12.

Fidelity provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MSA") between the Firm and Fidelity. Fidelity receives revenue from mutual funds service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

If the revenue received by Fidelity from such mutual funds service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts, as disclosed in Note 1 - *Revenue Credit Program*, may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or the Plan Sponsor may make a payment to Fidelity for administrative expenses not covered by the revenue sharing.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Firm has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

NOTE 8. TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated February 24, 2017, that the Plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended and restated since receiving the determination letter, the plan administrator and the Plan's ERISA counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believe that the Plan is qualified and tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 11. LATE TRANSMITTAL

During the Plan year ended September 30, 2024, the lost earnings associated with a late transmittal during the year ended September 30, 2023, were remitted to the Plan. The late remittance and lost earnings were corrected outside of the Voluntary Fiduciary Correction Program (VFCP) during the plan year ended September 30, 2024.

NOTE 12. SUBSEQUENT EVENT

Effective October 1, 2024, the Plan moved to Fidelity's prototype plan, and changed the profit-sharing staff contribution formula. In May 2025, the Plan and Plan II were merged and all assets of Plan II were transferred into the Plan.
