**Note 1. Description of the Plan**

***General***

The following description of Meyer Group 401(k) Plan and Trust (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Meyer Properties, Wales Brothers Corp. dba Meyer Company Ranch, and Meyer Foods Group LLC (Company) for the benefit of its employees who have at least one month of service and are age 18 or older. All employees of the Company are eligible to participate in the Plan except for those represented by a collective bargaining agreement, leased employees, and non-resident aliens who do not earn income which constitutes United States sourced income. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company is the trustee of the Plan.

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual pre-tax and Roth contributions of up to 90 percent of their eligible compensation and annual after-tax contributions of up to 100 percent of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company may elect to make discretionary matching contributions each year, based on a percentage of each participant's salary deferrals to be calculated on a per pay period basis. For the years ended December 31, 2024 and 2023, the Company made matching contributions of 25% of each participant's elective deferral up to 6% of eligible employee compensation.

The Company may make an additional discretionary contribution to the Plan each year. The additional discretionary contribution shall be made in an amount determined by the Company and allocated to all eligible employees in the same ratio as the eligible employee's compensation bears to total compensation of all eligible employees, as defined by the Plan. The Company did not make an additional discretionary contribution for the years ended December 31, 2024 and 2023.

The Plan provides for eligible employees to be automatically enrolled into the Plan. For those eligible employees who are automatically enrolled, a pre-tax deferral in the amount of 6% eligible compensation will be contributed to the Plan unless the employee elects a different percentage or elects to not contribute to the Plan. For employees who are automatically enrolled and have not made any deferral changes, the Plan has an automatic deferral increase feature which provides for an annual 1% increase in the percentage deferred for each enrolled participant. The increase occurs each March 1 and is capped at 10% of eligible employee compensation.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is as follows:

Less than one year	0%
At least one year, but less than two	20%

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,700 and \$1,000, respectively. These amounts may be used to reduce future employer contributions or pay administrative expenses. During the years ended December 31, 2024 and 2023, forfeitures totaling approximately \$11,300 and \$5,400, respectively, were used to pay administrative expenses.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The participant may only have one loan outstanding at any given time. The loan interest rate is commensurate with local prevailing rates as determined by the Plan. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

Upon termination of service, participants receive the vested portion of their Company contributions and earnings on their Company contributions and 100% of their contributions and earnings on their contributions in a lump sum payment as soon as administratively possible following participants' request for distribution. A participant's total vested interest between \$1,000 and \$5,000 will be automatically rolled over to an individual retirement account (IRA) designated by the Company if the participant does not consent to a cash distribution and has not elected to have the balance rolled over into an IRA of the participant's choosing. A participant's total vested benefit of less than \$1,000 is subject to an involuntary cash-out distribution even if the participant does not consent to a distribution.

Subject to certain restrictions, in-service withdrawals from a participant's account may be permitted to participants who are over the age of 59 ½ or if the participant qualifies for a financial hardship, as described in the Plan document.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. The Plan's interest in the collective trusts is valued based on information reported by the investment advisor using the audited financial statements of the collective trusts at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Trust Management Company, a qualified institution, has certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

**Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**Note 6. Tax Status**

The Plan operates under a pre-approved defined contribution plan sponsored by Fidelity Management & Research Company. This plan document has been filed with the appropriate agency. The Internal Revenue Service ruled on June 30, 2020, that the Pre-Approved Defined Contribution Basic Plan Document (the plan document of Fidelity Management & Research Company upon which the Plan is based), as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan and related trust are currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

**Note 7. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company (Fidelity). Fidelity is the trustee of the Plan. Additionally, certain administrative and recordkeeping expenses are paid directly to Fidelity or an affiliate. The Plan paid \$12,683 and \$6,753 of administration expenses to Fidelity during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Plan Amendments**

During 2024, the Plan was amended to remove Meyer Natural Foods LLC as a participating employer and to allow part-time and seasonal workers to participate in the Plan once they have reached age 18 and one month of service.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through July 10, 2025, which is the date the financial statements were available to be issued.
