INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the
Easterseals MORC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Easterseals MORC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Easterseals MORC 401(k) Plan (the "Plan"), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which covers all employees of Easterseals MORC (the "Organization") over the age of 18 and who have completed 30 days of service. Prior to the plan restatement, the service requirement was 90 days. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On October 2, 2023 (plan restatement date), the Plan was amended and restated to appoint a new trustee, administrator and recordkeeper and the name of the Plan was changed from Easter Seals – Michigan, Inc. 401(k) Plan to Easterseals MORC 401(k) Plan. Plan assets transferred to the new trustee were transferred into funds comparable to those offered by the previous trustee, Fidelity Trust Company ("Fidelity").

The conversion initiated a blackout period through October 18, 2023. During this period, funds could not be applied to the employee-selected funds with the trustee or withdrawn from the Plan until the trustee could accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions, and the contributed were deposited and held in a discretionary fund until the completion of the transfer. At the end of the transfer, such funds were transferred to the investment options requested by each participant.

Effective October 2, 2023, the Macomb-Oakland Regional Center Money Purchase Plan ("MORC Plan") merged into the Plan and transferred assets of \$30,107,636 into the Plan. The plan merger was a result of a merger on the plan sponsor level, in which the plan sponsor of the MORC Plan merged with Easter Seals – Michigan, Inc.

John Hancock Trust Company LLC ("John Hancock") is the Plan's trustee. John Hancock Retirement Services LLC provides recordkeeping services to the Plan. The plan administrator has the overall responsibility for the operation and administration of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

The Setting Every Community Up for Retirement Enhancement Act 2.0 of 2022 (the SECURE Act 2.0) was signed into law December 29, 2022. This law, among other things, includes several required and optional provisions that will impact employee benefit plans that go into effect at various times through 2027. The provisions that were required to be implemented on or after December 29, 2022 are; 1) the change of the RMD age from 72 to 73, 2) a reduction in the excise tax due for failure to take a RMD, 3) the ability for fiduciaries to not have to recoup inadvertent overpayments to plan participants (though the Plan must still be made whole), and 4) limits the time to recontribute amounts taken for qualified birth or adoption distributions from an unlimited time period to 3 years. The optional provisions that could be implemented on or after December 29, 2022 are; 1) the ability to give de minimis incentives to boost employee participation in an employee benefit plan, 2) to allow employer match or non-elective contributions to be made on a Roth basis, 3) to allow an employer to elect if hardship withdrawals can be self-certified by participants, and 4) to allow for distributions related to disasters and terminal illness.

On October 2, 2023, the Plan adopted the only the required provisions of the Secure Act 2.0. The Plan will be amended for any provisions elected in accordance with applicable law and IRS guidance.

Contributions

The Plan allows participants to elect to defer a portion of their compensation up to 100%, as defined by the Plan and designate those contributions as pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Effective October 2, 2023, automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Prior to this date, automatically enrolled participants had their deferral rate set to 2% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Organization may contribute a discretionary percentage, as determined annually, to the Plan each year. During the plan years ended September 30, 2024 and 2023, the Organization matched 100% of the participants' contribution up to a maximum of 4% and 2%, respectively, of the participants' compensation. Discretionary profit-sharing contributions are determined annually by the Company. During the plan year ended September 30, 2024 and 2023, the Organization did not make a discretionary profit-sharing contribution.

Contributions (Continued)

The Organization also contributes a 3% safe-harbor contribution to all eligible participants. Contributions are subject to certain IRS limits. Participants direct the investment of their contributions, including their employer contribution, into various investment options.

Participant Accounts

Each participant's account is credited with the participant's contribution, Organization's discretionary matching contribution, the Organization's safe-harbor contributions and allocations of Plan earnings and charged with an allocation of administrative expenses. Plan earnings and administrative expenses are allocated based on the ratio of each participant's account balance to the total account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Effective October 2, 2023, the Plan provides that participants have no vested interest in the Organization contributions until they have completed 1 year of service, at which time participants become 33% vested, with vesting increasing to 67% after 2 years of service and 100% after 4 years of service. Prior to the plan restatement, after 1 year of service, participants were vested 25% in employer contributions, with vesting increasing by 25% each year up to 100% after 4 years of service. Participants that terminated on or before 9/30/2023 remain subject to the prior 4 year graded vesting schedule.

Balances transferred from the MORC Plan are subject to an alternate vesting schedule in which they are not vested in the MORC Plan employer matching contributions until they have completed 3 years of service, at which point they become 100% vested. Participants from the MORC Plan hired prior to January 1, 2009, will be 100% vested in MORC Plan employer matching contributions upon attainment of normal retirement age of 59.

Participants are fully vested immediately with respect to voluntary contributions, rollover contributions, employer safe harbor contributions and actual earnings thereon.

Forfeitures

At September 30, 2024 and 2023, there were unallocated forfeitures of \$3,861 and \$6,219, respectively. Forfeitures are used to either reduce any employer contributions or pay any administrative expenses incurred by the Plan. During the year ended September 30, 2024, forfeitures in the amount of \$106,469 were used to reduce employer contributions.

Payment of Vested Benefits

Participants, or their beneficiaries, are entitled to receive the entire amount of their interests in the Plan upon retirement, death, total or permanent disability, employment termination, reaching the age of 59 ½ or qualifying for a hardship distribution, as defined in the Plan. Effective October 2, 2023, early retirement provisions exist for participants retiring after age 55, and three years of service. Prior to the plan restatement, early retirement provisions exist for participants retiring after age 55, and four years of service. A participant will be considered to have suffered a disability if he or she is permanently unable to perform his or her customary duties for the employer due to a mental or physical condition which can be expected to result in death or be of a long continued and indefinite duration as determined by the plan administrator. On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or payments over a certain period in monthly, quarterly, semi-annual, or annual cash installments. If the participant's vested balance is less than \$1,000, the entire sum will be distributed as soon as possible following the participant's separation from service. If the participant's vested balance is less than \$5,000, but greater than \$1,000, the entire sum will be rolled into an IRA. If the participant's vested balance is greater than \$5,000, they can elect to receive a lump-sum distribution, installments, or an annuity. At September 30, 2024, there were no requested distributions that had not been paid as of the Plan year end.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the vested balance in the participant's account. The loans are secured by the vested balance in the participant's account. Effective October 2, 2023, the loan interest rate is set at 1% above the prime rate, as defined. Prior to the plan restatement, interest rates were commensurate with local prevailing rates as determined by the plan administrator. The term of such loans may not exceed five years except in the case of a loan for the purchase of a principal residence which may not exceed ten years. Participants may have a maximum of two outstanding loans at a time. Principal and interest is paid ratably, through payroll deductions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of certain accounting policies followed in the preparation of these financial statements.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for full benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measures.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investment bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the plan sponsor. Expenses paid by the plan sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. NOTE 4 – INVESTMENTS

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at September 30, 2024 and 2023.

Mutual funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments in Entities that Calculate Net Asset Value per Share

Following is a description of the valuation methodology used for assets measured at net asset value per share. There have been no changes in the methodology used at September 30, 2024 and 2023.

Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investments contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following table summarizes investments for which fair value is measured using the net asset per share practical expedient as of September 30, 2023. This asset was not held as of September 30, 2024. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

NOTE 6 – GROUP ANNUITY CONTRACT

In October 2023, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with John Hancock Life Insurance Company totaling \$7,055,212 at September 30, 2024. John Hancock Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on formula agreed upon with the issuer but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by John Hancock Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 7 – TAX STATUS

The Plan uses a prototype plan sponsored by John Hancock Trust Company, LLC. The Internal Revenue Service (IRS) has determined and informed the plan sponsor by a letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan itself is not required to and has not received a determination letter from the IRS. Although the Plan has been amended since receiving this letter, the plan administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 7 – TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – PARTY- IN- INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. During the year ended September 30, 2024, there were direct fees of \$221,515 and there were transactions involving the investment of plan assets in investment funds maintained by John Hancock, a party-in-interest as defined in Section 3(14) of ERISA. Indirect fees paid by the Plan for investment management services are included in the net appreciation of the fair value of investments.

NOTE 9 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 10 – RISKS AND UNCERTAINTIES

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for plan benefits.
