## Notes to Financial Statements

---

### Note 1: Description of Plan

The following description of the Sutton Transport, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is effective as of July 1, 2022. It is an amendment and restatement of a pre-existing plan which was originally adopted October 1, 1994. The Plan is a defined contribution plan covering all full-time employees of Sutton Transport, Inc. and Envoy Logistics, Inc., herein collectively referred to as the "Company", except for leased employees, nonresident aliens, and union employees. An employee becomes eligible to participate in the Plan following three months of service and attainment of age 21. Upon satisfying the eligibility requirements, an employee is eligible to participate on the first day of the following month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants are allowed to contribute up to 90% of pretax compensation, as defined in the Plan, or Roth contributions up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Plan also allows for Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Employees are automatically enrolled into the Plan upon becoming eligible with their deferral rate set at 2% of eligible pretax compensation unless they affirmatively elect not to participate in the Plan or elect a different deferral rate. Automatically enrolled participants will have their deferral percentage increased annually by 1% until a deferral rate of 10% is reached and contributions invested in a designated fund until changed by the participant.

The Company may make a discretionary matching contribution. The Company matches an amount equal to 25% of the first 8% of a participant's eligible compensation. These contributions are remitted each payroll period. Rollovers are not matched. For the plan year ended September 30, 2024, the Company made discretionary matching contributions of \$494,257, net of forfeitures of \$41,471.

The Company may also make a discretionary profit sharing contribution as determined annually by the Company. These contributions are allocated to eligible participants in a manner as determined by the Company on the last day of the plan year. There were no discretionary profit sharing contributions for the year ended September 30, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, and allocations of (a) the Company's discretionary profit sharing contribution and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest in discretionary matching contributions at a rate of 20% beginning with the second year of service, 40% after the third year of service, and 100% after the fourth year of service. Participants vest in discretionary profit sharing contributions at a rate of 20% per year beginning with the second year of service and become fully vested after six years of service.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest ranging from 4.25% to 9.50%, which are commensurate with 1% over the U.S. Prime interest rate, in accordance with plan provisions. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of their vested interest in their account in a lump-sum, substantially equal installments, or partial withdrawals. For termination of service for other reasons, if the participant's balance does not exceed \$5,000, the Plan will make a mandatory distribution in accordance with plan provisions. In addition, hardship distributions out of the participant's voluntary, matching, and profit sharing accounts are permitted if certain criteria are met. The Plan also allows for in-service distributions from all accounts upon attaining age 59 1/2.

#### Forfeitures

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$4,486 and \$14,079, respectively. These accounts are used to reduce future Company contributions, pay administrative expenses of the Plan, or reinstate terminated participant accounts in accordance with the plan document. During the year ended September 30, 2024, forfeitures totaling \$41,471 were used to reduce Company contributions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### **Excess Contributions Payable**

At September 30, 2024 and 2023, amounts payable to participants totaling \$5,991 and \$11,017, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to December 15, 2024 and 2023, respectively.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

#### Subsequent Events

The Plan has evaluated subsequent events through July 15, 2025, which is the date the financial statements were available to be issued.

On December 31, 2024, the Company was acquired by Dohrn Transfer Company, LLC ("Dohrn"). As a result, on February 17, 2025, the Company's Board of Directors made a resolution to terminate the Plan effective March 31, 2025, at which time all participant and Company contributions into the Plan ceased. Upon termination of the Plan, all participants became 100% vested in their account balances. Plan assets will be fully liquidated and final distributions will be made to participants in accordance with participants' directives in conjunction with the plan termination. Employees of the Company will transition to employment with Dohrn and eligible employees of the Company will then have the option to participate in the plan sponsored by Dohrn.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of September 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* Valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding and is used as a practical expedient to estimate fair value. The NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments that are traded on an active market. Participant transactions (i.e., purchases and sales) may occur daily. There are no unfunded commitments and funds may be redeemed on a daily basis.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of September 30, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

### **Note 4: Information Prepared and Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at September 30, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended September 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

### **Note 5: Related-Party Transactions and Party-in-Interest Transactions**

ADP, LLC ("ADP") is the third-party administrator, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

Plan investments are managed by Reliance Trust Company, the Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Plan Termination**

The Company's Board of Directors voted to terminate the Plan effective March 31, 2025, at which time all participant and Company contributions into the Plan will be ceased and all participants became 100% vested in their account balances. See Note 2 - Subsequent Events for additional information.

### **Note 7: Tax Status**

The Company adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
