## Independent Auditors' Report

### Opinion

## 1. Description of Plan

The following description of the Prudential Overall Supply Employee Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document and Summary Plan Descriptions (SPD) for a more complete description of the Plan's provisions.

### General

The Plan provides medical, vision, dental, and death benefits for full-time, permanent employees (and, where applicable, their enrolled eligible dependents) of Prudential Overall Supply (the Company and the Plan's sponsor), excluding leased employees, independent contractors and employees covered by a collective bargaining agreement, unless the collective bargaining agreement provides for participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Certain plan assets are held in a Voluntary Employees' Beneficiary Association (VEBA) trust.

### Eligibility

Full-time employees of the Company, following the completion of two months of continuous employment, are eligible to participate in the Plan. An employee ceases to participate in the Plan upon the earliest of (1) the date upon which the Plan terminates; (2) for medical and death benefits, the last day of the calendar month in which the employee is terminated; and (3) for all other benefits, the date of termination. In accordance with the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA), employees and their dependents have the option to continue coverage under the Plan whenever certain qualifying events occur. If the election is made to continue coverage, participants will be required to pay for the cost of these benefits.

### Contributions

The Plan provides for Company contributions to the Plan on a voluntary basis for a specified amount to cover benefits as determined by the Company. The contributions are reserved exclusively for the benefit of the Plan participants. The Company makes contributions to a Voluntary Employees Beneficiary Association (or VEBA) trust fund (the Trust), as necessary, to pay benefits, claims, and insurance premiums. Participant contributions are made through bi-weekly payroll deductions for specified amounts, determined periodically by the Plan, and represent health premiums for benefit coverage and are based on the type of coverage elected for themselves and their eligible dependents.

### Payment of Benefits

The Plan provides self-insured medical, prescription, dental, vision, and life insurance, all of which are subject to certain exclusions and specified maximum coverage limitations, as described in the plan document and SPD. A death benefit of \$10,000 is payable upon the employee's death to the designated beneficiary. Benefit payments are processed by third-party administrators for medical, prescription, dental and vision benefits. The third-party administrators process claims, except death benefit, submitted by participants, and determine the benefits to be paid based on the provisions of the Plan from assets of the VEBA trust.

## Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants and dependents, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, to the extent that funds are available from the Trust, any covered expenses which have been incurred prior to the date of termination will be payable in accordance with the terms and conditions of the Plan. Plan assets will first be allocated to the payment of claims, and thereafter in a manner that is for the exclusive benefit of the participants, except that any taxes and administrative expense may be paid from plan assets. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

## 2. Summary of Accounting Policies

### Basis of Accounting

The accompanying financial statements have been prepared using the modified cash basis of accounting which is a basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP).

### Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Payment of Benefits

Premiums paid by either the Plan or the Company and are recorded as premium payments in the accompanying Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis. Claim payments are recorded when paid to the third-party claims processor.

### Administrative Expenses

Administrative expenses may be paid in whole or in part by the Plan. Any expenses not paid by the Plan shall be paid by the Company. The payment of administrative expenses by the Company constitutes an exempt party in interest transaction as defined by ERISA. Administrative expenses paid by the Plan mainly relate to administrative service fees paid to the healthcare claims administrator, also a party in interest, and totaled \$474,857 for the year ended September 30, 2024, as included on the accompanying Statement of Changes in Net Assets—Modified Cash Basis.

## Stop-Loss Coverage/Reinsurance Claims and Receipts

The Plan entered into a stop-loss insurance agreement with an insurance company to limit its losses on individual claims. Under the terms of this agreement, the insurance company will reimburse the Plan claim amounts in excess of \$225,000 per covered person up to \$575,000 for an identified participant as noted per the agreement. The premiums paid for stop-loss insurance coverage is reported as expenses under Payments of Premiums to insurance entities in the accompanying Statement of Changes in Net Assets—Modified Cash Basis. Reimbursements in excess of the stop-loss provision, are reported as a reduction of Payments of Claims on the accompanying Statement of Changes in Net Assets—Modified Cash Basis. During the year ended September 30, 2024, stop-loss reimbursements received totaled approximately \$624,000 and are offset against the payments of claims on the accompanying Statement of Changes in Net Assets—Modified Cash Basis.

## Rebates

Rebates are recorded when received. Pharmacy rebates totaling \$38,866 have been netted with claims paid in the accompanying Statement of Changes in Net Assets Available for Benefits—Modified Cash Basis for the year ended September 30, 2024.

## Subsequent Events

Subsequent events were evaluated through July 14, 2025, the date the financial statements were available to be issued.

## 3. Benefit Obligations

Medical benefits payable and estimated claims incurred but not reported as of September 30, 2024 and 2023 were approximately \$1,300,000 and \$1,190,000 respectively. Plan obligations at September 30 for claims incurred but not reported are estimated by the Company based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment. Estimated claims incurred but not reported are estimates, which are based on claim run-off experience and are subject to uncertainty. The Plan's estimated liability for claims incurred but not reported or approved is estimated by utilizing claims paid subsequent to the financial statement date that were incurred prior to or on the financial statement date. The estimate also takes into consideration prior claims experience and the expected time period from the date such claims are incurred to the date that the related claims are submitted and paid.

## 4. Claims Paid

The claims paid by the Plan by major category, net of stop loss reimbursements and rebates discussed in Note 2, for the year ended September 30, 2024 are as follows:

## 5. Concentrations

The Trust currently maintains substantially all of its cash with one major financial institution. At times, these cash balances may be in excess of the federally insured limits. The Company's management believes the Plan's cash balances are held with a quality financial institution; the Plan has not experienced any losses for such accounts.

## 6. Related-Party and Party in Interest Transactions

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

## 7. Tax Status

The VEBA Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service (IRS) dated December 4, 1975, and the Plan's sponsor believes that the Trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the Trust. The Plan's management believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related Trust is tax-exempt.

The Plan's management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress. The Plan's management is aware of certain events of noncompliance and is in the process of remediation. The Plan's income tax returns are open to examination by applicable authorities, generally, for the prior three years for federal and four years for state. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
