Management has obtained a certification from a qualified institution as of and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Their report dated July 15, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

**NOTES TO FINANCIAL STATEMENTS  
September 30, 2024 and 2023**

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of Shiel Sexton Company, Inc. Employee Stock Ownership and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan was organized effective January 1, 2012, as a defined contribution retirement savings plan covering all eligible employees of Shiel Sexton Company, Inc. (the Employer). The Plan was restated in its entirety effective October 1, 2022, and currently consists of the following two components: 1) a stock bonus plan qualified under Internal Revenue Code (IRC) Section 401(a) which is designed to invest primarily in qualifying employer securities (the ESOP component) and 2) a qualified cash or deferred arrangement described in IRC Section 401(k) (the 401(k) component). The ESOP component of the Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Sections 4975(e)(7) and the regulations thereunder of the IRC. The Plan owns 100% of the outstanding shares of common stock of Shiel Sexton Company, Inc. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Benefits Committee, as appointed by the Employer's Board of Directors. The Benefits Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Employer's Board of Directors. TI-TRUST is the independent fiduciary that serves as the trustee of the ESOP component of the Plan. Newport Trust Company, LLC serves as the trustee of the 401(k) component of the Plan.

**Eligibility:** Covered employees are eligible to participate in the Plan at age 21. Entry into the 401(k) component of the Plan occurs on the first day of the month immediately following completion of one hour of service during a consecutive three-month period. Entry into the ESOP component of the Plan occurs the first day of the April or October following the completion of 1,000 hours of service during a consecutive 12-month period.

**Contributions:** Each year, participants may authorize the Employer to contribute to the 401(k) component of the Plan up to 100% of their eligible annual compensation, subject to the maximum annual amount permitted under Section 402(g) of the IRC. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from amounts representing distributions from other qualified plans and certain Individual Retirement Accounts (IRA) as defined in the Plan Agreement. Contributions are subject to certain limitations under the IRC.

The 401(k) component of the Plan includes an auto-enrollment provision whereby certain employees are automatically enrolled in the Plan unless an affirmative election not to participate in the Plan is executed. Automatically enrolled participants have their contribution rate set at 4% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. The Plan also provides for an automatic escalation provision in which a participant's auto-enrollment contribution rate will increase by 1% per year up to a maximum of 15% of eligible compensation until an affirmative election is made by the respective participant.

The Employer may elect to make discretionary matching and profit-sharing contributions to the 401(k) component of the Plan. In 2024, the Employer made matching contributions equal to 25% of the first 6% of compensation that each participant contributed to the Plan. No Employer profit-sharing contributions were made to the Plan in 2024.

## NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

The Employer may elect to make an ESOP contribution to the Plan as determined each year at the discretion of the Board of Directors. The Employer made an ESOP contribution to the Plan in 2024 and 2023 in the amount of \$2,822,815 and \$2,240,409, respectively. Generally, participants must be credited with at least 1,000 hours of service and be employed on the last day of a Plan year to be eligible for an allocation of Employer contributions.

Participants direct the investment of their contributions, as well as those made by the Employer to the 401(k) component of their accounts, into various investment options offered by the Plan.

**Participant Accounts:** The Plan is a defined contribution plan under which a separate individual account is established for each participant.

The ESOP component of each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Employer's common stock released by the Trustee from forfeitures of terminated participants' nonvested accounts. The ESOP component's earnings are allocated to each participant's account based on the ratio of the participant's account balance to total balance of all participants, as defined in the Plan Agreement.

The 401(k) component of each participant's account is credited with the participant's contributions and the Employer's profit-sharing and matching contributions, as well as allocations of the Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses of the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined in the Plan Agreement.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account, subject to certain restrictions as specified below under *Benefits*.

**Voting Rights:** The ESOP Trustee votes all of the Employer's common stock held as part of the Plan assets provided that the participant or participant's beneficiary is entitled to direct the ESOP Trustees as to the manner in which voting rights on shares of the Employer's common stock which are allocated to the participant's account are to be exercised with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets, or such similar transaction. If the participant does not exercise their right to vote the Employer's common stock, the ESOP Trustees will vote such shares along with any shares held in the Plan's suspense account on behalf of the collective best interest of Plan participants and beneficiaries, subject to the ESOP Trustees' fiduciary duties under ERISA.

**Vesting and Forfeitures:** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their account and in the ESOP component of their account is based on years of service. A participant becomes 20% vested after two years of service, increasing by 20% per additional year, with full vesting after six years of credited service.

At September 30, 2024 and 2023, forfeited nonvested accounts of terminated participants totaled \$31,144 and \$3,950, respectively. These accounts will be used to reduce future Employer contributions, pay Plan expenses, and/or be allocated or reinstated to the accounts of eligible participants, as defined in the Plan Agreement. In 2024, forfeited nonvested 401(k) accounts of \$8,925 were used to pay Plan expenses. Forfeitures from terminated participant's non-vested ESOP accounts are reallocated to participants. For the year ended September 30, 2024, approximately \$6,494 of forfeited shares and approximately \$51,546 in cash were reallocated to the remaining participants.

**Notes Receivable from Participants:** Participants may borrow from their 401(k) account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment terms of the notes cannot exceed five years except for the purchase of the participant's principal residence, for which the terms may exceed five years per the Plan Agreement. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through regular payroll deductions.

## NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

**Benefits:** Upon the occurrence of a distributable event due to separation from service by termination, death, disability, retirement, or other reasons, as defined by the Plan Agreement, a participant may elect to receive a partial payment or lump-sum cash distribution equal to the value of the participant's vested interest in the 401(k) component of their account. Hardship and in-service withdrawals, as well as required minimum distributions, rollover contribution account distributions, and automatic distributions to former participants, as defined in the Plan Agreement, are also permitted from a participant's 401(k) account.

Participant account balances in the ESOP component of the Plan are subject to special rules relating to the timing of distributions. Payment of a participant's vested ESOP account balance may not commence until the close of the Plan year following the Plan year in which a participant incurs a distributable event. A participant will receive a lump-sum cash distribution equal to the value of the participant's vested interest in their ESOP account balance subject to certain limits as defined in the Plan Agreement.

**Put Option:** Under federal income tax regulations, the Employer's common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to require the Employer to repurchase the Employer's common stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Employer can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Diversification:** Diversification is offered to participants close to retirement age so that they may have the opportunity to move part of the value of their investment in the Employer's common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. The election to diversify is made subsequent to year-end based upon the shares of the Employer's common stock in the participant's account at year-end. Participants who elect to diversify may elect to receive a cash distribution or to make a rollover to another eligible plan.

**Plan Termination:** Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in their accounts.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Benefits Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor, trustees, and valuation specialist. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Cash:** The Plan maintains cash in bank deposit accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts.

**Notes Receivable from Participants:** The Plan's notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of September 30, 2024 or 2023. If a participant ceases to make repayments and the Plan Administrator deems the note receivable from the participant to be in default, the balance of the note receivable from the participant is reduced and a benefit payment is recorded per the Plan Agreement.

**Payment of Benefits:** Benefits are recorded when paid.

**Expenses:** Administrative expenses for maintaining the Plan may be paid by the Employer or the Plan, at the Employer's discretion. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Tax Status:** The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated January 20, 2015 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other taxing authorities.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

**Reclassifications:** Certain amounts in the 2023 financial statements have been reclassified to conform to the presentation of the 2024 financial statements.

**Subsequent Events:** The Plan Administrator has evaluated the financial statements for subsequent events occurring through July 15, 2025, the date the financial statements were available to be issued. See Note 10.

## NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan has categorized its assets and liabilities that are measured at fair value into a three-level fair value hierarchy. The hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

### NOTE 4 - INFORMATION CERTIFIED BY THE TRUSTEE OF THE 401(k) COMPONENT OF THE PLAN (UNAUDITED INFORMATION)

Certain Plan information for the 401(k) component of the Plan related to investments and notes receivable from participants held at September 30, 2024 and 2023, and net appreciation or depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended September 30, 2024, disclosed in the accompanying financial statements and supplemental schedule was obtained by the Plan's management and agreed to or derived from information certified as complete and accurate by Newport Trust Company, LLC, the trustee of the 401(k) component of the Plan, in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### NOTE 5 - INVESTMENT IN EMPLOYER COMMON STOCK (AUDITED INFORMATION)

### NOTE 6 - PLAN AMENDMENT

Effective January 1, 2024, the Employer amended the Plan Agreement to increase the cash-out provision for individuals who have vested balances in the 401(k) or ESOP components of the Plan from \$5,000 to \$7,000.

#### **NOTE 7 - TERMINATED PARTICIPANTS**

Included in net assets (deficit) available for benefits are amounts allocated to terminated participants who have vested account balances but are not eligible for a withdrawal from the Plan until they reach retirement age, become disabled, or deceased. Net assets (deficit) available for benefits allocated to these individuals totaled \$6,734,242 and \$9,012,846 at September 30, 2024 and 2023, respectively.

#### **NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan has arrangements with several third-party service providers. The Plan pays certain expenses related to the Plan's operation, administration, and investment activity. The Plan's expenses may be paid directly to the respective service provider or indirectly through the Plan's investments returns. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

The Plan's assets include the Employer's common stock. Transactions in this investment qualify as exempt party-in-interest transactions.

The Employer provides certain accounting, administrative and investment management services to the Plan for which it receives no compensation.

Notes receivable from participants are permitted party-in-interest transactions.

#### **NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, primarily consisting of an investment in the Employer's common stock, which are exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment securities and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the investment securities, primarily the Employer's common stock, will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.

#### **NOTE 10 - SUBSEQUENT EVENT**

Effective October 1, 2024, the Plan Agreement was amended to change the name of the Plan to Structure Man Holding Company, Inc. Teammate Stock Ownership and 401(k) Plan.
