Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Hazen Research, Inc. Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Hazen Research, Inc. Employees' Stock Ownership Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

General – In 1966, Hazen Research, Inc. (HRI or the "Company") converted its employee profit-sharing plan to an employee stock ownership plan. During 1985, HRI initiated a leveraged buyout by the Plan of substantially all of its remaining outstanding stock. The leveraged buyout was completed in 1993 when paid in full. As of September 30, 2024 and 2023, approximately 96 percent of the Company's outstanding stock was held by the Plan.

Effective September 30, 2024, the Company approved an amendment to freeze the Plan.

The Plan is a defined contribution employee stock ownership plan covering all eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Hazen Research, Inc. is the Plan's sponsor and serves as Plan administrator.

Eligibility – Employees of the Company are eligible to participate in the Plan immediately upon hire. Participants must complete at least 1,000 or more hours of service annually in order to participate in a plan contribution and forfeiture allocation.

Contributions

Employer contributions – Each year, HRI contributes to the Plan 10 percent of its net profits, plus any additional discretionary amounts determined by HRI's board of directors, not to exceed 15 percent of the participants' qualified compensation. However, if such contributions are applied to loan payments, then a contribution, not to exceed 25 percent of the aggregate eligible participants' compensation, can be made. For the year ended September 30, 2024, the Company committed to make a \$200,000 cash contribution to the Plan, which is recorded as a Plan receivable on the statements of net assets available for benefits.

Contributions are subject to regulatory limitations.

Participant accounts – HRI's contribution is allocated among individual accounts established for each participant in proportion to the ratio that each participant's qualified compensation for the year compares to the qualified compensation of all participants for that plan year.

Vesting – The Company adhered to a vesting schedule for employees who were credited with at least one hour of service subsequent to October 1, 2007. The vesting increased by 10 percent per year for the first two years and then 20 percent per year for the remaining four years.

Effective September 30, 2024, all participant accounts were deemed fully vested, as a result of the freezing of the Plan.

Notes receivable from participants – The Plan allowed participants to obtain loans against their vested participant account balances. Loan applications were subject to plan committee approval. The plan committee documented every loan in the form of a promissory note. Every note was for at least \$1,000 up to a maximum equal to the lesser of \$50,000 or the greater of 50 percent of the participant's vested account balance or \$10,000. The notes receivable were secured by the balance in the participant's account and bore interest at the bank's prime rate plus 1.00 percent per annum, which was commensurate with local prevailing rates determined periodically by the plan administrator.

Effective March 1, 2024, the Plan was amended to disallow loans to participants. There were no participants with outstanding loan balances as of September 30, 2024 or 2023.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant (or their beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or five substantially equal annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Eligible participants receive cash and shares of HRI common stock equal to the vested amount of their account balances. Unpaid installments totaled \$706,722 and \$392,004 as of September 30, 2024 and 2023, respectively.

Put Option – Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over five years. The purpose of the put option is to ensure that the participant can ultimately obtain cash.

Diversification – Participants who have completed ten years in the Plan and who have attained age 55 may sell up to 25 percent of their shares of HRI stock acquired by the Plan subsequent to January 1, 1986, and can reinvest the proceeds in the Hazen Research, Inc. 401(k) Retirement Savings Plan. The qualified election period is the six-year plan period beginning with the later of the first plan year in which the participant becomes eligible or the first plan year beginning after December 31, 1986. In the sixth year, the participant may diversify up to 50 percent of his or her total shares of HRI stock that were acquired by the Plan subsequent to January 1, 1986. The participant's account balance must exceed \$500 in order to make this election. The election must be made within an administratively reasonable period of time after the close of each plan year during the qualified election period.

Forfeitures – Plan forfeitures are allocated to each participant's account based on the relation of the participant's qualified compensation to the total qualified compensation for the plan year. The amount forfeited will be deducted from the participant's cash balance first, and any remaining forfeitures will be deducted from the participant's HRI stock balance. If the participant is reemployed prior to five consecutive one-year breaks in service and returns any distribution previously made, the forfeited account balance will then be restored from income, gains, and forfeitures of the Plan or HRI contributions at the discretion of the plan committee. There were no forfeited nonvested accounts to be allocated to participant accounts as of September 30, 2024 and 2023.

Voting Rights – Each participant is entitled to exercise, in certain matters, voting rights attributable to the shares allocated to his or her account and is notified by the trustee, or person or persons appointed by the Company, prior to the time that such rights are to be exercised. The trustee shall vote any undirected shares in the same proportion and manner as the directed shares.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – Investments are stated at fair value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Payment of benefits – Participants eligible to receive benefits from the Plan are distributed the vested portion of cash and shares of HRI stock allocated to their individual participant accounts. Shares distributed are recorded at the estimated fair value as of the last regular valuation date preceding the date of distribution and are recorded when paid. The Plan, HRI, and other stockholders of HRI have a right of first refusal on the subsequent sale of any stock distributed to participants under the Plan. Participants receiving distributions of HRI stock have the option to sell such shares to the Plan within one year plus 60 days from the receipt of such stock distribution. If the Plan is unable to or refuses to purchase the distributed stock, HRI is required to purchase such stock at the fair market value.

Administrative Expenses – Administrative expenses of \$90,260 for the year ended September 30, 2024 were paid by the Company.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through July 15, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at September 30, 2024 and 2023.

Registered investment companies (mutual funds) and money market mutual fund – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

HRI Company stock – Fair value is determined annually by independent valuation specialists. The Company provides financial statement support for the valuation that the trustee approves. As of September 30, 2024 and 2023, the independent valuation specialists estimated the fair value of HRI company stock to be \$301.76 and \$215.13 per share, respectively.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no purchases, transfers, or issuances of Level 3 investments during the years ended September 30, 2024 and 2023.

The fair value of HRI company stock as of September 30, 2024, was determined based on the asset approach and the income approach. The asset approach used an adjusted book value method completed on an orderly liquidation basis. The income approach used both the discounted future cash flow and the capitalization of cash flow methods. The discounted future cash flow method is based on cash flow using a weighted-average cost of capital discount rate. The capitalization of cash flow method is based on a calculation of cash flow available to invested capital using a weighted-average cost of capital capitalization rate. The income approach models also used the fair value of operating real estate in their approach, which is an enhancement to these models. These approaches were weighted at 10, 45 and 45 percent, respectively.

The fair value of HRI company stock as of September 30, 2023, was determined based on the asset approach and the income approach. The asset approach used an adjusted book value method completed on an orderly liquidation basis. The income approach used the discounted future cash flow method based on cash flow using a weighted-average cost of capital discount rate. The model also used the fair value of operating real estate in its approach, which is an enhancement to this model. These approaches were weighted at 50 percent.

Note 4 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 4, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Party-in-Interest Transactions

The Plan invests in Company common stock. These are related party and party in interest transactions. The Company pays all administrative expenses. The Plan has several services providers. Such providers are parties in interest under ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA.
