**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

I have performed an audit of the financial statements of the Council of Three Rivers American Indian Center 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 30, 2024, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Council of Three Rivers American Indian Center 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of September 30, 2024, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion**

In my opinion, based on my audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

I conducted my audit in accordance with auditing standards generally accepted in the United States of America (GAAS). My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I am required to be independent of the Council of Three Rivers American Indian Center 403(b) Plan and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audit. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the

design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Council of Three Rivers American Indian Center 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of my report, my objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, I:

My audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that I identified during the audit.

**Supplemental Schedule Required by ERISA**

The supplemental schedule of assets held at end of year as of September 30, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the Council of Three Rivers American Indian Center 403(B) Plan (COTRAIC 403(B) Plan) provides only general information. Participants should refer to the 403(B) Adoption Agreement, and Summary Plan Description, for a more complete description of the COTRAIC 403(B) Plan's provisions.

General

The COTRAIC 403(B) Plan was established on October 1, 1992 and restated effective October 1, 2009. The plan is an Annuity Contract Plan authorized under Internal Revenue Code Section 403(b)(1) covering all employees of the Council of Three Rivers American Indian Center (the Center) who have completed one year of service, are age twenty-one or older, and who complete 1,000 hours of service per year. Employees who normally work less than twenty hours per week are excluded from the Plan. The COTRAIC 403(B) Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting is immediate in the Center's elective contribution.

Contributions

Each year, participants may elect to reduce their compensation by a specific percentage or dollar amount by making contributions to the Plan on a pre-tax basis. The Plan refers to these contributions as 'elective deferrals.' Total deferrals in any taxable year may not exceed a dollar limit that is set by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans subject to approval by the Plan Administrator. Participants direct the investment of their contributions into various options offered by the Plan. The Plan currently offers a variety of qualified variable annuities, administered by the Security Benefit Life Insurance Company, as listed in the supplemental schedule. Each year the Center makes discretionary 'elective' contributions to the Plan. During the 2023-2024 Plan year, the Center made discretionary elective contributions totaling 7.65% of the participant's compensation as defined in the Plan. The Center's elective contributions are invested directly into the qualified variable annuities administered by Security Benefit.

Participant Accounts

An individual account is maintained for each participant. Center and participant contributions are credited directly to the participant's account along with interest earnings from the variable annuity investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant, or their designated beneficiary, will receive distributions of their vested amount in accordance with the options available under the investment product.

Loans

The Plan permits participant loans. Participants are not entitled to borrow less than \$1,000 in any single loan. Loan interest is calculated at the current prime rate plus 1%. Loans issued during the 2023-2024 plan year totaled \$53,848. Participant loan balances as of September 30, 2024 totaled \$400,748.

2. SIGNIFICANT ACCOUNTING POLICIES

The accounting policies followed by the Plan and the method of applying those policies which materially affect the determination of net assets available for benefits and changes in net assets available for benefits are as follows:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets available for Plan benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The COTRAIC 403(B) Plan investments are comprised of qualified variable annuities as listed in the supplemental schedule valued at annuity contract value as provided by Security Benefit Life Insurance Company (Note 3). Interest is credited to each individual account on a quarterly basis. Interest rates paid by Security Benefit Life Insurance Company on amounts allocated to each participant's general account may be changed at the discretion of Security Benefits but cannot be less than the minimum guaranteed rate indicated in each individual participant's annuity contract.

Payments of Benefits

Benefits and withdrawals are recorded when paid.

Administrative Expenses

All significant expenses of maintaining the Plan are paid by the Council of Three Rivers American Indian Center and are not recorded as part of the COTRAIC 403(B) Plan.

3. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The COTRAIC 403(B) Plan entered into an agreement with the Security Benefit Life Insurance Company to provide tax-deferred retirement investment options to eligible employees of the Council of Three Rivers American Indian Center. Security Benefits maintains Center and participant contributions in a general account for each individual Plan participant. Each account invests in a corresponding mutual fund (underlying fund) as detailed in the supplemental schedule. The account is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses (anniversary processing fees). The contract is included in the financial statements at contract value as reported to the Plan by Security Benefits Life Insurance Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

4. INFORMATION CERTIFIED BY SECURITY BENEFITS

The following is a summary of the investment information as of September 30, 2024, and for the year ended September 30, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator by the Trustee related to the following investments is complete and accurate to the best of their knowledge. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under the ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following investments as of September 30:

As listed in the supplemental schedule, Security Benefit Life Insurance Company provides individual Plan participants with a variety of investment options relative to their qualified variable annuities. The fixed annuity investments totaling \$5,589,027 represent 76% of the Plan's total contract value as of September 30, 2024. The total contract value of the Plan's investments is comprised of the individual general account of each participant and their respective loan account if applicable.

5. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Authoritative guidance regarding *Fair Value Measurements* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I measurements) and the lowest priority to unobservable inputs (Level III measurements). The three levels of the fair value hierarchy under the authoritative guidance are described below:

- Level I            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level II            Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.
- Level III            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.


