Opinion

We have audited the accompanying financial statements of the Vigilant Manufacturers Trust Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of September 30, 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Vigilant Manufacturers Trust Plan (the Plan) as of September 30, 2024, and the changes in its net assets available for benefits and of changes in benefit obligations for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Prior Period Financial Statements

The financial statements of the Plan as of September 30, 2023, were audited by other auditors whose report, dated July 15, 2024, expressed an unmodified opinion on those financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Description of the Plan and Trust

The Vigilant Manufacturers Trust Plan (the Plan) was established on January 1, 2013. The Plan was established to provide programs of health and other welfare benefits for participating employers under the employee benefit plans they maintain for their employees and dependents. The following description of the Plan provides only general information. Participants should refer to the Plan documents, summaries, and other descriptive plan literature for a more complete description of the Plan's provisions.

This Plan is considered a “multiple employer welfare arrangement” as defined by the regulations promulgated under the Employee Retirement Income Security Act of 1974 (ERISA). ERISA regulations define a “multiple employer welfare arrangement” as an employee welfare benefit plan or any other arrangement, which is established or maintained for the purpose of offering or providing any welfare benefit to the employees of two or more employers, or to their beneficiaries. The types of benefits available under the Plan through September 30, 2024, are described as follows: medical, hospital, surgical, prescription drug, dental, vision, accidental death and dismemberment, and life benefits.

An employer is entitled to participate in the Plan once the employer has completed and filed a master application adopting the trust agreement, has been accepted for participation by the insurers, and has made all contributions required by the related trust. The employer must be engaged in the manufacturing industry in the geographic area covered by the Plan.

Each participating employer agrees to promptly remit contributions to the related trust to adequately cover the payment of insurance premiums for its participants and beneficiaries and its share of any reasonable and necessary obligations and expenses incurred during its participation. The Board of Trustees may bring action to collect contributions if coverage has been provided or if benefits have been paid, and no contributions or incorrect amounts of contributions have been paid.

Employer and participant contributions are received and held by the related trust pending payment of approved insurance premiums. Such contributions are determined pursuant to rules adopted by the Board of Trustees.

The endorsing sponsor of the Plan is Vigilant. During the years ended September 30, 2024 and 2023, the Plan and related trust were administered by the Board of Trustees, with the assistance of Vigilant Services, Inc. (a wholly owned subsidiary of Vigilant); Vimly Benefit Solutions, Inc., a contract administration organization; Brown & Brown Insurance Services, Inc. dba DiMartino Associates, a benefits consulting services firm; and Barlow Coughran Morales & Josephson, P.S., a legal services firm. Effective April 3, 2025, Barlow Coughran Morales & Josephson, P.S. was reorganized as Barlow & Coughran, P.S. Financial statement accounting and auditing services are provided by Anastasi, Moore & Martin, PLLC and Schoedel & Schoedel, PLLC for the years ended September 30, 2024 and 2023, respectively. The Plan is marketed to employers by various insurance brokers.

Note 2 – Summary of Significant Accounting Policies

The summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are the representations of the Board of Trustees, who is responsible for the integrity and objectivity of the financial statements.

Note 2 – Summary of Significant Accounting Policies (Continued)

These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

- a. **Basis of accounting** – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Board of Trustees to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- c. **Noninterest-bearing cash** – Noninterest-bearing cash includes cash on hand and noninterest-bearing demand deposits held at financial institutions.
- d. **Interest-bearing cash** – Interest-bearing cash includes investments which are not subject to withdrawal restrictions and can be converted to cash on short notice. Interest-bearing cash includes interest-bearing demand deposits held at financial institutions, money market accounts, and certificates of deposit.
- e. **Investment valuation** – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.
- f. **Contributions recognition** – Employer and participant contributions are recognized as the Plan becomes obligated for the payment of insurance premiums. Therefore, contributions received after September 30 for benefits provided before the beginning of the subsequent year are recognized as contributions receivable. On the other hand, contributions received before September 30 for benefits provided in the subsequent year are recognized as unearned.
- g. **Payment of insurance premiums** – Insurance premiums are recognized when paid.
- h. **Subsequent events** – Subsequent events have been evaluated through July 10, 2025, which is the date the financial statements were available to be issued.

Note 3 – Income Tax Status

The Trust established under the Plan to hold the assets of the Plan is qualified as a tax-exempt organization under Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the net investment income of the Trust is exempt from income taxes. The Trust obtained its latest tax determination letter from the Internal Revenue Service (IRS) with an effective date of exemption for tax years ending after July 15, 2019, in which the IRS stated that the Trust, as then designed, was in compliance with the applicable requirements of the IRC. The Board of Trustees and legal counsel believe the Trust and related Plan are designed and have been operated through September 30, 2024, in accordance with applicable provisions of the IRC.

Note 3 – Income Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the tax-exempt status; however, there are currently no audits for any tax periods in progress.

Note 4 – Priorities Upon Termination

The Plan may be terminated at any time by action of the Board of Trustees. Upon the termination of the Plan, the Board of Trustees will conclude the affairs of the Plan. Where the termination occurs as a result of a merger, any and all monies and assets remaining in the Plan, after the payment of expenses, will be transferred to the trust fund with which the merger has been negotiated. With respect to any other termination, any and all monies and assets remaining in the Plan, after the payment of expenses, will be used for the continuance of the benefits provided by the then existing benefit plans, until such monies and assets have been exhausted. In no event will any of the remaining monies or assets be paid to or be recoverable by any participating employer, or paid in cash to participating employees, unless such disposition is required by applicable laws.

Note 5 – Risks and Uncertainties

In determining the fair value of financial instruments, the Board of Trustees uses a variety of methods and assumptions that are based on market conditions and risks existing at the date of the statement of net assets available for benefits. All methods of assessing fair value result in a general approximation of value, and such value may never actually be realized.

Currently, the Plan operates as a fully insured arrangement and, therefore, is contracted with particular insurance carriers. In the Plan's service area, there is a limited number of qualified insurance carriers willing and capable of meeting the Plan's insured benefit needs.

The Plan maintains accounts at one financial institution which, as of September 30, 2024, are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, the Plan's cash balances may exceed the FDIC insurance limit.

The Plan and related insurance carriers face an increasingly challenging regulatory environment. Certain interpretations of laws, rules and regulations could potentially result in adverse effects to the Plan. However, it is not expected that the Plan will significantly change operations or terminate prior to September 30, 2025.

Note 6 – Noninterest-bearing Cash and Interest-bearing Cash

As of September 30, 2024 and 2023, noninterest-bearing cash consisted of a checking account at Heritage Bank totaling \$196,035 and \$182,382, respectively. The checking account has an interest-bearing business sweep account attached to it. Heritage Bank manages the related accounts in order to maintain the majority of the funds in the sweep account, while ensuring that adequate funds are present in the checking account to cover checks written as they are presented for payment.

As of September 30, 2024 and 2023, interest-bearing cash consisted of a business sweep account at Heritage Bank totaling \$1,743,917 and \$1,633,325, respectively.

Note 7 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 7 – Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Level 1 – The fair value of interest-bearing cash is based on the closing price reported on the active market in which the individual securities are traded.

Level 2 – The Plan has no investments that are classified as Level 2 at September 30, 2024 or 2023.

Level 3 – The Plan has no investments that are classified as Level 3 at September 30, 2024 or 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 8 – Related-party Transactions

Vigilant Services, Inc. (VSI), a wholly owned subsidiary of Vigilant, performs consulting and administration services for the Plan. Additionally, an employee of VSI serves as an unpaid trustee of this plan. For the years ended September 30, 2024 and 2023, the Plan recognized expenses totaling \$286,974 and \$301,750, respectively, for such services. As of September 30, 2024 and 2023, amounts due to VSI totaled \$2,148 and \$1,328, respectively.
