Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the **Global Information Systems, LLC 401(k) Profit Sharing Plan and Trust** (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) [“ERISA Section 103(a)(3)(C) audit”]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL’s”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

(1) **DESCRIPTION OF PLAN**

The following description of the **Global Information Systems, LLC 401(k) Profit Sharing Plan and Trust** (the “Plan”) provides only general information. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Global Information Systems, LLC and affiliates (the “Company”). An employee may join the Plan immediately upon one hour of service and attainment of age 21. The Plan is subject to the provisions of ERISA. The Plan trustees are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

Participants may make pre-tax and after-tax Roth elective salary deferrals up to 100% of eligible compensation, as defined in the plan document, subject to limitations imposed by Internal Revenue Code (“IRC”) regulations. Eligible participants are also permitted to make catch-up contributions in accordance with IRC regulations, and may roll over contributions representing distributions from other qualified defined benefit or contribution plans.

The Company made discretionary matching contributions for the plan years ended December 31, 2024 and 2023 equal to 50% of each participant’s deferrals, limited to 6% of eligible compensation.

Effective for employees who become eligible participants on or after January 1, 2016, the Plan automatically withholds 6% of the employee’s pay on a pre-tax basis. Employees can opt out of the Plan’s automatic enrollment provisions by providing written notice to the plan administrator. Automatically enrolled participants have their contributions invested in a designated lifestyle fund until the investment election is changed by the participant.

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a group annuity contract as investment options for participants. Participants may change their investment elections at any time.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of plan earnings, and charged with an allocation of plan losses and administrative expenses. Allocations are based on participant compensation, account balances or specific transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Prior to July 1, 2012, participants were immediately vested in the Company's discretionary contribution portion of their accounts plus actual earnings thereon. Effective July 1, 2012, vesting in employer discretionary contributions is based on years of continuous service. Participants are 100% vested in any employer discretionary contributions after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Loan terms can be up to five years and participants are limited to one loan outstanding at a time. The loans are secured by the remaining vested balance in the participant's account and bear interest at a fixed rate of prime plus 1% on the loan origination date. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, participants may elect to receive a lump sum amount equal to the value of their vested account balance. The Plan also provides for in-service distributions for participants that have attained age 59½ or for financial hardships. Separated participants with vested account balances exceeding \$5,000 may elect to defer benefits until reaching normal retirement age.

Forfeited Accounts

Participants forfeit employer contribution accounts when terminating service prior to vesting in their employer contributions. These accounts will be used to reduce future employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7 and \$93, respectively. Forfeited nonvested accounts of \$15,630 and \$14,239 were used to reduce employer contributions for the years ended December 31, 2024 and 2023, respectively.

(2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for additional discussion of fair value measurements and Note 9 for additional discussion of fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Capital gain distributions from mutual funds are included in dividend income. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for these investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. At December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. The interest rate on notes receivable from participants outstanding at December 31, 2024 ranged from 5.00% to 9.50%.

Administrative Expenses

Some administrative expenses are paid by the Company and some are paid by the Plan. Those that were paid by the Plan are reflected in the accompanying financial statements. Employees of the Company perform certain administrative functions for the Plan. Neither the Company nor its employees receive compensation from the Plan.

Payment of Benefits

Benefits are recorded when paid. At December 31, 2024 and 2023, there were no allocated amounts to participants who had elected to withdraw from the Plan, but had not yet been paid.

Subsequent Events

Management has evaluated whether any subsequent events that require recognition or disclosure in the accompanying financial statements and related notes thereto have taken place through July 3, 2025, the date these financial statements were available to be issued.

(3) FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observed for the asset; or inputs that are derived principally from or can be corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs are used only if Level 1 or Level 2 inputs are not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation techniques and related inputs used for assets measured at fair value at December 31, 2024 and 2023.

Mutual Funds

The fair value of mutual funds is based on the quoted net asset value (“NAV”) of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the United States Securities Exchange Commission. The funds must publish their daily NAV and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

(4) RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are interests in a group annuity contract managed by Transamerica Life Insurance Company (“Transamerica”). Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Administrative fees paid by the Plan to Transamerica and its affiliates were \$24,440 and \$23,911 for the years ended December 31, 2024 and 2023, respectively.

(5) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

(6) TAX STATUS

The Plan is based on a pre-approved plan that has received a favorable opinion letter from the IRS dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the IRC. The plan sponsor has not separately applied for a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(7) RISKS AND UNCERTAINTIES

The Plan invests in mutual funds and a group annuity contract. The investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with the investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from Reliance Trust Company, the custodian of the Plan, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information is complete and accurate.

(9) **GROUP ANNUITY CONTRACT**

The Plan offers participants the option to invest in the Transamerica Stable Value Focus Account (the "Stable Value Fund"). Transamerica maintains the contributions in a general account, and is contractually obligated to repay the principal and a specified rate of interest. The contract is fully benefit responsive and investment contracts held in the Stable Value Fund are recorded at contract value. Contract value represents contributions made, less withdrawals and administrative expenses, and interest credited, and represents the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. Daily liquidity at contract value is generally available for participant contributions and withdrawals.

There are no reserves against contract value for credit risk of Transamerica or otherwise. The contract value of the group annuity contract at December 31, 2024 and 2023 was \$589,123 and \$758,564, respectively, which approximates fair value. The effective credited interest rate is set semi-annually by Transamerica and interest is credited daily, based on the beginning daily balance. The average yield earned by the Plan from the Stable Value Fund was 2.05% and 1.65% for the years ended December 31, 2024 and 2023, respectively. There is no minimum guaranteed interest rate under the contract.

Certain events such as a plan merger or termination could limit the ability of the Plan to transact at contract value with Transamerica. Upon occurrence of any such event, a market value adjustment or withdrawal restrictions may apply. The plan administrator was not aware of any events that would have limited the Plan's ability to transact at contract value at December 31, 2024 and 2023.
