Opinion

NOTES TO THE FINANCIAL STATEMENTS

SEPTEMBER 30, 2024 AND 2023

Note 1—Description of the Plan

The following description of the JTS Enterprises of Tampa, Ltd. Healthcare Benefit Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan’s provisions.

General – The Plan was established to provide certain life, medical, and dental care treatment, disability, accidental death, and other benefits to eligible employees of JTS Enterprises of Tampa, Ltd. and Subsidiaries; OCHG, LLC; Oxford Exchange, LLC; Oxford Exchange Design Studio, LLC; Library JV, LLC; Caspers Service Company, LLC; The Stovall House Club, LLC; Predalina, LLC; and Mad Dogs 2.0 LLC (collectively, the “Employer”, the “Sponsor”, or the “Company”) and their dependents. The Plan, funded through the JTS Enterprises of Tampa, Ltd. and Affiliates Employee Benefits Trust (the “Trust”), is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The responsibilities of the Sponsor include the determination of benefit rights, authorization of payment of benefits, and development of rules and regulations as it may deem necessary to carry out the provisions of the Plan and reimbursement of all claim payments made on behalf of the Plan.

Plan Termination – Effective October 1, 2024, subsequent to the Plan year-end, the trustees of the Plan decided to terminate the trust underlying the Plan. The assets and liabilities of the Plan were already reported at their net realizable values and, as such, no adjustments were required in connection with the termination of the Plan.

Benefits – Subject to specific limitations, the Plan provides certain health benefits for: (1) full-time, permanent employees who work a minimum of 30 hours per week and have met the Plan’s service requirements, and (2) for part-time employees who average at least 30 hours per week during a 12-month measurement period, are currently in a stability period (as defined by the Plan), and have met the Plan’s service requirements. Employees with at least 60 days of service are eligible for medical, prescription drug, dental, and disability benefits, and become eligible for life insurance after 90 days of service. Benefits include the payment of doctor, dental, vision care, hospital, pharmacy, and surgical expenses. Benefits also include disability benefits up to 13 weeks determined as a percentage of compensation, life insurance, professional counseling services, and accidental death and dismemberment benefits ranging from \$10,000 to \$50,000 depending on employee classification.

Contributions – Contributions are made by the Sponsor and eligible employees who voluntarily participate in the Plan. Employee contributions are based on fixed monthly charges for each type of coverage. Employer contributions are made in amounts necessary to fully fund the Plan.

Insurance – The Plan maintains an excess risk group health insurance contract which was underwritten by Symetra Life Insurance Company for the year ended September 30, 2024. A specific-risk clause is in force which limits the annual liability of the Plan for any claim to a maximum of \$150,000. Medical claims that exceed this amount are reimbursed by the respective underwriter. There is no aggregate risk group health or disability insurance in force. The Plan also maintains life and accidental death and dismemberment insurance, which fully covers its obligations. Premiums paid are included in insurance premiums in the accompanying statement of changes in benefit obligations and net assets available for benefits. Reimbursements received of approximately \$179,000 during the Plan year have been netted with benefits paid in the accompanying statement of changes in benefit obligations and net assets available for benefits.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Plan Benefit Obligations – Plan benefit obligations have been determined based on: (1) claims due and payable plus, and (2) a provision for claims incurred but not reported (“IBNR”). IBNR was actuarially determined by the Plan’s independent consulting actuary based upon average number of anticipated employees and their dependents, economic trends, past claim experience, and other related factors. Due to the subjective nature of the estimate for IBNR, it is reasonably possible that a change in the estimate may occur in the near term, and those changes could be significant. There have been no substantial changes in the trend rate assumptions discussed above through the date the financial statements were available to be issued. Plan benefit obligations are paid by the Plan when claims are submitted and approved for payment.

Contributions Receivable – The Plan contributions receivable are contributions to be made by the Plan Sponsor to fund the Plan’s benefit obligations and were received subsequent to the fiscal year-end.

Administrative and Other Operating Expenses – Administrative and other operating expenses consist of administrative expenses, banking fees, and accounting expenses.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events – Management has considered subsequent events through July 14, 2025, in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued. See discussion above regarding the *Plan termination*.

Note 3—Concentration of credit risk

The Plan is subject to concentrations of credit risk due to periodic balances of interest-bearing cash in excess of federally insured limits and the majority of the Plan contributions being funded by the Sponsor.

The Plan places its cash on deposit with financial institutions in the United States. The Federal Deposit Insurance Corporation covers up to \$250,000 for substantially all depository accounts. The Plan from time to time may have amounts on deposit in excess of the insured limits. As of September 30, 2024, the Plan has no deposits that exceed these insured amounts.

Note 4—Plan termination

As discussed in Note 1, the Plan was terminated effective October 1, 2024. The Plan will continue until such time as the remaining benefit obligations incurred through the termination date are paid.

Note 5—Income tax status

The Trust, established under the Plan to hold the Plan’s assets, obtained its latest determination letter on November 24, 1981 at which time the Internal Revenue Service stated the Trust, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”) and, as such, is exempt from taxes. The Trust has been amended since receiving the determination letter; however, the Plan administrator believes the Trust is currently designed and being operated in compliance with the applicable requirements of the IRC.

Note 6—Party-in-interest transactions

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption applies. PNC Bank, N.A. is the “Custodian” of the Plan’s assets and is considered a party-in-interest, as defined by ERISA; however, transactions with the Custodian is exempt under Section 408 (b)(8) of the IRC and are not prohibited by ERISA.
