

Notes to Financial Statements

Note 1 – Description of Plan

The following description of the CBIZ Insurance Trust (the Trust) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General

The Trust provides fully insured health and other benefits to substantially all full-time active employees of several employers that participate in the Trust (the Sponsors).

Benefits

The Trust provides health benefits (medical, prescription drugs, dental, and vision), disability benefits, and life insurance coverage to full-time employees of the Sponsors and to their beneficiaries and covered dependents.

Blue Cross Blue Shield of Alabama, and United Healthcare provide medical and prescription drug benefits under a group insurance contract. Cigna, Aetna and MetLife provide dental benefits under a group insurance contract. MetLife and VSP Vision Care provide vision benefits under a group insurance contract. Short-term disability, long-term disability, life, and other related benefits are administered by Cigna and MetLife.

Contributions

Participants contribute specific amounts, determined by the individual Sponsors, and the Sponsors contribute the balance of insurance premiums. If a deficit should occur each Sponsor would be responsible for their respective portion of the obligation.

Eligibility

Participants are eligible for benefits based on each Sponsor's requirements. The benefits are for full time employees so there is no vesting period once eligible.

Administrative Expenses

A portion of the administrative expenses of the Trust are paid by the Sponsors.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are presented on the accrual basis of accounting in accordance with generally accepted accounting principles.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Concentrations of Credit Risk

The Trust's financial instruments that may be exposed to concentrations of credit risk consist primarily of temporary cash investments.

CBIZ Insurance Trust

Notes to Financial Statements

The Trust maintains its cash balances at a financial institution. At times such investments may exceed federally insured limits. The Trust has not experienced any losses in such accounts. The Trust believes it is not exposed to any significant credit risk on cash.

Subsequent Events

Management of the Plan has evaluated subsequent events through July 15, 2025, which is also the date the financial statements were available to be issued. No subsequent events were noted during this evaluation that require recognition or disclosure in these financial statements.

Note 3 – Trust Termination

Trust Termination

Although it has not expressed any intent to do so, the trust administrator may terminate the Trust by sending written notice to the trustees. Once the Trust has determined to terminate, the insurance contracts would be terminated and benefits would stop in accordance with the written notice. All additional payments or assets submitted by Sponsors would be returned to each sponsor in the amount of excess contributions or assets left over by the Trust at the termination date.

Note 4 – Plan Merger

On July 9, 2024, the Tech Systems health and welfare plan was merged into the Trust. Prior to the merger, the Tech Systems plan was an individual custodial account managed by CBIZ. The transferred assets resulted in an increase in cash of \$18,812 and an increase in accrued liabilities of \$18,812.
