INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of
Northern California Bakery Drivers' Security Fund:

Opinion

We have audited the financial statements of Northern California Bakery Drivers' Security Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and benefit obligations as of September 30, 2024 and 2023; and the related statements of changes in its net assets available for benefits and of changes in benefit obligations for the years then ended; and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of Northern California Bakery Drivers' Security Fund as of September 30, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Northern California Bakery Drivers' Security Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Northern California Bakery Drivers' Security Fund's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. DESCRIPTION OF THE PLAN

The Plan was established during 1952, pursuant to a Trust Agreement (amended and restated in December 1994) entered into by parties to an area-wide collective bargaining agreement between local unions affiliated with the International Brotherhood of Teamsters and employers in the baking industry in Northern California.

General eligibility rules under the Plan are as follows:

- a. Initial eligibility requires at least 80 hours to be worked in each of any three months during the immediate prior 12 calendar months.
- b. To maintain eligibility, an employee must work at least 80 hours in the preceding month, providing that employer contributions are made on the employee's behalf.

The purpose of the Plan is to provide health, welfare, and life insurance benefits for present and retired employees and their dependents. Plan participants have the option of receiving medical benefits either directly from the Plan or from one of several prepaid health maintenance organizations. Life insurance and accident and sickness coverage are provided through a group contract with ReliaStar Life Insurance Company. The Plan also provides for dental, prescription drug, and vision benefits on behalf of eligible participants, as specified in the Plan.

Employees may contribute specified amounts, determined periodically by the Plan's actuary, to extend coverage to eligible dependents. The costs of the post-retirement benefit plan are shared by the Plan's participating employers and retirees. In addition to deductibles and co-payments, 84% and 89% of the estimated cost of providing post-retirement benefits in the current and prior year, respectively, were funded through retiree contributions.

Continuation of health-care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act ("COBRA"), has been adopted by the Plan.

Participants should refer to the Summary Plan Description for more complete information.

2. DESCRIPTION OF THE PLAN SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The accompanying financial statements of Northern California Bakery Drivers' Security Fund (the "Plan") are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation, Transactions, and Income Recognition

General - Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets, or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities' own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods - In determining fair value, FASB ASC 820 allows various valuation approaches. The specific method used for the Plan's investment class is presented below.

Mutual Funds: The Plan's investments in mutual funds are valued using quoted market prices in active markets (Level 1).

Valuation Methods, Consistency - The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition - Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Related Receivables

Employer contributions are when recognized when earned. Participant contributions are recognized in the month for which benefit coverage is provided. Employer contributions due and not paid at year-end are recorded as employer contributions receivable. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

Deferred Revenue

Contributions from certain participants received in September and prior months, for eligibility in October and subsequent months, are recorded as deferred revenue.

Payment of Benefits

Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Benefit Obligations

Claims payable and claims incurred but not reported were estimated by the Plan's consultant based on claims experience. Accumulated eligibility credits were estimated by the Plan's consultant and represent an estimate of one month of average benefit expenses less retiree benefit and administration costs. Premiums payable are an estimate of premiums due but not paid as of September 30 for each year presented.

Post-Retirement Benefit Obligations

Post-retirement benefit obligations are computed by the Plan's actuary as the net cost to the Plan and consider future contributions to be received from current participants during their remaining active service and post-retirement periods.

Stop-Loss Claim Recovery Receivable

Stop-loss claim recoveries earned and not yet received prior to year-end are recorded as receivables.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The actuarial present value of post-retirement benefit obligations is calculated based on certain assumptions pertaining to interest rates, participant demographics, and other assumptions, all of which are subject to change. Due to the inherent uncertainty of the assumption process, it is at least reasonably possible that changes in these assumptions in the near term would be material to the disclosure to the financial statements of the actuarial present value of post-retirement benefit obligations.

The Plan invests in mutual funds. Such investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Plan obtained its latest determination letter, dated March 20, 1979, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan's administrator believes that the Plan was qualified, and the related trust was tax exempt, as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of September 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's administrator believes the Plan is no longer subject to income tax examinations for the fiscal years prior to 2021.

5. FUNDING POLICY

The Plan is financed by employer and retiree contributions and from members electing COBRA coverage. The monthly employer contribution rate is specified in the collective bargaining agreements. The monthly retiree and COBRA contribution rates are determined annually by the Board of Trustees in consultation with the Plan's consultant.

6. CASH CONCENTRATIONS

The Plan has significant cash balances at financial institutions which throughout the year regularly exceed the federally insured limit of \$250,000. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's financial condition, results of operations, and cash flows.

7. POST-RETIREMENT BENEFIT OBLIGATIONS

The Plan provides health-care coverage to certain retirees and their dependents. Certain benefits provided to retirees, reflected in the statements of benefit obligations, are being funded by current employer contributions and monthly co-payments from retirees. Although these benefits were provided by the Plan for the current fiscal year, they are not guaranteed. The Board of Trustees reserves the right to reduce or discontinue these benefits or to increase the employer contributions and/or co-payments required to fund these benefits.

The amount reported as post-retirement benefit obligations represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' services rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Post-retirement benefit obligations include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, post-retirement benefit obligations are the portion of the expected post-retirement benefit obligations that are attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected post-retirement benefit obligations is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The increase in post-retirement benefit obligations due to changes in actuarial assumptions and methods (approximately \$2.24 million) is due to the following changes: 1) the demographic rates were updated to those in the latest non-seasonal actuarial valuation of the Western Conference of Teamsters Pension Plan, 2) the medical trend rate assumptions for indemnity and Kaiser were increased and 3) the discount rate was decreased from 5.75% to 5.00% (per the change in available rates of return from last year).

Effective January 1, 2024, the Plan was amended to lower the indemnity medical plan participants' annual out-of-pocket limit from \$5,000 to \$1,000. The net impact of the plan changes was \$525,400 increase in post-retirement benefit obligations as of September 30, 2024.

The trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the post-retirement obligation as of September 30, 2024 and 2023, by \$851,300 and \$208,900, respectively.

8. MAJOR EMPLOYERS

During the years ended September 30, 2024 and 2023, the Plan had one employer that accounted for approximately 98% in both years, of employer contributions. In the event this employer suspends contributions, the Plan would terminate coverage to the employers' participants, as required under the Plan document. The Plan would retain the risk of current fixed administrative expenses until the appropriate adjustments were made.

9. STOP-LOSS INSURANCE POLICY

The Plan has a stop-loss insurance policy under which certain medical and prescription drug benefits are paid. If the claims paid on behalf of an eligible participant or dependent exceed \$350,000 and \$325,000 for the policy years effective January 1, 2024 and 2023, the carrier will reimburse the Plan for the excess benefits. In accordance with the terms of the insurance arrangement, the annual maximum amount is unlimited. For the years ended September 30, 2024 and 2023, the Plan received \$1,468,032 and \$244,303, respectively.

During the years ended September 30, 2024 and 2023, the Plan did not have any experience refunds from the stop-loss insurance carrier. Per the stop-loss insurance policies effective January 1, 2024 and 2023, the Plan will receive an experience refund if, at the end of the policy period, certain premiums exceed the stop-loss claim recoveries. There is no guarantee that this will occur every year, as it is based on the experience of the claims paid, and the amount cannot be reasonably estimated.

10. INSURANCE AND OTHER REFUNDS

During the years ended September 30, 2024 and 2023, the Plan received rebates from OptumRx, Inc. totaling \$571,396 and \$323,175, respectively. OptumRx, Inc., on behalf of the Plan, has entered into rebate programs with drug manufacturers, which have products on the drug formulary system. On a quarterly basis, all rebates collected are remitted to the Plan by OptumRx, Inc.
