Opinion

We have audited the accompanying financial statements of Atlanta Ironworkers Local #387 Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of September 30, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Basis for Opinion

NOTE 1 DESCRIPTION

The following description of the Atlanta Ironworkers Local #387 Welfare Fund provides general information only. Participants should refer to the Plan Agreement for more complete information.

General – The Plan was formed pursuant to a Collective Bargaining Agreement between The Association of Steel Erectors and Heavy Equipment Operators, Inc. and International Association of Bridge, Structural, Ornamental and Reinforcing Ironworkers Local Union #387. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits – The plan provides vision, life, accidental death and dismemberment and short-term disability benefits to eligible participants and their dependents.

Eligibility - Eligibility to participate in the Plan is based upon the eligibility requirements of the companion Southeastern Ironworkers Health Care Plan.

An employee becomes eligible for benefits on the first day of the benefit quarter following the date on which contributions for a minimum of 750 hours are made during any consecutive twelve months period.

Continued qualifying requires a minimum of 375 hours of contributions in each qualifying quarter. The qualifying and benefit quarters are as follows:

<u>Qualifying Quarter</u>	<u>Benefit Quarter</u>
January through March	July through September
April through June	October through December
July through September	January through March
October through December	April through June

Contributions – Plan benefits are funded by contributions from employers, pursuant to collective bargaining agreements, based upon the number of journeymen hours worked. The employer contribution rate is \$.43 per hour.

Other – The Board of Trustees have the right under the Plan to discontinue or modify the requirements for participation in the Plan, eligibility of participants, type of benefits offered, amount to be paid and procedures for payment of benefit claims. The Plan may be terminated by joint agreement by the Board of Trustees, subject to the provisions set forth in ERISA.

NOTE 2 SUMMARY OF ACCOUNTING POLICIES

This summary of accounting policies and information of Atlanta Ironworkers Local #387 Welfare Fund is presented to assist in understanding the Plan's financial statements.

Method of Accounting – The accounts of the Fund are maintained on the cash basis of accounting. Memorandum entries have been applied to the cash basis accounts to present them on the accrual basis for financial reporting purposes.

Use of Estimates – The presentation of financial statements requires the trustees to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Cash Concentration Credit Risk – The Fund maintains its cash in bank deposit accounts at a high credit, quality financial institution. The balances, at times may exceed federally insured limits. Balances are insured by the Federal Deposit Insurance Corporation up to \$250,000.

Valuation of Investments and Income Recognition – Investments are valued as fair value. Quoted market prices are used to value investments. See Note 3.

Contributions Receivable – Contributions receivable were determined by a review of cash collections in subsequent periods. Accordingly, an allowance for uncollectible contributions is not considered necessary.

Employer contributions receivable totaled \$36,166 and \$39,356 for 2024 and 2023 respectively. Delinquent contributions receivable may exist at September 30, 2024 and 2023, however due to the uncertainty of the amount and collectability no receivable has been recorded.

The Plan maintains an on-going payroll compliance audit program to collect these amounts and monitor reporting compliance.

Contribution Concentration Risk – For the year ended September 30, 2024 approximately 62% or \$250,000 of total contributions was received from three employers. As of September 30, 2024, amounts due from these employers totaled \$17,353.

For the year ended September 30, 2023, approximately 65% or \$186,000 of total contributions was received from three employers. As of September 30, 2023, amounts due from these employers totaled \$21,726.

Operating Expenses - The Fund's expenses are paid by the Fund, as provided by the Plan document. Operating expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

NOTE 2 SUMMARY OF ACCOUNTING POLICIES (continued)

Income Taxes – The Fund is exempt from income taxes under the Internal Revenue Code.

Management has evaluated the tax positions taken by the Fund and concluded that as of September 30, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Reclassification – The 2023 financial statements have been reclassified to conform to the current year's presentation. There was no effect to the net assets available for benefits as a result of the reclassification.

NOTE 3 INVESTMENT, at Fair Value

Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Financial Accounting Standards Board (FASB) has established a framework to provide a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at September 30, 2024.

Registered Investment Companies (Mutual Funds): Valued at the net asset value (NAV) of the shares held by the Fund at year end.

NOTE 4 BENEFIT OBLIGATIONS

The Plan provides eligibility and benefit periods in three month increments based upon calendar quarters. There is a three - month lag period between the qualifying and benefit period. Plan benefit obligations at September 30, 2024 and 2023 are based upon accumulated eligibility of participants and are estimated at \$48,000 and \$42,000 for 2024 and 2023 respectively.

NOTE 5 RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

The Plan pays operating expenses directly to service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE 6 RISK AND UNCERTAINTIES

The Fund invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 7 SUBSEQUENT EVENTS

In preparing these financial statements, the impact of events and transactions for potential recognition or disclosure through July 10, 2025 were evaluated.
