**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Poulin Grain, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(c) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### (1) DESCRIPTION OF THE PLAN

The following description of the Poulin Grain, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

- (a) General – The Plan is a defined contribution plan covering all full-time employees of Poulin Grain, Inc. (the “Company”) who have reached the age of 18. There is a two-month service requirement to become a participant in the Plan. Participants are eligible to enter the Plan and begin making salary deferrals on the first day of the month following when eligibility has been met. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Employee Contributions – Participants may contribute up to 100% of eligible compensation as defined in the Plan, limited to a maximum amount as periodically set by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the plan year may contribute an additional amount set by the IRS. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans.
- (c) Employer 401(k) Matching Contribution – The Company makes a safe harbor matching contribution each payroll period for each employee who enters into a salary reduction agreement. During 2024 and 2023, the match equaled 100% of the first 3% deferred by participants and 50% of the next 2% deferred by participants.
- (d) Discretionary Profit-Sharing Contributions – The Company may also contribute a discretionary profit-sharing contribution for each employee. To be eligible for the discretionary profit-sharing contribution, a participant must be employed on the last day of the year and complete a year of service for that year. The discretionary profit-sharing contribution is allocated based on a participant's eligible compensation relative to total eligible compensation as outlined in the Plan Document. Total discretionary profit-sharing contributions, net of forfeitures, amounted to \$133,580 and \$138,068 in 2024 and 2023, respectively.
- (e) Participant Accounts – Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contribution, and allocation of (a) the Company's discretionary profit sharing contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested account balances. Allocations are based on a participant's eligible compensation relative to total eligible compensation, deferred contribution amounts or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant determines the investment strategy of their account as provided by the Plan.
- (f) Vesting – Participants are immediately vested in their voluntary and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's other contributions of the participant's account plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two years of credited service, with an additional 20% per year thereafter until fully vested. Upon normal retirement age, death or disability, a participant becomes fully vested.

(g) Payments of Benefits – On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive distributions equal to the value of the participant's vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, or leave the funds in the Plan until retirement age or transfer to a trustee of another qualified plan or individual retirement account. If the terminating employee's non-forfeitable account balance is less than \$1,000, excluding rollovers, it is mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical.

A participant may withdraw rollover contributions at any time.

(h) Unallocated Accounts – The unallocated forfeiture account represents amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used to reduce the Company's contributions. Forfeitures used during 2024 and 2023 amounted to \$9,049 and \$13,694, respectively, which is reflected as a reduction to the Company's contribution receivable. Available forfeitures at December 31, 2024 and 2023 were \$10,674 and \$7,875, respectively.

(i) Notes Receivable – The Plan does not allow participant loans.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.

(b) Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of net assets available for plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Unrealized gains and losses are based on the differences of beginning of the year fair values or cost if purchased during the current year, and year-end fair values. Interest income is accrued as earned. Dividends are recorded on the ex-dividend date.

(c) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

- (d) Administrative Expenses – In general, all plan expenses, except certain recordkeeping fees, are paid for by the Company.
- (e) Benefit Payments – Benefits are recorded when paid.
- (f) Subsequent Events – The Plan has evaluated subsequent events through June 30, 2025, which is the date that the financial statements were available to be issued.

(3) PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions or terminate the Plan at any time, subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

(4) TAX STATUS

The Plan is based on a prototype plan and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. This letter states that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator and prototype sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(5) RELATED PARTY TRANSACTIONS

The plan has a number of other service providers. Such parties are considered parties-in-interest under ERISA.

(6) INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(7) INVESTMENT CONTRACT

The Plan has entered into a fully benefit-responsive investment contract. The trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the investment contract. The investment contract is presented on the face of the statements of net assets available for plan benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(8) FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

We have performed audits of the accompanying financial statements of Poulin Grain, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(c) audit]. ### (1) DESCRIPTION OF THE PLAN

The following description of the Poulin Grain, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

- (a) General – The Plan is a defined contribution plan covering all full-time employees of Poulin Grain, Inc. (the “Company”) who have reached the age of 18. There is a two-month service requirement to become a participant in the Plan. Participants are eligible to enter the Plan and begin making salary deferrals on the first day of the month following when eligibility has been met. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Employee Contributions – Participants may contribute up to 100% of eligible compensation as defined in the Plan, limited to a maximum amount as periodically set by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the plan year may contribute an additional amount set by the IRS. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans.
- (c) Employer 401(k) Matching Contribution – The Company makes a safe harbor matching contribution each payroll period for each employee who enters into a salary reduction agreement. During 2024 and 2023, the match equaled 100% of the first 3% deferred by participants and 50% of the next 2% deferred by participants.
- (d) Discretionary Profit-Sharing Contributions – The Company may also contribute a discretionary profit-sharing contribution for each employee. To be eligible for the discretionary profit-sharing contribution, a participant must be employed on the last day of the year and complete a year of service for that year. The discretionary profit-sharing contribution is allocated based on a participant's eligible compensation relative to total eligible compensation as outlined in the Plan Document. Total discretionary profit-sharing contributions, net of forfeitures, amounted to \$133,580 and \$138,068 in 2024 and 2023, respectively.
- (e) Participant Accounts – Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contribution, and allocation of (a) the Company's discretionary profit sharing contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested account balances. Allocations are based on a participant's eligible compensation relative to total eligible compensation, deferred contribution amounts or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant determines the investment strategy of their account as provided by the Plan.
- (f) Vesting – Participants are immediately vested in their voluntary and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's other contributions of the participant's account plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two years of credited service, with an additional 20% per year thereafter until fully vested. Upon normal retirement age, death or disability, a participant becomes fully vested.

(g) Payments of Benefits – On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive distributions equal to the value of the participant's vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, or leave the funds in the Plan until retirement age or transfer to a trustee of another qualified plan or individual retirement account. If the terminating employee's non-forfeitable account balance is less than \$1,000, excluding rollovers, it is mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical.

A participant may withdraw rollover contributions at any time.

(h) Unallocated Accounts – The unallocated forfeiture account represents amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used to reduce the Company's contributions. Forfeitures used during 2024 and 2023 amounted to \$9,049 and \$13,694, respectively, which is reflected as a reduction to the Company's contribution receivable. Available forfeitures at December 31, 2024 and 2023 were \$10,674 and \$7,875, respectively.

(i) Notes Receivable – The Plan does not allow participant loans.

### (2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.

(b) Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of net assets available for plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Unrealized gains and losses are based on the differences of beginning of the year fair values or cost if purchased during the current year, and year-end fair values. Interest income is accrued as earned. Dividends are recorded on the ex-dividend date.

(c) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

- (d) Administrative Expenses – In general, all plan expenses, except certain recordkeeping fees, are paid for by the Company.
- (e) Benefit Payments – Benefits are recorded when paid.
- (f) Subsequent Events – The Plan has evaluated subsequent events through June 30, 2025, which is the date that the financial statements were available to be issued.

(3) PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions or terminate the Plan at any time, subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

(4) TAX STATUS

The Plan is based on a prototype plan and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. This letter states that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator and prototype sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(5) RELATED PARTY TRANSACTIONS

The plan has a number of other service providers. Such parties are considered parties-in-interest under ERISA.

(6) INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(7) INVESTMENT CONTRACT

The Plan has entered into a fully benefit-responsive investment contract. The trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the investment contract. The investment contract is presented on the face of the statements of net assets available for plan benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(8) FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted market prices by the Plan at year end. These investments are considered Level 1 and total \$27,990,605 and \$24,659,997 at December 31, 2024 and 2023, respectively.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
