The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1: Plan Description

The following description of the Appleton Union Employees' 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all hourly employees of Great Northern Corporation (the "Company"), whose conditions of employment are covered by a collective bargaining agreement, who have 45 days of service, and who have attained 18 years of age. Employees are eligible to participate in employee deferrals, the Company discretionary match, and discretionary profit sharing contributions on the first day of the month upon satisfying the eligibility requirements. Employees must be employed on the last day of the year to receive the discretionary profit sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Retirement Plan Committee (the "Committee") is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitoring of investment performance.

Contributions

Each year, participants may contribute to the Plan on a pre-tax or Roth basis, up to the maximum allowed by the Internal Revenue Service (IRS). Participants who attain age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The automatic deferral amount will increase by 1% per year up to a maximum of 7% of eligible compensation, unless the participant affirmatively elects out of this option.

The Company may make discretionary matching and discretionary profit sharing contributions to the Plan. For the year ended December 31, 2024, the discretionary matching contribution was calculated as 50% of participant deferrals up to 9% of eligible compensation. Also for the year ended December 31, 2024, the Company made a discretionary profit sharing contribution, which ranged from 2.50% to 6.50% of eligible compensation, depending on a combination of years of service and a participant's age. Rollover contributions are not matched.

Note 1: Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions and allocations of (a) Company discretionary profit sharing contributions and (b) plan earnings or losses. Participant accounts are reduced by withdrawals and are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus related earnings thereon. Vesting in the Company's discretionary matching and discretionary profit sharing contributions plus actual earnings thereon is based on years of continuous service. A participant vests at a rate of 20% per year after the first year, with 100% vesting after five years of service. In addition, participants become 100% vested upon death or disability.

Payment of Benefits

Plan benefits are available at normal retirement (age 65), disability retirement, death, or termination of employment with vested interests. Benefits are payable in the form of a lump sum distribution. The Plan allows for in-service distributions upon attaining age 59½ and for financial hardship, if certain criteria are met. Participants may withdraw their rollover contributions at any time.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions.

Forfeited nonvested accounts totaled \$47,245 at December 31, 2024, and \$54,316 at December 31, 2023. This account is used to reduce future Company contributions. During 2024, Company contributions were reduced by \$54,618 from forfeited nonvested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment expenses and included in net investment income. Certain fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. All other expenses paid directly by the Plan (except fees for withdrawals) are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through July 15, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed investment contract: The Key Guaranteed Portfolio Fund's value is derived from contract provisions and, therefore, contract value approximates fair value. The value of the fund is determined based on contributions plus interest less withdrawals and charges. In determining the reasonableness of the methodology, the Retirement Plan Committee evaluates a variety of factors, including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date), while others are substantiated utilizing available market data (for example, swap curve rate).

Note 4: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians of the Plan.

Note 5: Party-in-Interest Transactions

Certain plan investments are managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians as defined by the plan document, and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid by the Plan to the custodians amounted to \$67,832 for 2024. Retirement Strategies, LLC was the third-party administrator of the Plan through September 2024 and, therefore, transactions with the third-party administrator qualify as party-in-interest transactions. Fees paid to Retirement Strategies, LLC amounted to \$8,333 for 2024 and are included in net appreciation in fair value of investments, since they are paid through revenue sharing rather than a direct payment. Nicolet National Bank and Gallagher Benefit Services Inc. also provided investment advisory services in the amounts of \$3,607 and \$42,960, respectively, for 2024.

Note 6: Plan Termination

The Company has the right under the plan document to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their Company contributions.

Note 7: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated May 20, 2021, which states the non-standardized pre-approved plan document, as then designed, is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the plan document has been amended since receipt of the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
