The financial statements comprise the statements of net assets available for benefits in liquidation as of November 29, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits in liquidation for the period ended November 29, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ECM 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of November 29, 2024 and December 31, 2023, and for the period ended November 29, 2024, stating that the certified investment information, as described in Note B to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ECM 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note E to the financial statements, the Plan Administrator of the ECM 401(k) Retirement Savings Plan approved a Plan liquidation July 31, 2023, and management determined liquidation is imminent. As a result, the 2024 and 2023 financial statements are presented under the liquidation basis of accounting. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ECM 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore there is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of ECM 401(k) Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about ECM 401(k) Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A -- Description of plan and significant accounting policies

The following description of ECM 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The participating employers, as described below, adopted the Associated Trust Company, N.A. Pre-Approved Defined Contribution Plan originally effective August 1, 2014. The Plan has been subsequently amended and restated with the most recent restatement effective January 1, 2022.

Effective July 31, 2023, the Plan was terminated (Note E). As a result, all participants became fully vested in their account balances and all Plan assets were distributed or transferred by November 29, 2024.

General

The Plan is a defined contribution plan covering all employees, excluding employees covered under a collective bargaining agreement, non-resident aliens, and leased employees, who have completed one hour of service during the first month of employment or have completed one year of service (1,000 hours) and have obtained age 18. The Plan is a multiple-employer profit sharing plan with elective deferral 401(k) features covering eligible employees of ECM Holding Group, Inc., HVAC Armor, LLC, Green IT Solutions, LLC, TEL Solutions, LLC, and Aqua Energy Services, LLC WI -- (herein collectively referred to as "the employers"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance.

The Plan's federal identification number is 85-3595632, and the Plan's number is 001.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. As a result of the Plan termination (Note E), there were no participant contributions for the period ended November 29, 2024.

The employers will make an employer prevailing wage contribution based on an hourly contribution rate for the participant's employment classification under the applicable federal, state, or municipal prevailing wage laws. The contribution under the prevailing wage will offset the other employer contributions made. As a result of the Plan termination (Note E), there were no prevailing wage contributions for the period ended November 29, 2024.

The employers may make a discretionary matching contribution equal to uniform percentage and dollar amount of participant elective deferrals. As a result of the Plan termination (Note E), the employers did not make a discretionary matching contribution for the period ended November 29, 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Participant accounts and “rollovers”

Each participant’s account is credited with the participant’s contribution and allocations of (a) the employer’s matching and discretionary contribution, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocation of employer contributions are based on participant compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant’s rollover account.

Vesting

Participants are immediately vested in their contributions and employer prevailing wage contributions plus actual earnings thereon. Vesting in the employer matching contributions portion of their accounts is based on years of continuous service. A participant is 100% vested ratably after six years of credited service. Participants who reach the normal retirement age or leave the Plan because of death or disability, as defined in the Plan, are considered 100% vested in all amounts.

Participant loans

Participants may not borrow from their fund accounts.

Benefits

On termination of service due to death, disability, retirement (age 65), or other reasons, a participant may elect to receive a lump-sum amount equal to the entire or partial value of the participant’s vested interest in his or her account, annual installments over a set number of years, or roll over the distribution to another qualified plan. A participant with an account valued at less than \$5,000 shall receive a lump sum distribution. For accounts exceeding \$5,000 the participant may elect a lump sum distribution, annual installments over a set number of year, or the participant may elect to roll over the distribution to another qualified plan.

Forfeited accounts

At November 29, 2024 and December 31, 2023, forfeited nonvested accounts were \$0 and \$9,203, respectively. It is at the discretion of the employers to determine the use of forfeitures each year. In 2024, administrative expenses were reduced by \$10,135 from forfeited nonvested accounts.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting standards generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold and held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The employers pay some of the administrative expenses of the Plan, which are excluded from these financial statements. Those major administrative expenses are payroll and related expenses.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions and adjustments to net appreciation/depreciation in fair value of investments. The Plan distributed the 2023 excess contributions to the applicable participants on September 23, 2024.

Subsequent events

These financial statements have not been updated for subsequent events occurring after June 25, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after that date.

NOTE B -- Information certified by the asset custodian and trustee

Certain information related to investments disclosed in the accompanying financial statements, including investments held at November 29, 2024 and December 31, 2023, and interest and dividends and net appreciation in fair value of investments for the period ended November 29, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Associated Trust Company, N.A. (Associated), the asset custodian and trustee of the Plan.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the years presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 29, 2024 and December 31, 2023.

- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Collective trust funds. Funds that are composed primarily of fully benefit-responsive investment contracts are valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits in Liquidation for the period ended November 29, 2024 are reported in net appreciation in fair value of investments.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of November 29, 2024 and December 31, 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

NOTE D -- Party-in-interest transactions

Certain Plan investments are managed by Associated. Associated is the trustee and asset custodian for the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Associated provides certain administrative services to the Plan pursuant to a Retirement Plan Service Agreement with the employers. Associated receives revenue from mutual fund service providers for services Associated provides to the funds. This revenue is used to offset certain amounts owed to Associated for its administrative services to the Plan.

If the revenue received by Associated from such mutual fund service providers exceeds the amount owed, Associated remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Associated for administrative expenses not covered by revenue sharing.

NOTE E -- Plan termination

The Plan Administrator of the Plan approved a plan of liquidation on July 31, 2023, and management determined liquidation is imminent. The stock of ECM Holding Group, Inc. was acquired by a third-party and the Plan terminated on July 31, 2023. No further contributions to the Plan were made after this date. All participants became 100% vested in their allocated shares upon termination of the Plan. All plan assets were either distributed or transferred, as elected by each plan participant, by November 29, 2024. As a result, the 2024 and 2023 financial statements are presented under the liquidation basis of accounting.

NOTE F -- Tax status

The Associated Trust Company, N.A. Pre-Approved Defined Contribution Plan that the Plan has adopted effective January 1, 2022, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE G -- Concentration of market risk

The Plan invests in various investments securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits in Liquidation.

NOTE I -- Excess contributions payable

The Plan failed the discrimination test for the year ended December 31, 2023. Excess contributions, net of appreciation, amounting to \$27,416 are recorded as a liability in the accompanying Statements of Net Assets Available for Benefits in Liquidation and as a reduction of participant-directed contributions and adjustment to net appreciation in fair value of investments in 2023. The Plan has reimbursed these excess contributions to its participants during September 2024. For the purposes of Form 5500, the disbursement of the excess contributions is not reported until the year paid.
