Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of the Bush Brothers & Company Employees' 401(k) Plan and Trust Agreement (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions. Copies of this booklet are available from Bush Brothers & Company (the "Company").

General

The Plan is a defined contribution plan sponsored by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility for Participation

Substantially all employees of the Company are eligible to participate in the Plan. Employee is defined as any individual employed by the Company other than non-resident aliens, interns, independent contractors, leased employees, union employees, migrant employees, or outsourced employees, even if reclassified as common law employees.

Participant Accounts

The Plan automatically withholds 3% of each eligible employee's compensation, 60 days after eligibility, unless the employee elects not to defer or elects to defer a different percentage. Participants may elect to contribute up to 100% of pre-tax compensation not to exceed certain limits as set forth in the Plan. Highly compensated employees are subject to limitations on the percentage of compensation allowed to contribute. Plan earnings or losses are allocated based on each participant's account balance within each elected investment option. Each participant's account is credited with the participant's contributions, an allocation of plan earnings or losses, and an allocation of administrative expenses that are paid by the Plan. Effective January 1, 2025, the Plan was amended to allow Roth elective deferrals. The Plan accepts rollovers from other tax-qualified plans.

Administrative Expenses

Administrative expenses consist primarily of investment advisory fees paid to Ascensus Trust Company (the "Custodian"). These transactions qualify as party-in-interest transactions. Remaining fees for legal, accounting, and other administrative fees are paid primarily by the Company. Certain investment-related expenses are included in net realized and unrealized appreciation in the fair value of investments.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Investments

The Plan permits participants to direct the investment of their accounts directly into one or more investment options offered by the Plan.

Generally, the Plan's investment funds are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform and any collateral was insufficient is the recorded amount of such investments.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Vesting

Participants vest immediately in their contributions plus allocated earnings or losses thereon.

Payment of Benefits

Hardship withdrawals are available to active participants while in service. When a participant terminates employment, they are eligible to receive the value of their account in a lump sum distribution. If the value of the participant's account is greater than \$5,000, the participant must request a distribution, in accordance with the plan document. If the value of the participant's account is less than \$5,000, the Company may distribute the balance without the consent of the participant. Account balances less than \$1,000 are distributed, net of taxes, via check to the participant. Account balances greater than \$1,000 but less than \$5,000, which are not requested for distribution by the participant, are distributed to another qualified retirement account set up by the Plan on the participant's behalf. Distributions, unless rolled over into another qualified retirement account, are taxable to the participant when paid, including excise penalties, if applicable. In the event of a participant's death prior to receiving their distribution, their account is distributed to the designated beneficiary.

Plan Termination

Although the Company intends for the Plan to continue indefinitely, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA.

2. Summary of Accounting Policies

Accrual Basis of Accounting

The financial statements for the Plan are prepared using the accrual basis of accounting.

Morley Stable Value Fund

The Plan invests in the Morley Stable Value Fund (MSVF), a common/collective trust fund with Principal Global Investors Trust Company. MSVF invests in a variety of high quality stable value investment contracts, as well as cash and cash equivalents. Withdrawals, other than for benefit payments and participant transfers to noncompeting investment options, require written notice 12 months in advance. Withdrawals from the MSVF for benefit payments and participant-directed transfers to noncompeting options are made within 30 days after written notification. The Statement of Net Assets Available for Benefits presents the fair value of the investment in this fund. Participants should refer to the MSVF financial statements for more information.

Contributions and Benefit Payments

The Plan allows participants to defer a portion of eligible compensation up to the Internal Revenue Service (IRS) limitations. Participants who have attained the age of 50 before the end of the plan year are also eligible to make catch-up contributions. Participant contributions are recorded in the period the Company makes payroll deductions from the participants' earnings and are remitted to the Plan after each payroll. The Company has the option to make discretionary contributions to the Plan. Participants are immediately vested in these employer contributions. Receivables from the Company for these contributions are unsecured. Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value based primarily on quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

2. Summary of Accounting Policies (continued)

Subsequent Events

In preparation of the accompanying financial statements, events that have occurred since December 31, 2024, have been evaluated through July 10, 2025, the date the financial statements were available for issuance.

3. Income Tax Status

The Plan Sponsor adopted a prototype plan sponsored by FIS Business Systems, LLC, which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which states the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Investments (Unaudited)

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as at December 31, 2024 and 2023, and net realized and unrealized appreciation in the fair value of investments and interest and dividend income for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian, a qualified institution.

The Plan's investments totaled \$66,279,225 and \$57,935,939 as of December 31, 2024 and 2023, respectively. The investments appreciated in value by \$6,511,885 during 2024, which includes \$56,308 of appreciation of the MSVF during 2024. The investments appreciated in value by \$7,729,081 during 2023, which includes \$61,683 of appreciation of the MSVF during 2023. The fair value of the MSVF has been determined using inputs other than quoted prices in an active market (Note 5). The investments also earned interest and dividend income totaling \$1,321,117 in 2024 and \$1,191,329 in 2023.

The Plan has one investment, the Vanguard 500 Index Fund, representing 21% of net assets available for benefits as of December 31, 2024.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan can access.
- Level 2 Inputs to the methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value, which have not changed during 2024 or 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at fair value using the NAV practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund (Note 2).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
