To the Participants and Plan Administrator of the Tague Lumber, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Tague Lumber, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

We are required to be independent of the Tague Lumber, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of Plan management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Tague Lumber, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. The Plan became effective on September 1, 1987, and was most recently amended and restated effective January 1, 2022. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees (except collective bargaining employees that do not include the Plan as the sole pension plan in their collective bargaining agreement) of Tague Lumber, Inc; Applewood Lumber Company; Tague Lumber of Media, Inc.; Tague Door, Frame and Hardware, Inc.; Tague, Incorporated; Tague Lumber of Kennett, Inc.; and Tague Lumber of Doylestown, Inc. (collectively the “Company”) who are eighteen or older, and have completed 30 days of eligible service for employee deferrals, and one year of eligible service for safe harbor matching contributions and discretionary nonelective contributions (except for certain collective bargaining employees who are eligible immediately). Employees who are non-resident aliens and leased employees are ineligible to participate in the Plan. Eligible employees may enter the Plan upon employment commencement date or if later, upon satisfaction of eligibility conditions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Empower Trust Company, LLC (formerly Great-West Trust Company, LLC) is the trustee of the Plan. Empower Retirement, LLC and affiliates provide recordkeeping services to the Plan. The Plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan administrator.

Contributions

Each year, participants may contribute a percentage of their pretax annual compensation, as defined in the Plan document, provided that in no event shall a participant elect to contribute more than the maximum allowed by law. Contributions may also be designated as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for rollovers from other qualified plans.

The Plan includes an automatic contribution arrangement provision whereby all participants who have not made an affirmative election to contribute to the Plan are automatically enrolled into the Plan and their deferral rate set at 6% of eligible compensation, and their contributions invested in a designated fund until changed by the participant. This deferral rate will increase by 1% each subsequent March 1st until a maximum of 12% of eligible compensation is reached (see Note 9).

The Plan provides for safe harbor matching contributions, under which the Company provides a tiered match of 100% of employee deferrals up to 1% of compensation, and 50% of employee deferrals up to the next 5% of compensation. The safe harbor matching contributions will be each Plan year.

Discretionary nonelective contributions may be contributed at the option of the Company. To receive any discretionary nonelective contributions, participants must be employed on the last day of the Plan year and have completed a year of service, as defined in the Plan document, unless the participant terminates employment due to death, disability or the attainment of normal retirement age (65). Nonelective contributions may also be contributed as set forth in certain collective bargaining agreements for certain for collective bargaining employees.

For the 2024 Plan year, the Company provided a discretionary nonelective contribution of 1% of base compensation for eligible non-union participants. For participants covered under collective bargaining agreements, the nonelective contribution equaled \$4.60 per hour worked, not to exceed a maximum of 8 hours per day or forty hours per week for the 2024 Plan year. Discretionary nonelective contributions totaled \$282,398 (including \$122,819 for union participants) and safe harbor matching contributions totaled \$563,592 for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and safe harbor matching contributions, as well as allocations of the Company's discretionary nonelective contributions, if any, nonelective contributions for certain collective bargaining employees and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant, at all times, has a fully vested (100%) interest in their contributions, including their elective pre-tax deferral contributions, Roth 401(k) contributions, and rollover contributions, plus actual earnings thereon. Participants become 100% fully vested after five years of credited service in the Company's discretionary nonelective and prior matching contributions (20% per completed year). A participant is 100% vested after 2 years of credited service in safe harbor matching contributions. Collective bargaining employees are 100% vested in nonelective contributions that are contributed as set forth in collective bargaining agreements.

Notwithstanding the above vesting schedule, a participant will become 100% vested in these accounts upon their attainment of normal retirement age (65) or death or disability while an employee.

Forfeited Accounts

Forfeitures are generally used to pay administrative expenses or to offset employer contributions. The total unallocated forfeiture account balance was \$24,449 and \$16,545 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures of \$25,072 were used to offset employer contributions and \$0 were used to pay expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts at a minimum amount equal to \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balances. The loans are secured by the balance in the participant's account and bear interest rate, determined quarterly, at 1% over the prime interest rate. Principal and interest are paid ratably through payroll deductions. Loan terms shall not extend beyond five years from the date of the loan, unless the loan is for the purchase of a participant's primary residence. A participant may have up to one loan outstanding at any given time.

Payment of Benefits

On termination of service due to death, disability, retirement, or separation from service, a participant or their beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. In circumstances when a terminated participant has a vested account balance less than \$1,000, the participant's vested account balance shall be distributed in a lump sum. Balances over \$1,000 but less than \$7,000 (\$5,000 prior to modification allowed by the Setting Every Community Up for Retirement Enhancement ("SECURE") 2.0 Act of 2022), unless specified by the terminated participants, will be paid to the participants in a direct rollover to an individual retirement plan designated by the Plan administrator. Hardship and in-service distributions are also available in certain circumstances, as defined by the Plan.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodian, trustee, insurance company and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and safe harbor matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective contributions from the Company, if any, are recorded in the year earned.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit distribution is recorded, based upon the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

All reasonable administrative expenses, including trustee, custodial and third-party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

- Investment activity, including net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds, collective interest trust, and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust: Valued at the net asset value or equivalent based on units of the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the collective investment trust less its liabilities. This practical expedient is not used when it is determined to be probable that the collective investment trust will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan is applying the practical expedient as of December 31, 2024 and 2023 to its collective investment trust (MassMutual Pooled Stable Trust Class R). The investment objective is to preserve principal while generating earnings at rates competitive over time with short-term high-quality fixed income investments, while maintaining sufficient liquidity. Participants' ownership of the collective investment trust is represented in units. Units are issued and redeemed daily at each common collective trust's current NAV. The collective investment trust allows for daily liquidity, with no additional days' notice required for redemption for participant-initiated transactions.

5. Related Party and Party-In-Interest Transactions

Empower Trust Company, LLC provides trustee and custodial services to the Plan. Empower Retirement, LLC and affiliates provide recordkeeping services to the Plan. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance. Therefore, these qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. Fees paid by the Plan amount to \$121,659 for the year ended December 31, 2024.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Tax Status

Effective January 1, 2022, the Plan was amended and restated with the adoption of a Great-West Trust Company, LLC defined contribution pre-approved plan. The Internal Revenue Service ("IRS") issued an opinion letter, dated June 30, 2020, stating that the defined contribution pre-approved plan document was designed in accordance with applicable IRC requirements as of that date. With the rebranding of Great-West Trust Company, LLC to Empower Trust Company, LLC, the IRS issued an opinion letter dated November 14, 2022 for the Empower Trust Company, LLC Defined Contribution Pre-Approved Plan stating that the pre-approved plan document as then designed was in accordance with applicable IRC requirements. Although the Plan has been amended since this date, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. Plan Amendments

Effective July 1, 2024, the Plan was amended to increase the automatic enrollment percentage from 4% to 6%, increase the maximum auto escalation percentage from 10% to 12%, and change the auto escalation date from January 1st to March 1st.
