Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Healthcare Association of New York State, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Healthcare Association of New York State, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Healthcare Association of New York State, Inc. Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Healthcare Association of New York State, Inc. Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Healthcare Association of New York State, Inc. Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 — DESCRIPTION OF PLAN

The Healthcare Association of New York State, Inc. Retirement Savings Plan (the Plan) is a single employer, participant directed, defined contribution plan sponsored by the Healthcare Association of New York State, Inc. (HANYS) or (Plan Sponsor).

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

Employees are eligible to participate in the Plan effective the first payroll of the month following the date of hire. Employees are eligible to receive employer matching contributions upon completion of one year of service.

(b) Contributions

(1) Employees

Eligible employees can elect pre-tax contributions from their annual compensation up to the annual limits imposed by the Internal Revenue Service (IRS). The annual limit for 2024 and 2023 was \$23,000 and \$22,500, respectively. Participants who are 50 years or older and make the maximum pre-tax contribution may make catch-up contributions, subject to annual limits imposed by the IRS. The annual limits for catch-up contributions in 2024 and 2023 was \$7,500. In addition, participants can contribute up to 5% of their annual after-tax compensation to the Plan. A participant's contribution may be limited to lower percentages by income tax regulations.

The plan also accepts Roth 401k elective deferrals allowed under Internal Revenue Code Section 401(a). Participant deferrals are allocated to a separate account in the employee's name maintained exclusively for Roth contributions.

Participants direct the investments of their contributions into various investment options offered by the plan.

(2) Employer

In accordance with the terms of the Plan, the Employer is required to make a basic contribution to the Plan equal to 2% of a participant's annual compensation. In addition, if the participant elects to make a pre-tax contribution of at least 2% of their annual compensation, the Plan allows the Employer to make, at its discretion, a supplemental contribution up to 8% of the participant's annual compensation. The Employer made a supplemental contribution of 8% in 2024 and 2023 to participants eligible for the contribution. The total contribution by the Employer may not exceed the maximum amount deductible from the Employer's income under Internal Revenue Code Section 404(a)(3)(A).

(c) *Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of (a) the employers' contribution, (b) plan earnings and losses, and c) an allocation of administrative expenses. Allocations are based on participant contributions or account balances, as defined. The benefit to which a participant is entitled is based on the participant's vested account.

(d) *Vesting*

Participants are fully vested in their contributions plus actual earnings thereon. Participants become fully vested in the employer contributions portion of their accounts after five years of service.

(e) *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at prime plus 1%, which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through payroll deductions.

(f) *Payment of Benefits*

On termination of service due to death, a participant's beneficiary will receive a lump sum amount equal to the value of the participant's vested account balance. On termination of service due to disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic installments not to exceed fifteen years.

Under the terms of the Plan, participants are eligible for benefit payments upon reaching age 65. The Plan also provides for early and late retirement benefits.

(g) *Forfeited Accounts*

At December 31, 2024 and 2023 there were no forfeited nonvested account balances. These accounts are used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by approximately \$32,500 and \$13,100, respectively, due to the use of forfeited nonvested account balances.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting.

(b) Subsequent Events

For purposes of preparing the financial statements, the Plan considered events through June 26, 2025, the date the financial statements were available for issue.

(c) Investment Valuation, Income Recognition and Fair Value Measurements

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received if an asset was sold or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if the participant were to initiate permitted transactions under the terms of the plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

The Plan follows generally accepted accounting principles for *fair value measurements* which establishes a framework for measuring fair value of investments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820, Fair Value Measurements, are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

(c) Investment Valuation, Income Recognition and Fair Value Measurements (Continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The mutual fund investments are traded in public markets and are valued based on unadjusted quoted market prices within active markets. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(d) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Operating Expenses

Operating expenses incurred to maintain the Plan are shared between the Plan and the Plan Sponsor.

(g) Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

NOTE 3 — INVESTMENT WITH INSURANCE COMPANY

The Plan maintains a benefit-responsive investment contract with Metropolitan Life Insurance Company (Met Life). Met Life maintains the contributions in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Met Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer, but it could not be less than 1.5%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include premature termination of the contracts by the plan, layoffs, plan termination, bankruptcy and mergers. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract permits either party to terminate the agreement by giving the other party at least a 60 day notice.

Lincoln Financial Group Trust Company, Inc., trustee of the Plan, has certified as to the completeness and accuracy of the investment information related to the fair value and contract value of investments, notes receivable from participants, interest income on notes receivable from participants, and interest and dividend income and net appreciation (depreciation) in fair value of investments that is included in the Plan's financial statements and supplemental schedule.

NOTE 5 — PLAN TERMINATION

Although HANYS has not expressed any intent to terminate the Plan, it may do so at any time under the terms of the Plan. In the event the Plan terminates, participants will be 100% vested in all amounts which were credited to their accounts.

NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS

Lincoln Financial Group Trust Company, Inc. is the trustee of the Plan's investment assets and executed investment transactions as of and for the years ended December 31, 2024 and 2023; therefore, the transactions with Lincoln Financial Group Trust Company, Inc. qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Notes receivable from participants are also party-in-interest transactions

The Plan and HANYS are considered related parties based upon shared management and certain shared Board of Trustee members.

For the years ended December 31, 2024 and 2023, there were no prohibited transactions between either the related parties and the Plan or the parties-in-interest.

NOTE 7 — INCOME TAX STATUS

In a letter dated February 28, 2018 the Internal Revenue Service (IRS) ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code and is therefore not subject to tax under current income tax law.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 — RISKS AND UNCERTAINTIES

The Plan invests in various investment funds. These investment funds are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment funds, it is at least reasonably possible that changes in the values of investment funds will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.
