Notes to the Financial Statements

1. Description of the Plan

The following description of the American Beverage Marketers 401K Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as applicable sections of the Internal Revenue Code (IRC). The plan was effective January 1, 1996 and was most recently amended January 1, 2024. The Plan covers all eligible employees of American Beverage Marketers (Employer and Plan Administrator).

Eligibility

The plan covers all eligible employees of the Employer and Plan Administrator. A full time employee is eligible to join the Plan after reaching the age of 18. A part time employee is eligible to join the Plan after reaching the age of 18 and completing 1,000 hours of service. The Plan allows entry quarterly.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined by the Plan adoption agreement. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Employer makes a safe-harbor matching contribution equal to 100 percent on the first 6 percent of compensation that each participant contributes to the Plan. The Plan allows for discretionary contributions to be made by the Employer. No discretionary contributions were made for the year ended December 31, 2024. Contributions are subject to Internal Revenue Service (IRS) limitations.

Participant Accounts

Individual accounts are maintained by each Plan participant. Each participant's account is credited with the participant's contributions and Employer safe-harbor matching and discretionary contributions as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan adoption agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, Employer safe-harbor matching and discretionary contributions plus actual earnings thereon.

1. Description of the Plan, continued

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Payment of Benefits

After termination of employment, if a vested account balance does not exceed \$5,000, the distribution will be made in a lump sum. If the vested account balance exceeds \$5,000, participants are permitted to leave their account balance in the Plan until they elect to receive benefits or to rollover their balances to another qualified plan or Individual Retirement Account.

Prior to participants' retirement, death, disability, separation from service or attainment of age 59-1/2, participants may withdraw amounts from their salary deferral accounts, provided that such withdrawal is due to a hardship (necessary in light of immediate and heavy financial needs).

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, overall market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

Investment Valuation and Income Recognition

Investments are reported at fair value (see Note 4) except for the fully benefit responsive investment contract which is reported at contract value (see Note 5). The Plan defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian.

2. Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition, continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which participant compensation is earned.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Fees related to the administration of distributions to participants are charged directly to the participants' accounts and are included in administrative expenses. In addition, administrative expenses include fees for recordkeeping, administrative, investment and consulting services. Certain expenses of maintaining the Plan are paid by the Plan Administrator (in addition to its contributions under the Plan) and are excluded from these financial statements.

Subsequent Events

The Plan Administrator has evaluated subsequent events for accounting and disclosure requirements through July 11, 2025, the date which the financial statements were available to be issued.

3. Information Certified and Provided by the Custodian

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by the custodian of the Plan, Empower Trust Company, LLC, and furnished to the Plan Administrator. The Plan Administrator has obtained the certification from Empower Trust that such information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note and which appears throughout the financial statements and the supplemental schedule.

Empower Trust also certified the completeness and accuracy of \$2,266,972 of net realized and unrealized appreciation in investments and \$1,835,123 of dividends and interest income related to the investments for the year ended December 31, 2024.

4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for the investments measured at fair value on a recurring basis:

Mutual funds: Mutual funds are valued at quoted market prices in exchange and active markets.

There have been no changes in valuation methodology used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer related to total assets available for benefits.

5. Investment Carried at Contract Value

The following table provides information about the investment carried at contract value as of December 31:

The Empower General Account is a traditional investment contract which is fully-benefit responsive. Empower maintains the contributions in a general account that is principally composed of fixed rate investments with matching duration characteristics that can generate predictable, steady rates of return. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. Because the Empower General Account is fully-benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Empower General Account.

Certain events may limit the ability of the Plan to transact at contract value. Such events include the following: (i) removal of a group of participants from Plan coverage as a result of temporary absence; (ii) change in position or other occurrence qualifying as a temporary break in service under the Plan; (iii) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the Employer; or (iv) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Employer's business. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. Tax Status

The Plan uses a prototype Plan document sponsored by Retirement Management Services, LLC (RMS). RMS received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

6. Tax Status, continued

Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Administrator has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. Related Party and Party-In-Interest Transactions

Fees paid by the Plan to UBS Financial Services, Inc. (UBS) for investment and Plan consulting services were \$30,000 for the year ended December 31, 2024 and are included in administrative expenses. The amount due to UBS as of December 31, 2024 and 2023 was \$7,500. UBS served as investment advisor for the year ended December 31, 2024, therefore, these transactions qualify as party-in-interest.

Empower Retirement, LLC (Empower Retirement) deducts an expense charge each month based on investment account values. These fees were \$84,479 for the year ended December 31, 2024 and are included in administrative expenses on the statement of changes in net assets. The amount due to Empower Retirement as of December 31, 2024 and 2023 was \$7,586 and \$5,949, respectively. Empower Retirement served as recordkeeper for the year ended December 31, 2024, therefore, these transactions qualify as party-in-interest.
