- A *Schedule A* (or information for a complete *Schedule A*) representing our insurance contract with Opticare Vision Services is not included in this filing because Opticare is no longer in business and the relevant records are no longer accessible. During 2024, a court order placed Opticare in Rehabilitation under the Utah Insurer Receivership Act. The Plan Administrator made good-faith efforts to obtain the required information, including contacting the Utah Receivers Office, but that office no longer has access to the relevant information. Consequently, it is impossible to obtain now, or in future, information to (fully) complete Schedule A. The Plan is providing this explanation to document its efforts to comply with Form 5500 Instructions and Schedule A, to explain that the omission was beyond the Plan's control, and to report that documentation of its efforts to comply (obtain a Schedule A) has been retained and is available upon request.
