### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bosselman Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits - cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### 1. Plan Description

---

The following brief description of the Bosselman Employee Retirement Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan sponsors (the Company) include the following adopting employers within the Bosselman Companies: Bosselman Administrative Services, Inc., Bosselman Pump & Pantry, Inc., Bosselman Travel Centers, Inc., Boss Truck Shops, Inc., Bosselman Food Services, Inc., Bosselman Motels, Inc., and VisionComm Vending, Inc.

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of the Company.

Employees are eligible to make salary deferral contributions and receive Company discretionary matching and profit-sharing contributions after attaining age 18 and completing six months of service. Eligible employees become participants on the first day of the following month coinciding with the date on which entry requirements were fulfilled. In order to be eligible for discretionary profit-sharing contributions, employees are required to have 1,000 hours of service during the Plan year and must be employed on the last day of the Plan year.

#### ***Contributions***

Participants are permitted to make voluntary pre-tax salary deferral contributions and after-tax Roth contributions up to 100% of their total eligible compensation as provided by the Plan, up to the maximum deferral dollar amounts allowed by law. At any time, a participant can elect to not contribute or may increase or decrease his or her deferral rate to any rate allowed under the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Eligible participants reaching the applicable age may make catch-up contributions up to the amounts allowed by law.

The Company's matching contribution is a discretionary percentage of the employees' deferrals to be determined by the Company and subject to change (50% of the participants' elected deferral up to 6% of eligible compensation in 2024 and 2023). The Company may make discretionary profit-sharing contributions to the Plan as determined by resolution of the Board of Directors of the Company (none in 2024 or 2023).

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of a) the Company's discretionary matching and profit-sharing contributions and b) Plan earnings or losses. The Company's discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary profit-sharing contributions

are allocated based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are currently maintained in individual member accounts managed by Transamerica Retirement Solutions, LLC (Transamerica). Reliance Trust Company (Reliance) is the custodian.

### ***Vesting***

Participants are immediately vested in their elective deferrals plus actual earnings thereon. The Company's discretionary matching and profit-sharing contributions credited to participants' accounts are vested based on years of continuous service. A participant is 20% vested after one year of credited service and vesting increases 20% per year until a participant is 100% vested after five years of credited service.

### ***Payment of Benefits***

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive either a lump sum or installment payments equal to the value of the vested funds allocated to the participant's account. Hardship withdrawals and age 59.5 in-service distributions are also permitted by the Plan. Distributions between \$1,000 and \$5,000 will be contributed to an IRA if no option is elected by the participant, whereas amounts under \$1,000 will be paid out to those participants in one lump sum. Benefits are recorded when paid.

### ***Forfeitures***

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of their Company contributions not then vested shall be forfeited. The forfeitures account will be used to reduce plan administrative expenses or the Company's discretionary matching and profit-sharing contributions. During the years ended December 31, 2024 and 2023, forfeitures of \$45,878 and \$30,379, respectively, were used to reduce Company discretionary matching contributions and to pay plan administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested amounts totaled \$209 and \$282, respectively.

### ***Notes Receivable from Participants***

Participants currently employed by the Company may borrow from their fund accounts any amount up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are only allowed from pre-tax and after-tax Roth participant deferrals. The notes may not exceed five years unless it is a qualified home loan, and only one note is allowed at any one time. The notes are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

### 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

#### ***Basis of Presentation***

The Plan uses a cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Contributions are recorded when received by the Plan. Corrective distributions resulting from failures in compliance testing are recorded in the year distributed. Investment income and interest income from notes receivable are recorded when received rather than when earned. Benefit payments are recorded when paid.

#### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

#### ***Use of Estimates***

The preparation of financial statements in conformity with the cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchase and sales of securities are recorded on a trade-date basis. Realized and unrealized gains and losses are recorded in net appreciation in fair value of investments. Interest and dividend income are recorded when received.

### *Other*

Certain expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Audit fees and fees related to administrative activities are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments. Record-keeping expenses and the fidelity bond premium are paid by the Company on behalf of the Plan.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any interest that is earned at the end of each calendar year. Participant notes receivable are deemed past due and in default after a scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits – cash basis.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits – cash basis date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. The Plan and the Company have considered such events or transactions through July 11, 2025, noting no items requiring disclosure.

### **3. Information Certified by Reliance**

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their Net Asset Value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds:* The estimated value of the collective trust fund is at Net Asset Value (NAV). The use of NAV as fair value is deemed appropriate as the collective trust funds do not have finite lives, unfunded commitments relating to these types of investments, or significant restrictions on redemptions. FASB ASC 820, *Fair Value Measurement*, allows NAV to serve as a practical expedient to estimate fair value as long as certain requirements are met. It is in the Plan’s assessment that this fund meets those requirements, since the participants have the ability to redeem this fund at NAV as of the measurement date on a daily basis.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment Contract with Transamerica

The Plan has entered into an investment contract with Transamerica. This account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Transamerica.

As the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the interest contract. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic developments. No events are probably of occurring that

might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### 6. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution to participants of the account balances would be made as soon as practicable after the termination date.

### 7. Tax Status

---

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The cash basis of accounting, a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America, requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 8. Related Party Transactions

---

Certain Plan investments are a stable value fund and a mutual fund managed by Transamerica. Transamerica is a service provider as defined by the Plan and therefore, these transactions qualify as party-in-interest.
