The following description of JFS 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Jewish Family Service of Colorado, Inc. (the "Company") who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the sponsor of the Plan and has responsibility for the administration of the Plan. The Standard Insurance Company functions as custodian, third-party administrator, recordkeeper, and investment manager. Investment management fees and custodian fees are paid by the Plan in accordance with the plan agreement and are recorded as a reduction in the realized and unrealized gains on investments and as administrative expenses, respectively, in the accompanying financial statements.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 100 percent of their eligible compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company made discretionary matching contributions equal to 50 percent of participant contributions on the first 4 percent of eligible compensation deferred. The Company also made discretionary profit-sharing contributions equal to 2 percent and 3 percent of eligible compensation in 2024 and 2023, respectively. Participants who have completed one year of service, defined as completing 1,000 hours of service during the year, will be eligible to receive company discretionary matching and profit-sharing contributions.

Participant Notes Receivable

Participant notes receivable are not allowed under the provisions of the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participants' contributions and eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in their contributions and rollovers into the Plan plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of service, beginning with one-third after two years of service and increasing one-third for each year of continuous service thereafter. A participant is 100 percent vested after four years of service with the Company. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service beginning at 20 percent after two years of service and increasing 20 percent for each year of continuous service thereafter. A participant is 100 percent vested after six years of service with the Company. A participant is entitled to 100 percent of his or her account balance upon retirement, death, or disability.

Note 1 - Plan Description (Continued)

Benefit Payments

On termination of service due to death, disability, retirement, attaining age 59½, or termination of employment, a participant may elect to receive either a lump-sum amount in cash or direct rollover equal to the value of the participant's vested interest in his or her account, substantially equal installments, or partial withdrawals.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions. At December 31, 2024 and 2023, forfeited account balances totaled approximately \$1,000 and \$2,000, respectively.

The Plan used approximately \$22,000 for the year ended December 31, 2024 to reduce employer contributions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by The Standard Insurance Company or its affiliates. The Standard Insurance Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive investment contract is valued at contract value. Contract value represents contributions, less withdrawals and administrative expenses, plus interest credited.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of approximately \$20,000 for the year ended December 31, 2024 were paid by the Company.

Note 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including July 9, 2025, which is the date the financial statements were available to be issued.

Note 4 - Certified Information

The Standard Insurance Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 5 - Investment Contract

The Plan has a benefit-responsive investment contract, the Stable Asset Fund, through a rider to the Custodian's group annuity contract. The Custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a monthly basis for resetting but may not be less than 3 percent annually. When establishing interest crediting rates for this product, the Custodian considers many factors, including yield forecasts from the Custodian's advisory group and margins required for the Custodian's business.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. The Custodian may terminate the contract with 30 days' advance written notice to the contract owner for reasonable cause, which may result in a market value adjustment or other withdrawal restrictions.

Note 6 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
