## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

### **STANDARDAERO 401(k) SAVINGS PLAN**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of **StandardAero 401(k) Savings Plan** ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### **Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### (1) Description of the Plan

The following description of the **StandardAero 401(k) Savings Plan** (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General** - The Plan, which commenced on October 1, 2004, is a defined contribution plan covering substantially all employees of **StandardAero Business Aviation Services, LLC** and its subsidiaries (together, the "Company" or "Plan Sponsor") who are age eighteen or older and who are not covered by a collective bargaining agreement. The Plan Advisory Committee of the Company controls and manages the operation and administration of the Plan. Bank of America, N.A. ("BOA") serves as the trustee of the Plan's assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- B. Contributions** - Each year, participants may contribute up to 100% of eligible compensation as defined in the Plan document, subject to the Internal Revenue Code ("IRC") limitation of \$23,000 for the year ended December 31, 2024. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions not to exceed \$7,500 for the year ended December 31, 2024. Participants may also make after tax contributions up to 30% of eligible compensation and may contribute amounts representing rollover distributions from other qualified plans and certain individual retirement accounts. The Company contributes 100% of the first 5% of eligible compensation that a participant contributes to the Plan. Additional profit sharing amounts may be contributed at the option of the Company's board of directors for participants who have earned at least 1,000 hours of service and are employed on the last day of the Plan year. No additional profit sharing amounts were contributed for the year ended December 31, 2024.
- C. Investment options** - Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds, common stock and common collective trust funds as investment options for participants.
- D. Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- E. Vesting** - Participants are immediately vested in all contributions plus actual earnings thereon.
- F. Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. At December 31, 2024, outstanding notes bore interest rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.
- G. Payment of benefits** - On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or various installment options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. Amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participants reach the age of 59 ½ years. Hardship distributions are permitted upon demonstration of financial hardship.

### (1) Description of the Plan (continued)

- H. **Forfeitures** - At December 31, 2024 and 2023, there were no forfeited accounts. All accounts are immediately vested.
- I. **Plan termination** - Although the Plan Sponsor has not expressed an intention to do so, the Plan Sponsor has the right to terminate the Plan at any time, subject to the provisions of ERISA.

### (2) Summary of significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** - The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

**Use of estimates** - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Risks and uncertainties** - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

On April 2, 2025, President Trump signed the Executive Order, *Regulating Imports with a Reciprocal Tariff to Rectify Trade Practices that Contribute to Large and Persistent Annual United States Goods Trade Deficits* ("the April 2 EO"), to take action based on the results of certain investigations related to the causes of the U.S.'s large and persistent annual trade deficits in goods. Subsequent to the April 2 EO, there have been additional Executive Orders that have, among other actions, effectively suspended the enforcement of certain country-specific tariffs until July 9, 2025, for all trading partners except for the People's Republic of China. The Plan Sponsor's currently assessing the potential impact of these actions. Additionally, as a result of the impact of these actions on the financial markets, the Plan's investment portfolio may experience significant volatility.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from notes receivable from participants is recorded when received. Other interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus unpaid interest.

**Payment of benefits** - Benefits are recorded when paid. Amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid were \$65,060 and \$245,182 at December 31, 2024 and 2023, respectively.

**Administrative expenses** - The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and benefit payments) are charged directly to the participant's account.

**Subsequent events** - The Plan has evaluated subsequent events through July 9, 2025, the date the financial statements were available to be issued.

In May 2025, the assets of the Aero Turbine 401(k) Plan & Trust, totaling approximately \$5,500,000, were transferred into the Plan.

### (3) Fair value measurements

FASB ASC 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common stocks:* Valued at fair value, which is based on the closing price reported on the active market which the common stock is traded.

*Mutual funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year end based on readily determinable fair values, which are published daily and are the basis for current transactions.

*Common collective trusts:* The Plan's investments in the common/collective trusts are stated at NAV, or its equivalent, which is a practical expedient for estimating the fair values of those investments. The common/collective trusts have no unfunded commitments and can be redeemed daily with no redemption notice period or other redemption restrictions.

*Money market fund:* Valued at cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### (5) Exempt party-in-interest transactions

Certain Plan investments are common collective trusts managed by BOA. BOA is the trustee as defined by the Plan and, therefore, these recordkeeping and information management expenses qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan for administrative services were as follows for the year ended December 31, 2024:

### (6) Tax status

The IRS has determined and informed the Trustee by a letter dated June 30, 2020 that the prototype plan document was designed in accordance with applicable sections of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.
