## INDEPENDENT AUDITORS' REPORT

### Opinion

We have audited the accompanying financial statements of Tampa Banana Handlers Health and Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits – modified cash basis as of September 30, 2024 and 2023 and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended and the related notes to the financial statements.

NOTE 1            DESCRIPTION

The following description of the Tampa Banana Handlers Health and Welfare Plan provides general information only. Participants should refer to the Plan Agreement for more complete information.

**General** – The Plan is currently maintained pursuant to a Collective Bargaining Agreement between Logistec USA, Inc. and Local 2078 of the International Longshoremen’s Association.

Prior to May 1, 2024, the employee bargaining representative was the International Longshoremen’s Association Local #1402/Manatee.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Medical Benefits** – The plan provides health benefits (medical, life, accident and disability) for eligible members and dependents through participation in the Management-ILA Managed Health Care Trust (MILA). Members become eligible for benefits on the first day of the benefit period after attaining the required number of work hours during the qualifying period as follows:

<u>Qualifying Period</u>	<u>Benefit Period</u>
October - September	January - December

Members become eligible for the MILA Core benefits after attaining at least 700 hours in a qualifying period. Eligibility for the MILA Basic benefits requires a minimum of 1,000 hours worked in a qualifying period. Eligibility for the MILA Premier benefits requires a minimum of 1,300 hours worked in a qualifying period.

Continual eligibility, depending upon the plan, requires at least 700-1,300 hours in the qualifying period.

Contributions to the Management-ILA Managed Health Care Trust are determined based upon the number of hours worked. The current contribution rate is \$5.00 per hour worked.

If a member becomes disabled, disability credits equal to 24 hours per week to a maximum of 1,300 hours in a qualifying period, are credited to the participant.

Terminated employees may extend coverage through MILA by contributing specified amounts.

NOTE 1            DESCRIPTION (continued)

**Holiday-Vacation Benefits** – The Plan also provides a holiday-vacation benefit to eligible participants. Eligibility for a holiday-vacation benefit requires a minimum number of hours worked during the qualifying period of October 1 through September 30. The minimum hour requirement is as follows:

Qualifying Period	Minimum Hour Requirement
October 1, 2023 to September 30, 2024	499 Hours
October 1, 2022 to September 30, 2023	500 Hours
October 1, 2021 to September 30, 2022	900 Hours

The benefit is \$1,815 plus \$25 per 100 hours worked in excess of the minimum hour requirement, payable in December.

**Funding** – Plan benefits are funded by contributions from the plan sponsor pursuant to the collective bargaining agreement based on the number of hours worked. The current employer contribution rate is \$6.60 per hour determined as follows:

Health and Welfare	\$5.25 per hour
Holiday-Vacation	\$1.35 per hour

**Other** – The Board of Trustees have the right under the Plan to discontinue or modify the requirements for participation in the Plan and eligibility of participants. The Plan may be terminated by joint agreement by the Board of Trustees, subject to the provisions set forth in ERISA.

NOTE 2            SUMMARY OF ACCOUNTING POLICIES

This summary of accounting policies and information of Tampa Banana Handlers Health and Welfare Plan is presented to assist in understanding the Plan's financial statements.

**Method of Accounting** – The accompanying financial statements have been prepared on the modified cash basis of accounting. Under this basis, revenues are recognized as collected and expenses are recognized when they are paid. This basis differs from generally accepted accounting principles primarily because the Plan has not recognized balances and the related effect on earning of contribution receivable from the employer and accounts payable to creditors. If an expenditure results in an asset having an estimated useful life which extends substantially beyond the year of acquisition, the expenditure is capitalized.

**Use of Estimates** – The presentation of financial statements requires the trustees to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates. Material estimates that are particularly susceptible to significant change in the near term are the Plan's Benefit Obligations.

NOTE 2      SUMMARY OF ACCOUNTING POLICIES (continued)

**Valuation of Investments and Income Recognition** – Investment are recorded at period end values, which approximates fair value. See Note 3.

Investment policies, guidelines and procedures have been established by the Board and may be modified or amended only at the direction of the Board. In establishing and determining the reasonableness of investment valuations, the Plan enlists the assistance of fiduciaries and investment managers who review the performance of investments to ensure adherence to those policies, guidelines and procedures.

Security transactions are accounted for on the date the order to buy or sell is executed. Realized and unrealized gains and losses from security transactions are calculated on the cost basis.

Interest income is recorded upon receipt.

**Cash Concentration Credit Risk** – The Plan maintains its cash in bank deposit accounts at a high credit, quality financial institution. The balances, at times may exceed federally insured limits. Balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. As of September 30, 2024, the Plan had no amounts that were in excess of FDIC limits.

**Payment of Benefits** – Insurance premium payments are recorded when paid. These payments are recorded in the accompanying statements of changes in net assets available for benefits.

**Operating Expenses** - The Plan's expenses are paid by the Plan, as provided by the Plan document. Operating expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

**Income Taxes** – The Fund is exempt from income taxes under the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Fund and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 3      INVESTMENTS

Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value hierarchy prioritizes inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

*Level 1 Fair Value Measurements*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2 Fair Value Measurements*

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active or non-active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observed for substantially the full term of the asset or liability.

*Level 3 Fair Value Measurements*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used, need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Holiday-Vacation Benefits** - The Holiday-Vacation obligation, as of September 30, payable December 2024 and 2023 totaled \$55,475 and \$82,630 respectively.

NOTE 5                    RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

The Plan pays operating expenses directly to service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE 6                    SUBSEQUENT EVENTS

In preparing these financial statements, the impact of events and transactions for potential recognition or disclosure through June 30, 2025 were evaluated.

NOTE 7                    OTHER

The Trustees have evaluated the Fund's ability to continue as a going concern for the twelve months following the issuance date of these financial statements. The Fund's recurring operating losses and cost of providing benefits raised substantial doubt about its ability to continue operations.

The Board of Trustees established a \$250,000 threshold contingency that provides for additional funding of \$.25 per hour. The additional funding ceases once the threshold amount is re-established.

The additional funding, which has been implemented, alleviates the substantial doubt about the Company's ability to continue as a going concern.



