NOTE 1 DESCRIPTION OF PLAN

The following description of 403(b) Thrift Plan for Employees of United Way of Greater Milwaukee & Waukesha County, Inc. (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of United Way of Greater Milwaukee & Waukesha County, Inc. (the Company) are eligible to participate in the deferral option of the Plan on their date of employment. Participants are eligible for the Employer match components if they are making employee deferrals and have and completed at least 12 months of service. Participants are eligible for the Employer base contribution after they have completed at least 12 months of service. Employment in the nonprofit health or social service field within the three-year period immediately before employment with the Company counts as service for purposes of eligibility.

Contributions

Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 403(b) or Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

For the years ended December 31, 2024 and 2023, the Company base contribution was 5.5% of the employee's compensation for that year, regardless of whether or not the employee was making salary deferral contributions. Effective July 1, 2016, employees who entered the nonunion group before May 1, 2015 will receive a service-weighted Employer base contribution. If the participant completed 1 to 5 years of service, the Company makes a contribution of 7% of eligible compensation received during the Plan year. If the participant completed 6 to 10 years of service, the Company makes a contribution of 8% of eligible compensation received during the Plan year. If the participant completed 11 to 15 years of service, the Company makes a contribution of 9% of eligible compensation received during the Plan year. If the participant has completed 16 years or more of service, the Company makes a contribution of 10% of eligible compensation during the Plan year.

Contributions (Continued)

The Company matching contribution is dependent on the years of service of the participant. If the participant has completed less than 10 years of service, the Company makes a matching contribution of the lesser of 70% of the salary reduction amount deferred by the participant or 3.5% of eligible compensation received during the Plan year. If the participant has completed 10 years or more of service, the Company makes a matching contribution of the lesser of 80% of the salary reduction amount deferred by the participant or 4% of eligible compensation received during the Plan year. If the participant has completed 25 years or more of service, the Company makes a matching contribution of the lesser of 90% of the salary reduction amount deferred by the participant or 4.5% of eligible compensation received during the Plan year.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, the Company's base contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company matching and base contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested in the Company matching contributions after three years of credited service. A participant is 100% vested in the Company base contributions after five years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent.

Forfeited Accounts

Forfeited nonvested accounts are first used to reduce future Company contributions and then are used to reduce administrative expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$-0- and \$5,705, respectively. There were \$37,279 and \$19,020 of forfeitures used to reduce Company contributions for the years ended December 31, 2024 and 2023, respectively. There were no forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through June 25, 2025, the date the financial statements were available to be issued.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Interest Accumulation Account: Valued at fair value by the insurance company by discounting the cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. The account does not meet the fully benefit-responsive investment criteria and therefore, is reported at fair value. Certain observable inputs are assessed through review of control terms while others are substantiated utilizing available market data.

Pooled Separate Account: Valued based on the net asset value (NAV) of units, which is based on the market prices of the underlying investments in the account, held by the Plan at year-end. The underlying investments are mutual funds that are valued at the daily closing price as reported by the fund. NAV is a readily determinable fair value and is the basis for current transactions.

NOTE 5 PLAN LOANS

Participants may borrow directly from Mutual of America Life Insurance Company (Mutual of America), up to the lesser of \$50,000 or 50% of the vested portion of their fund account. These loans are direct loans between the participant and Mutual of America, and as such they are not treated as a transfer from the investment funds to a note receivable from participant funds. However, Mutual of America requires 120% of the loan balance to be collateralized by the participant's account, and this portion of their account is transferred at the time of the loan and maintained in the Mutual of America Interest Accumulation Account within the participant's account. Loans must be repaid by the participant in five years unless the proceeds are used to acquire a primary residence, which may be repaid under a longer term. The loans bear interest at a reasonable rate determined by Mutual of America. In the event of default, foreclosure on the participant's account balance will not occur until a distributable event occurs in the Plan.

NOTE 5 PLAN LOANS (CONTINUED)

Outstanding loans between Plan participants and Mutual of America totaled \$23,021 and \$27,158 as of December 31, 2024 and 2023, respectively, and were collateralized by \$27,625 and \$32,590 of investments included in the statements of net assets available for benefits as of December 31, 2024 and 2023, respectively. Plan management believes that the Plan loans have met the conditions for exemption under ERISA and as such they have not been reflected in the accompanying financial statements and supplemental schedule as nonexempt transactions.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 8 PLAN TAX STATUS

403(b) plans are not required to receive a favorable determination letter from the IRS indicating that the Plan is qualified under section 403(b) of the Internal Revenue Code (IRC) and the trust established under the plan is tax-exempt under present income tax law. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the qualified institution as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.
