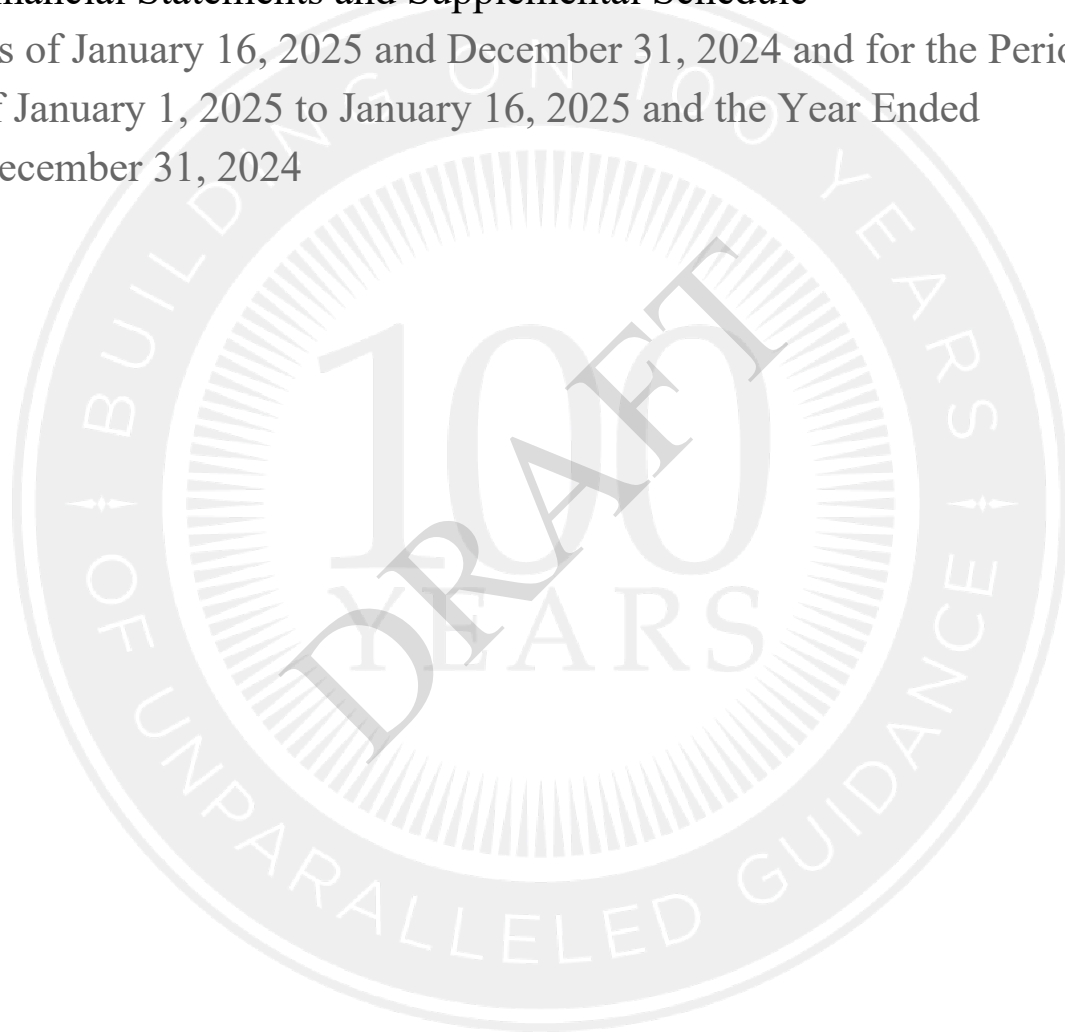

Independent Auditor's Report

To the Plan Administrator of the Finch Therapeutics Group, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Finch Therapeutics Group, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

As a result, the Plan changed its basis of accounting from the going-concern basis of accounting to the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. DESCRIPTION OF PLAN

The following description of the Finch Therapeutics Group, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Finch Therapeutics Group, Inc. (the “Company”) who have attained age 21. The following class of employees are not eligible to participate in the plan: employees covered by a collective bargaining agreement, non-resident aliens, leased employees, and interns. The purpose of the Plan is to provide a savings and investment vehicle for eligible employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are participant directed.

Ascensus Trust Company is the Trustee of the Plan. Vanguard Group, Inc. (“Vanguard”) has retained Ascensus, Inc. as a subcontractor to provide recordkeeping services to the Plan.

Plan Termination

In October 2024, the Company’s chief financial officer adopted a resolution to terminate the Plan effective January 16, 2025. As a result, management determined that liquidation was imminent.

Effective January 16, 2025, and in accordance with termination agreement, the plan has been terminated and final distributions were processed to participants.

Participant Contributions

Prior to termination, an active participant may elect two types of contributions to the Plan as follows:

Elective Deferrals

Each year, participants may contribute a portion of their pre-tax compensation, as defined in the Plan, subject to certain Internal Revenue Code (“Code”) limitations. Also, participants may elect to contribute Roth elective deferral contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants may change salary deferral elections at any time which become effective as soon as administratively feasible after it is received by the plan administrator. Participants direct investment of their contributions into various investment options offered by the Plan.

Rollover Contributions

Participants may also contribute amounts representing rollover distributions from other qualified plans, if the contributions satisfy the tax law requirements for a qualified rollover.

Employer Contributions

Safe Harbor Nonelective Contributions

Prior to termination, the Company will make safe harbor nonelective contributions in an amount equal to 100 percent of the first three percent of eligible compensation, and 50 percent of the next two percent of eligible compensation.

Profit Sharing Contributions

Prior to termination, the Company may make a discretionary profit sharing contribution that will be allocated based on the percentage of participants' eligible compensation to the total of all such compensation. A participant must be employed on the last day of the plan year to be eligible for a discretionary profit-sharing contribution unless the participant died, became disabled, or reached normal retirement age during the plan year. No employer profit sharing contributions were made in 2025 and 2024.

Vesting

As a result of the decision to terminate the Plan during 2024, all participants became fully vested in their account balances.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant directed transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

As of January 16, 2025 and December 31, 2024, there were no unallocated forfeitures. Forfeitures are used to reduce future employer contributions to the Plan. During 2025 and 2024, no forfeitures were used to reduce employer contributions to the Plan.

Notes Receivable from Participants

Prior to termination, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

Benefits

Prior to termination of the Plan, on termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Further, while still employed by the Company, participants may withdraw the employee contribution portion of the account under certain hardship circumstances, as defined by the Plan. Also, upon attainment of age 59 ½ a participant may elect to receive a distribution.

Distributions pursuant to the Plan termination will be paid at the participants' election by (a) rollover distribution to an eligible retirement plan; or (b) a combination of cash distribution and rollover distribution to an eligible retirement plan. Final distributions of the participant's accounts occurred on January 16, 2025.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

Due to the decision to terminate the Plan during 2024, management determined that liquidation of the Plan is imminent and the financial statements for 2025 and 2024 have been prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make assumptions and estimates that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All investments in the December 31, 2024 Statement of Net Assets Available for Benefits are reported at liquidation value. For all investments fair value approximates the amount the Plan expects to collect at liquidation. There were no investments remaining at January

16, 2025. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions

Contributions from Plan participants and the Company safe harbor nonelective contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the recordkeeping of the Plan, administration of notes receivable from participants, and processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investment.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments as of January 16, 2025 and December 31, 2024 and net appreciation in fair value of investments and interest and dividends for the period ended January 16, 2025 and year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, LLC and Newport Trust Company, LLC, qualified institutions.

Ascensus Trust Company and Newport Trust Company, LLC also certified the information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 16, 2025, and December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

As described in Note 1, Vanguard has retained Ascensus, Inc. as a subcontractor to provide recordkeeping services to the Plan. Certain plan investments are managed by Vanguard. In 2025 and 2024, the Plan incurred administrative expenses of \$7,800 and \$8,668, respectively, to Vanguard which qualify as party in interest transactions.

6. TAX STATUS

The Plan adopted a non-standardized profit-sharing plan with CODA, in which the Internal Revenue Service ("IRS") stated in a letter dated January 1, 2018, that the Plan, as then designed, was in compliance with the applicable requirements of the Code.

The Plan has subsequently been amended since receiving the letter, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor ("DOL"). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 16, 2025, and December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to examinations for years prior to 2021.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. SUBSEQUENT EVENTS

Management has evaluated subsequent events through June 20, 2025, which is the date the financial statements were available to be issued. There were no subsequent events that require adjustment to or disclosure in the financial statements.
