Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Medical Diagnostic Associates, P.A. Employees' Profit-Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

Note A – Description of Plan:

The following description of the Medical Diagnostic Associates, P.A. Employees' Profit-Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan qualifying under Section 401(k) of the Internal Revenue Code and is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established for the purpose of providing eligible employees of Medical Diagnostic Associates, P.A. (the Company) and their beneficiaries, funds for retirement. The Board of Trustees is responsible for the oversight of the Plan.

Eligibility

Employees are eligible to make elective deferrals upon the completion of 1,000 hours of service within a 12 consecutive month period. Employees covered by a collective bargaining agreement or are considered leased employees are not eligible.

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan document, not to exceed \$23,000 or \$30,500 for employees over 50 years of age, for the year ended December 31, 2024. Under the Plan, participants may make tax deferred contributions and Roth elective contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover), provided they are made within 60 days of receipt of such amounts by the employee. Participants direct the investment of their contributions into various investment options offered by the plan. The Company elected to make a safe harbor 401(k) non-elective contribution in the amount of 3% of compensation for all eligible participants. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. Profit sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all participants within their compensation class. Participants must be employed on the last day of the year and have worked at least 1,000 hours to be eligible for profit-sharing contribution. Participants also direct the investment of safe harbor and profit-sharing contributions into the investment options offered by the plan. The Company made safe harbor non-elective contributions and profit-sharing contributions in the amounts of \$196,310 and \$375,231 respectively, for the 2024 Plan year. Contributions are subject to certain limitations.

Participant Accounts

Each participant's individual account is credited with the participant's contributions and Company safe harbor non-elective contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note A – Description of Plan (continued):

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are fully vested in the Company's safe harbor non-elective contribution. Vesting in the Company's profit-sharing contribution is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable From Participants

Participants may borrow from their funds a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balances, whichever is less. The loans are secured by the balance in the participant's account and bear interest at prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through semi-monthly payroll deductions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,202 and \$1,810 respectively. As permitted by the plan documents, these amounts are used to pay any administrative expense of the plan or to reduce employer contributions. The amount of \$26,202 was used to pay plan expenditures in 2024. The amount of \$24,338 was used to pay plan expenditures in 2023.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum payment equal to the value of the participant's vested interest in his or her account, a rollover, or continue his or her account until age 73. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The plan allows for hardship withdrawals under certain circumstances. The plan permits in-service withdrawals for employee deferral contributions at age 59 ½ and for profit-sharing and safe harbor contributions at age 50.

Note B – Summary of Significant Accounting Policies:

Basis of Accounting

The accompanying financial statements have been prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures, including contingencies. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Note B – Summary of Significant Accounting Policies (Continued):

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as those held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Related fees are recorded as administrative expenses and are expended when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through June 12, 2025, the date the financial statements were available to be issued.

Note C – Fair Value Measurements:

The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board ("FASB") Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Note C – Fair Value Measurements (Continued):

The securities' fair value measurement level for the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the methodologies for the periods presented in these financial statements.

Mutual funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Cash and Cash Equivalents:

Interest bearing cash accounts, certificates of deposit and money markets are valued at amortized cost.

The following table sets forth by level, within the fair value hierarchy, the plan's assets at fair value as of December 31, 2024, and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Note D – Financial Information certified by the Custodian:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held on December 31, 2024, and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Advisor Trust Inc. (the custodian of the plan). Based on information provided and certified by the custodians, there are no fixed income obligations, leases or debt instruments in debt or deemed uncollectable, as defined by ERISA, for the years ended December 31, 2024, and 2023.

Note E – Related Party and Party In Interest Transactions:

Transactions with the custodians qualify as party-in-interest transactions, as well as transactions with the plan sponsor, the accountant involved in the Plan, the third-party administrator, investment managers and advisors. Fees incurred by the plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan sponsor pays directly any other fees related to the Plan's operations.

Note F – Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note G – Tax Status:

The IRS has determined and informed the company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter of determination, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

Note G – Tax Status (Continued):

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. In addition, there have been no tax-related interest or penalties for periods presented in these financial statements.

Note H – Risks and Uncertainties:

The Plan provides participants with the option to invest in various investment securities. All investment securities are exposed to some type of risk, including but not limited to, exposure to changes in interest rates, market fluctuations, economic conditions, and currency devaluation. Due to the level of risk associated with certain investment securities, it is possible that changes in the near term could materially affect certain participants' account balances, and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Users of these financial statements should be aware that the financial markets' volatility may significantly impact on the subsequent valuation of the Plan's Investments. Accordingly, the valuation of Investments at December 31, 2024, may not necessarily be indicative of the amounts that could be realized in a current market exchange.
