INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of MHALA 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the MHALA 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**1. General**

The Plan was established effective January 1, 2009 for the benefit of substantially all employees of Mental Health America of Los Angeles (the “Organization” or “Employer”). The Plan is a defined contribution plan that meets the requirements for plan qualification under Section 403(b) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**2. Eligibility**

Employees are immediately eligible to make elective deferrals in the Plan, including employees who work less than 20 hours per week. Student employees as defined by the Plan and employees participating in a 401(k) plan or 457 plan sponsored by the Employer are excluded from participation.

Eligible employees who have completed 6 months of service in which 1,000 hours have been worked and are employed on the last day of the year are eligible to receive Employer profit sharing contributions, subject to entry dates of January 1 and July 1. Employees covered by a collective bargaining agreement are excluded from participation.

**3. Contributions**

Participants may elect to contribute, on a tax-deferred or after-tax Roth basis, up to the maximum deferral limit per Section 402(g)(1) of the IRC. Additional catch-up contributions can be made beginning in the plan year in which a participant will be at least age 50 by the end of the plan year. With certain limitations, participants may also contribute from other qualified plans. For eligible participants, the Employer may make discretionary profit sharing contributions to the Plan. For the year ended December 31, 2024, the Employer contribution of \$1,494,900 was divided equally among eligible participants which amounted to \$4,950 per participant.

**4. Investment Options**

Upon enrollment in the Plan, a participant may direct employee and Employer contributions, as desired, in any of a variety of investment options made available by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan. Participants may change their investment options daily.

**5. Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of the Employer profit sharing contribution, and plan earnings, and is charged with an allocation of administrative expenses. Allocations of the Employer profit sharing contribution are made by employee group as determined by the Employer.

Allocations of plan earnings and administrative expenses are based on participant earnings, account balances, or specific transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**6. Vesting**

Participant contributions, Employer contributions, and earnings on all such contributions are fully vested at all times.

**7. Benefit Payments**

Upon termination of service, death, disability, or retirement, a participant or a participant's beneficiary, in the case of death, is entitled to receive a benefit payment equal to the total value of the participant's account balance. Additionally, participants may receive distributions upon attaining age 59½ or financial hardship if certain criteria are met.

**8. Notes Receivable from Participants**

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum of 50% of their vested account balance, not to exceed \$50,000 reduced by the participant's highest outstanding loan balance in the previous 12 months and the existing loan balance. The term of the loan cannot exceed five years. However, a 15 year term is allowed when the loan is used for the purchase of a principal residence. The interest rate is the prime interest rate plus 2% as granted by local commercial banks for similar loans. Participants are limited to two outstanding loans at a time. Loans are secured by the balance of the participant's account, which is used to settle defaulted loans or deemed distributed upon termination of employment. The interest rates on participant loans outstanding at December 31, 2024 ranged from 5.25% to 10.50%.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Presentation**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**2. Plan Administration**

The Organization is the plan sponsor and plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

**3. Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and custodians. See Note D for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

**4. Administrative Expenses**

Certain administrative expenses of maintaining the Plan are paid by the Plan. Substantially all other out-of-pocket administrative expenses including compliance fees, tax return preparation fees, and the annual audit fee to an independent accountant are paid by the Organization. Expenses paid by the Organization are excluded from these financial statements. Fees related to the administration of distributions and loans are charged to the participant's account. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

The plan administrator has an agreement with the custodian which provides for a monthly revenue sharing adjustment. The monthly adjustment is funded by the custodian's shared revenues from certain investments and is included in the asset holding account. At the direction of the Employer, these funds may be used to pay reasonable plan related expenses or can be allocated to plan participants at the end of the year. Shared revenues totaled \$29,628 and expenses paid from the plan expense account totaled \$19,541 for the year ended December 31, 2024.

**5. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**6. Benefit Payments**

Benefits are recorded when paid.

**7. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Loans in default are recorded as distributions based upon the terms of the Plan document and are included in benefits paid to participants.

**8. Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

**9. Subsequent Events**

Plan management has evaluated subsequent events through April 30, 2025, the date the financial statements were available to be issued.

**NOTE C - CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (the custodians of the Plan).

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a group annuity contract with Empower Annuity Insurance Company of America (Empower) which is a guaranteed investment contract (the Contract). The Contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus interest, less participant withdrawals and administrative expenses. The following represents the fully benefit-responsive contract held by the Plan:

Empower is obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting interest rate may not be less than 1% and is reset quarterly.

**NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)**

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third party issuer's ability to meet its financial obligations which may be affected by future economic and regulatory developments.

Certain events might limit the Plan's ability to transact at contract value including but not limited to a spin-off; sale; merger; partial plan termination, including distribution of assets performed by a Qualified Termination Administrator, as that term is defined under Federal law and regulations promulgated thereunder, or comparable person as allowed by applicable law; a layoff of at least 20% of work force in any twelve month period. Management has determined that such events are not probable of occurring.

In addition, the Employer is not able to offer competing funds unless mutually agreed upon by Empower and the Employer and participants are restricted from making a transfer into the Guaranteed Interest Fund (the "Fund") for up to 30 days from the date of the most recent transfer from the Fund. The contract may be terminated by Empower or the Employer with advance written notice.

**NOTE F - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Investments are held and certain investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the custodians and Empower Retirement, LLC is the recordkeeper. As a result, transactions with these entities qualify as party-in-interest transactions. Notes receivable from participants and related interest income are also considered party-in-interest transactions.

**NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**NOTE H - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, the assets will be distributed to participants in accordance with the provisions of the Plan.

**NOTE I - TAX STATUS**

The Organization adopted a volume submitter 403(b) plan (“volume submitter plan”) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, which stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction programs. Therefore, the plan administrator believes that the Plan was qualified and no provision for income taxes has been reflected in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
