### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Teak Isle, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of September 30, 2024 (in Liquidation), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to September 30, 2024 (in Liquidation) , and the statement of net assets available for benefits as of December 31, 2023 (Ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Teak Isle, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) audit pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and December 31, 2023 and for the period ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## **Emphasis of Matter – Basis of Accounting**

As discussed in Note 1 to the financial statements, the Plan Administrator of Teak Isle, Inc. 401(k) Plan approved a plan of liquidation in July 2024 and management determined liquidation is imminent. As a result, the plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in present the 2024 financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. # TEAK ISLE, INC. 401 (K) PLAN NOTES TO FINANCIAL STATEMENTS

## NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Teak Isle, Inc. 401(k) Plan (the “Plan”) provides only general information. The Plan is sponsored by Teak Isle, Inc. (the Company). Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Company’s corporate offices are located in Ocoee, Florida.

*General* - The Plan was effective January 1, 2023, and is a defined contribution plan available to all employees of the Participating employer who had attained age 18 and completed three months of service. Eligible employees were able to enter the Plan on the first day of the month coinciding with or next following the date of satisfying the eligibility requirements. The Plan includes an Automatic Contribution Arrangement provision. Upon becoming eligible to make salary deferrals under the Plan, participants are deemed to have entered into a Salary Deferral Election for each payroll period, unless the participant completed a Salary Deferral Election in accordance with procedures adopted by the Plan Administrator. Eligible participant’s compensation shall be automatically withheld at 2% of each payroll and contributed to the Plan as an Elective Deferral. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

*Plan Termination and Liquidation*- The Plan Sponsor adopted a resolution to terminate the Plan effective September 1, 2024. Effective with the Plan’s termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan’s termination also ceased employee and employer contributions in the Plan. All of the Plan’s assets were distributed during 2024.

*Contributions* – Participants may contribute a percentage of their pretax compensation, as defined in the Plan document, as an elective deferral contribution, subject to limitations. Additionally, participants may contribute a percentage of their after-tax compensation and designate it as a Roth elective deferral contribution. Eligible participants may make a rollover contribution to the Plan.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the year may make catch-up contributions in accordance with, and subject to, the limitations imposed by the IRC.

The Company will make, at its sole discretion, a flexible discretionary match. For the Plan year ended September 30, 2024, the Company made a matching contribution equal to 50 percent of participant’s salary deferrals up to the first 4 percent of the participant’s eligible compensation. In 2024, the Company’s matching contributions amounted to \$132,834. In addition, the Company may also make discretionary profit sharing contributions to participant accounts; however, none were made during 2024.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions and the Company’s matching contribution, as well as allocations of the Company’s profit sharing contribution, if any, and the Plan earnings. All contributions are allocated at the direction of the participant among selected investment funds. Each fund’s investment income or loss, less any investment management fee, is allocated to participants’ accounts based on their proportionate interest in the fund. The value of participant accounts will fluctuate with the market value of the securities in which the accounts are invested. Transaction fees charged for participant distributions are allocated directly to that participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Investment Alternatives* – Plan participants may direct their entire account balances in partial percentage increments to any of the various investment options offered by the Plan. Employer contributions are also invested based upon participant allocation elections. Participants may change their investment options on a daily basis.

*Vesting* – Participants are vested immediately in their contributions, the Company’s matching contribution, and the Company’s profit sharing contribution, if any, plus actual earnings thereon.

## NOTES TO FINANCIAL STATEMENTS

### NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

*Notes Receivable from Participants* - Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the vested account balance in the participant's account. The reasonable rate of interest is based on the Prime interest rate plus 1% per year. Principal and interest are paid ratably through regular payroll deductions. All loans are required to be repaid within a period of five years, except loans to acquire the participant's principal residence which must be repaid in a reasonable period of time, not to exceed thirty years. Any delinquent notes receivable from participants are recorded as distributions under the Plans provisions.

*Payment of Benefits* – On termination of service due to death, disability, retirement, or for other reasons, a participant may elect to receive or rollover a lump sum amount equal to the value of the participant's vested interest in his or her account or substantially equal installments. Partial withdrawals are permitted when participants reach the age of 59½, or in the event of financial hardship.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

As a result of the Plan's termination (See Note 1), the Plan's financial statements have been prepared on the liquidation basis of accounting which for this Plan is substantially the same as the accrual basis of accounting. For the year ended December 31, 2023, the financial statement was prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Contributions**

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and change therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual method. Related fees are charged directly to the borrowing participant's account and included as administrative expenses when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and benefit payment is recorded. A participant may have three loans outstanding at any given time.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants within the required time period.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment gains and losses are accounted for using the average cost basis of the securities sold. Net appreciation of fair value of investments includes the Plan's gains and losses on investments sold, as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of the fair value of investments.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

*Level 1* — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* — Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and December 31, 2023.

*Mutual Funds* - Valued at quoted market prices in an exchange and active market and are classified as Level 1 investments

*Common Collective Trust* – Valued at the net asset value (NAV) provided by the administrator of the fund. Issues and redemptions of units are recorded upon receipt of unit holder's instructions based on the determined NAV per unit, which is determined daily. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. For this fund, there are no unfunded commitments, redemption restrictions, and participants can transact daily.

## **NOTE 5 – TRANSFER OF FUNDS**

Due to the high cost of administering the Teak Isle, Inc. 401 (k) Plan that was established in 2023, a decision was made by the Board of Directors of the Sponsor Company in July 2024 to terminate the Plan effective September 1, 2024 at which time the Sponsor Company joined the ADP Totalsource Multiple Employer Plan (MEP) and the participant's account balances along with participant loans were transferred into the Totalsource Multiple Employer Plan.

The plan administrator is currently in the process of taking all of the required steps to ensure the plan is terminated in accordance with guidelines issued by the Internal Revenue Service.

## **NOTE 6 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Party in interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee organization, or relatives of such persons. ADP is the Plan's recordkeeper and third-party administrator, fees charged by ADP and transactions with ADP qualify as party-in-interest transactions. Such transactions are exempt from prohibited transaction rules.

Certain administrative functions of the Plan are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan for these services.

## **NOTE 7 – PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their employer contributions. The Plan has been terminated effective September 30, 2024.

## **NOTE 8 – TAX STATUS**

The Plan adopted a volume submitter plan offered by ADP effective January 1, 2023. The volume submitter plan received an advisory letter dated October 6, 2020, that the Plan, and related trust are designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The financial statement effects are recognized when the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of September 30, 2024, there are no uncertain tax positions taken or expected to be taken.

The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
