Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Shelter Systems Limited (the “Company”) 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Shelter Systems Limited 401(k) Plan and Trust is a defined contribution salary deferral pension plan which provides an individual account for each participant and provides benefits upon retirement based on amounts contributed by the employee and employer matching and discretionary contributions plus earnings on those contributions. The Plan was established on June 1, 1994.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participation

All employees of the Company are eligible to participate in the Plan. In order to be eligible to participate in the Plan, an employee must have completed one year of service with at least 1,000 hours of service during that year, and be at least eighteen years old. The initial year of eligibility is calculated from the employees' hire date. An employee became eligible to enter in the Plan on the first day of the plan year or the first day of the seventh month of the plan year after the age and service requirements are satisfied. Effective July 2024, the entry dates for the Plan were changed to quarterly. Employees are eligible to receive employer discretionary matching contributions and employer discretionary profit sharing contributions after fulfilling one year of service.

Contributions

Eligible participants may defer amounts from 1% to 15% (in whole percentages) of their compensation, not to exceed the limits of Internal Revenue Code (“IRC”) sections 401(K), 402(g), 404 and 415 of \$23,000 and \$22,500 for 2024 and 2023, respectively. The Company may contribute a discretionary base matching contribution throughout the Plan year based on a percentage of elective employee deferrals.

The year-end discretionary matching contribution equaled 75% and 100% of the elective deferrals participants contributed to the Plan for the years ended December 31, 2024 and 2023, respectively.

1. Description of Plan (continued)

Contributions (continued)

Also, the Company may make a discretionary profit sharing contribution at the end of the Plan year for employees who have been credited with at least 500 hours or more of service during the Plan year and be employed on the last day of the Plan year. The 500 hour requirement is waived in the event of the participant's death, termination of employment after becoming disabled or upon termination of employment after having reached normal retirement age as defined by the Plan. The discretionary contribution is allocated based on eligible compensation as defined by the Plan. The Company did not make discretionary profit sharing contributions for the years ended December 31, 2024 and 2023. Participant and Company contributions are directed by the participant into various investment options offered by the Plan.

All employees over the age of 50 before the close of the Plan year are eligible to make catch-up contributions totaling \$7,500 per year under IRC Sections 401 (a)(30), 402(g), 414(v) for 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's matching and discretionary contributions, and Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. The standard measure for one year of service is completion of 1,000 hours during the Plan year. A participant is 100% vested after six years of credited service at a rate of 20% per year, beginning with the second year of service. Any employer discretionary matching contributions and discretionary profit sharing contributions which are not vested are forfeited upon termination. If a participant is re-employed prior to incurring five consecutive one year breaks in service, and restores their vested balance, the amount forfeited will be restored to his or her account. If the participant does not return, the forfeitures are used to offset future employer contributions.

Notwithstanding the above, a participant shall be fully vested in their entire account upon the attainment of age 65, attainment of age 55 with at least ten years of service, death, disability or if the Plan is terminated.

Participant Loans

The Plan does not allow participant loans.

1. Description of Plan (continued)

Payment of Benefits

Upon termination of service, death, disability, retirement at age 65 or early retirement at age 55 with ten years of service, a lump sum of the participants' vested account balance may be distributed to the participant or beneficiary. Involuntary distributions can be made by the Company if the vested account balance is less than \$5,000.

A terminated or retired participant may elect to receive payment from their account soon after it is valued or postpone payment until a later date. If payment is postponed, the account will continue to share in investment earnings. However, payments must begin on April 1 of the year after the year in which the participant reaches 73 years of age, even if they are still working.

Upon the death of a participant before retirement or termination of employment, the current balance of such participant's individual account shall become payable as of the valuation date coincident with or next following his or her death.

In-service withdrawals and hardship withdrawals are permitted if certain criteria are met.

Forfeited Accounts

As of December 31, 2024 and 2023, there were no forfeited nonvested accounts. The balance of the forfeiture account is used to reduce future Company contributions to the Plan or to pay for administrative expenses. No amounts were applied to reduce Company contributions to the Plan for 2024 or 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

In accordance with generally accepted accounting principles, the Plan has adopted the provisions which establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition (continued)

Items carried at fair value on a recurring basis consist primarily of financial instruments which are valued primarily based on quoted prices in active or brokered markets for identical as well as similar assets and liabilities. Items carried at fair value on a non-recurring basis generally consist of assets held for sale, if applicable. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Cash: Valued at cost, which approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions and unrealized appreciation and depreciation of investments are determined using an average cost basis.

The Plan invests in mutual funds. Such investments are exposed to various risks such as market and credit risks. Due to the level of risk associated with such investments, and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. Plan assets are not FDIC insured.

Plan Expenses

The Company sponsors the Plan. Personnel within the employer organization perform certain administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are not included as Plan expenses. All expenses are paid by the Company.

Funding Policy

Contributions are funded as accrued.

Payments of Benefits

Benefit payments are recorded when paid.

3. Certified Information

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, realized losses from sales of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus Trust Company (the trustee of the Plan).

5. Related Party Transactions

Certain Plan investments are mutual funds managed by Ascensus Inc. Ascensus was the trustee defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for asset management services are paid by the Plan and/or the Plan Sponsor. Administrator expenses were \$58,174 and \$48,358 for the years ended December 31, 2024 and 2023, respectively.

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

7. Tax Status

The Plan adopted a non-standardized form of a prototype plan sponsored by Ascensus Trust Company. The prototype plan received an opinion letter from the Internal Revenue Service dated March 31, 2014. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities.

7. Tax Status (continued)

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.
