Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Denali Universal Services 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Denali Universal Services 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Denali Universal Services 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. 1) Description of plan

The following description of the Denali Universal Services 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for complete information regarding the Plan's provisions.

a) General

The Plan is a defined contribution plan sponsored by Denali Universal Services, LLC (Company or Employer). Full-time employees (as defined by the Company) are eligible to participate immediately upon hire or once they obtain age 18. Certain ineligible employees include leased employees, independent contractors and those not based in the United States of America. Employees covered by a collective bargaining agreement are eligible for employee deferrals and are excluded from receiving Employer matching contributions and profit sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

b) Participant contributions

The Plan contains an automatic enrollment feature. All new employees meeting eligibility requirements are automatically enrolled such that 3% of their compensation is withheld and contributed to the Plan, unless the employee affirmatively opts out of the Plan or changes their deferral percentage. Automatically enrolled contributions are invested in a designated balanced fund until changed by the participant. Participants may elect to contribute up to 50 percent of their compensation as defined in the Plan, subject to Internal Revenue Code regulations. Participants can direct their contributions and Employer contributions in one or more of several publicly traded mutual funds and a common collective trust offered by the Plan. In addition, a participant who has attained the age of 50 before the close of the plan year shall be eligible to make catch-up contributions in accordance with the limitations under the Code.

c) Employer contributions

Two separate accounts of the Plan exist for Employer contributions:

1) Basic matching

The Employer may make a matching contribution at its discretion. For 2024 and 2023, the Employer matching contributions were accrued by pay period in the amount of 50 percent of a participant's contribution, up to 6 percent of the participant's compensation.

2) Profit sharing

Profit sharing contributions are also made at the Employer's discretion. There were no profit sharing contributions made for the years ended December 31, 2024 and 2023.

d) Forfeitures

Forfeitures of Employer contributions are used to reduce Employer contributions. There were \$671 and \$6,506 in forfeitures available at December 31, 2024 and 2023, respectively, to offset future Employer contributions. Employer contributions were reduced by \$82,160 and \$92,185 from forfeited non-vested accounts for the years ended December 31, 2024 and 2023, respectively.

e) Participant accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1) Description of plan (continued)

f) Payment of Plan benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account either in a lump sum amount or in installment payments. Under certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, the employee contribution portion of their account balance. For termination of services with vested benefits of \$5,000 or less, a participant or beneficiary will automatically receive the value of the vested interest in his or her account as a lump-sum distribution.

g) Note receivable - participant loans

The Plan allows participants to borrow from the Plan up to the lesser of 50 percent of each participant's vested account balance or \$50,000 reduced by the excess of the participant's highest outstanding participant loan balance during the 12-month period preceding the loan. The minimum amount that can be borrowed is \$1,000. Loans must be repaid through payroll deductions with a maximum loan term of five years, unless the loan is for the purchase of a participant's primary residence. Interest rates are determined based on the prime interest rate plus 1 percent. Interest rates on the loans ranged between 4.25% and 9.5%.

h) Vesting

Participants are immediately vested in their voluntary contributions. Vesting for Employer contributions is based on years of service. A year of service is defined as 1000 hours of service within a Plan year. For participants hired on or after February 19, 2007, a participant becomes 20 percent vested after one year of service, 40 percent after two years, 60 percent after three years, 80 percent after four years and 100 percent vested in the Employer contributions after five years of credited service. If a participant dies, becomes disabled and/or reaches normal retirement age, the participant becomes 100 percent vested. Participants hired prior to February 19, 2007 are vested according to the schedule defined in the Plan documents.

2) Summary of significant accounting policies

a) Basis of accounting

The accompanying financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

b) Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 10 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

c) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

d) Payment of benefits

Benefits are recorded when paid.

e) Notes receivable – participant loans

Notes receivables from participants are measured at the unpaid balance plus unpaid accrued interest. Defaulted loans are deemed distributed and recorded as benefits paid to participants based upon the terms of the Plan document. For the years ended December 31, 2024 and 2023, deemed distributions in the amount of \$65,683 and \$83,802 respectively, were recorded as benefits paid to participants in the statements of changes in net assets available for benefits.

f) Plan and administrative expenses

Except for loan origination fees associated with notes receivable from participants and recordkeeping fees, all administrative expenses of maintaining the Plan are paid by the Employer. In addition, certain investment accounts charge asset and participant fees that are allocated among the respective participants.

3) Federal income taxes

The underlying non-standardized prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and, therefore, the related trust is tax exempt. In accordance with Revenue Procedure 2006-6, the Company has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan has been amended since receiving the letter, including amendments made to comply with recent law changes. The administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is not subject to United States federal and state income tax examinations by tax authorities beyond three years from filing of those returns.

4) Plan termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In such a case, participants would become 100 percent vested in their account and would be allocated their account balance at the time of the termination. Assets of the Plan will be distributed to participants after payment of expenses in accordance with the value credited to such participants as of the date of termination.

5) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6) Investments

During the years ended December 31, 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$3,636,271 and \$4,444,900, respectively.

7) Common collective trust

The Plan has entered into a benefit-responsive investment contract. The Morley Stable Value Fund distributes income in the form of units and provides a constant unit redemption value. The Morley Stable Value Fund invests in fully benefit-responsive investment contracts (FBRICs) and is presented at fair value based on its NAV. As a result, the Plan is an indirect investor in fully benefit-responsive investment contracts since the Plan itself does not directly invest in FBRICs. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. A common collective trust (stable value fund) issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer.

While it is possible that some of the plans participating in the trust may experience plan terminations or other events that would trigger fair value payouts under the trust's wrapper agreements, based on prior experience, management of the trust believes it is not probable that such events would be of sufficient magnitude to limit the ability of the trust to transact at contract value with the participants in the trust. Given that such events are beyond the control of the trust, however, there can be no guarantee that this will be the case.

8) Related party transactions

Certain Plan investments are managed by Charles Schwab Trust Bank that provide investment management services to the Plan. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

9) Information certified by the Plan's trustee (unaudited)

The following is a summary of the investment information regarding the Plan as of December 31, 2024 and 2023, and for the years then ended, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from information prepared by Charles Schwab Trust Bank, the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the trustee that such information is complete and accurate.

10) Fair value measurement

Financial Accounting Standards Board Statement (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820, are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for measuring assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: The Plan uses NAV per unit to value the collective investment trust funds. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.
