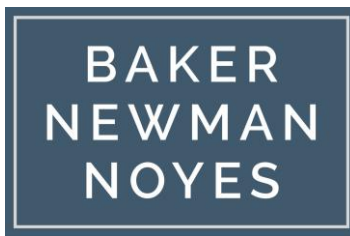

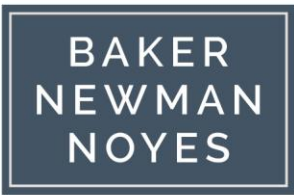

## INDEPENDENT AUDITORS' REPORT

The Plan Administrator  
Piper Shores 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Piper Shores 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### 1. Description of the Plan

The following description of the Piper Shores 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan effective February 20, 2003, amended and restated on January 1, 2022. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan covers all employees of Maine Life Care Retirement Community, Inc., d/b/a Piper Shores. Participants are eligible to participate after reaching age 21 and are eligible to receive qualified matching contributions after completing one year of service, 1,000 hours in one year, and reaching age 21.

##### Contributions

Contributions are made to participants' accounts as follows:

- Participants may elect to make pre-tax deferrals up to the maximum percentage of compensation and dollar amount permissible under Section 402(g) of the Internal Revenue Code (IRC) not to exceed the limits of IRC Sections 401(k), 404 and 415.
- Participants may elect to make Roth contributions into the Plan.
- Rollover contributions are subject to conditions stated in the Plan and in appropriate sections of the IRC.

Participants elect to have their employee deferral and their respective employer matching contributions invested in various managed funds included in the Plan which have different investment objectives.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Piper Shores' contributions and Plan earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in their voluntary contributions, all employer contributions, plus actual earnings or losses thereon.

##### Payment of Benefits

Participants are entitled to a distribution of their vested benefits upon attaining age 59 1/2 or upon separation from service. In addition, hardship withdrawals are permitted subject to certain criteria set forth in the Plan Agreement.

#### 1. **Description of the Plan (Continued)**

##### *Notes Receivable From Participants*

Participants may borrow from their accounts, excluding Roth account balances, a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear an interest rate of prime plus 2% at the date the loan is issued.

Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024, the interest rate on outstanding participant loans ranged from 5.25% to 10.5%, with maturities through 2029.

Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

##### *Plan Termination*

Although it has not expressed any intent to do so, Piper Shores has the right under the Plan to discontinue its contributions to the 401(k) plan at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, the trustees, once notified by Piper Shores of the termination date, will distribute to each participant his or her account balance on that date in accordance with the terms of the Plan.

##### *Administrative Expenses*

Piper Shores is responsible for certain administrative costs of the Plan.

#### 2. **Summary of Significant Accounting Policies**

##### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from these estimates.

#### 2. Summary of Significant Accounting Policies (Continued)

##### Investments

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are stated at contract value). See Note 5 for further discussion of fair value measurements. See Note 4 for further discussion on fully benefit responsive investment contracts.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### Contributions

Employee contributions are recorded when they are withheld from the employee's pay. Safe harbor matching employer contributions are recorded when the related compensation becomes payable.

##### Benefits

Benefits are recorded when paid.

##### Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by the Plan Administrator to determine whether such events should be recognized or disclosed in the financial statements. The Plan Administrator has evaluated subsequent events through June 18, 2025, the date the financial statements were available to be issued.

#### 3. **Information Certified by Trustees**

Plan asset information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants and investment and notes receivable transactions for the years ended December 31, 2024 and 2023, was obtained or derived from information provided to the Plan Administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC as of December 31, 2024 and 2023 and for the years then ended. Accordingly, as permitted under 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the trustees, except for comparing such information certified by the trustees to information included in the Plan's financial statements and supplemental schedule.

#### 4. **Investments – Contract Value**

The Plan invests in a group fixed annuity contract with Empower through the Key Guaranteed Portfolio Fund. The investment in this contract is stated according to the provisions of Accounting Standards Codification Topic 946, *Reporting of Fully Benefit-Responsive Investment Contracts Held by Certain Investment Companies Subject to the AICPA Investments Company Guide and Defined-Contribution Health and Welfare and Pension Plans*, which states that contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to guaranteed investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by the trustees, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The issuer, Empower Annuity Insurance Company, maintains the contributions to the Key Guaranteed Portfolio Fund in a general account. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed and may be reset on a quarterly basis.

Certain events limit the ability of the Plan to transact at contract value with the insurance company and the financial institution issuer under the group fixed annuity contract. Such events include (1) certain amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

#### 5. Fair Value Measurements

Fair value is the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value of shares (based upon quoted market price) held by the Plan at year end.

The Plan's assets carried at fair value at December 31, 2024 and 2023 consist exclusively of level 1 mutual funds totaling \$9,068,622 and \$7,225,555, respectively.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 6. Income Tax Status

Piper Shores adopted a prototype defined contribution plan and standardized profit sharing 401(k) plan. The prototype plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Code. The Plan has been amended since the most recent ruling and management believes the Plan continues to meet IRS requirements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the United States federal, state or local tax authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 7. Party-in-Interest Transactions

Certain plan investments are managed by Empower or their subsidiaries in 2024 and 2023, respectively. Therefore, these transactions qualify as party-in-interest. Administrative fees paid by the Plan to Empower in 2024 and 2023 were \$20,923 and \$23,126, respectively. In addition, the Plan pays fees to the Plan's investment advisors, Valmark Advisors, Inc., and transactions with these parties qualify as party-in-interest. Notes receivable from Plan participants, the related interest income and transactions are also considered party-in-interest transactions.

#### 8. Reconciliation of Financial Statements to Form 5500

Notes receivable from participants are reflected as a receivable on the financial statements which is different from the Form 5500 presentation. On the Form 5500, notes receivable are classified as investments under the caption "participant loans."
