**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

1 Description of Plan

The following description of the SEMA Construction, Inc. (the Company) 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General. The Plan was adopted July 21, 1991 and is a defined contribution plan sponsored by the Company. All non-union employees are eligible to enroll in the Plan immediately upon hire. The Plan is a qualified trust under Section 401(a) of the Internal Revenue Service (IRS) Code and is subject to the provisions of ERISA.
- B. Contributions. Each year, participants may contribute up to the maximum amount allowed under the IRS Code, as defined in the Plan. Participants who have attained the age of fifty before the end of the year may make catch-up contributions. The Company makes wage rate contributions to the accounts of employees who are working on jobs to which a prevailing rate schedule is applied. The Davis-Bacon Act mandates that contractors engaging in federally funded projects pay their workers no less than the locally prevailing wages and benefits. The Company may also make discretionary contributions to the accounts of employees who do not work on wage rate jobs. Employees are eligible for this type of contribution on the first day of the month after they have completed one year of service.
- C. Participant Accounts. Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses.
- D. Vesting. Participants are immediately 100% vested in participant and Company contributions plus actual earnings thereon.
- E. Investment Options. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers over twenty investment options for participants.
- F. Payment of Benefits. Benefits may be paid to participants under circumstances such as termination of employment, retirement, financial hardship, or death. Benefits may be paid as a lump sum or as installment payments over the participant's and beneficiary's life expectancy.
- G. Notes Receivable from Participants. Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account balance and are charged a reasonable rate of interest as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.
- H. Forfeited Accounts. At June 30, 2024 and 2023, there were no forfeited non-vested accounts to be used to offset future employer contributions.

2 Summary of Significant Accounting Policies

- A. Basis of Accounting. The financial statements of the Plan are prepared on the accrual basis of accounting.
- B. Use of Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C. Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.
- D. Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.
- E. Payment of Benefits. Benefits are recorded when paid.
- F. Operating Expenses. Expenses of maintaining the Plan are paid by the Company.

3 Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. The Plan is not covered under the Pension Benefit Guarantee Corporation termination insurance program.

4 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for Plan benefits.

**6** Tax Status

The IRS has determined and informed the Company, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS Code; and, therefore believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more than likely than not would not be sustained upon examination by the IRS.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to June 30, 2020.

7 Fair Value Measurements

FASB ASC 820-10-50, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 Measurements) and the lowest priority to unobservable inputs (Level 3 Measurements).

The three levels of the fair value hierarchy under FASB ASC 820-10-50 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include -

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and,
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts: Valued at Net Asset Value (NAV) of shares held by the Plan at year end.

Common/Collective Trust: The common/collective trust is a guaranteed investment contract. It is valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

**8 Group Annuity Contract with Insurance Company**

The Plan has a group annuity contract with Transamerica Life Insurance Company (Transamerica) that invests contributions in the Transamerica Stable Value Fund. The contract value was \$216,535 at June 30, 2024, respectively. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Empower.
