INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Valley Strong Credit Union 401(k) Plan and Trust subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Valley Strong Credit Union 401(k) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Valley Strong Credit Union 401(k) Plan and Trust (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Charles Schwab Trust Bank and Principal Trust Company, the trustees of Valley Strong Credit Union 401(k) Plan and Trust as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information as described in Note 9 to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by Charles Schwab Trust Bank and Principal Trust Company agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Valley Strong Credit Union 401(k) Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free of material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Valley Strong Credit Union 401(k) Plan and Trust's ability to continue as a going concern within one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining whether the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Valley Strong Credit Union 401(k) Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time non-excluded employees who are at least age 18 or older and have completed 30 days of service with Valley Strong Credit Union (the Plan Sponsor). Excluded employees are defined as leased employees or individuals considered by the Plan as independent contractors. If an employee does not complete the stated number of days, the employee is subject to a one-year service requirement. The Plan accepts rollover contributions, except former employees are not allowed to make a rollover contribution. The Plan permits participant direction of investments and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

For purposes of eligibility to participate in the Plan and vesting, the Plan follows the elapsed time method whereby the period of time that elapses while the employee is employed counts regardless of the actual number of hours the individual completes during such period.

Effective Date: The Plan became effective September 1, 2004. All non-excluded employees employed on that date were eligible to participate immediately. Former employees of Quantum Data Systems were allowed to participate in the Plan effective March 1, 2014 if they had attained age 21 and completed three months of service. Effective 2015, all non-excluded employees who have attained age 18 and have been employed for 30 days of service are eligible to participate in the Plan.

Plan Year: The plan year is the 12-consecutive-month period beginning January 1 and ending December 31. The Plan's records are maintained on this basis.

Contributions: The Plan allows participants to contribute up to 100% of their eligible compensation as defined in the Plan, up to the Internal Revenue Service (IRS) annual limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Starting in March 2015, the Plan automatically enrolls new employees with a 4% pretax contribution. The Plan Sponsor contributes a safe harbor matching contribution of 100% of the first 6% of participant deferrals. Additional discretionary employer contributions may be contributed at the option of the Plan Sponsor's Board of Directors.

For the year ended December 31, 2024, the employer safe harbor matching contributions totaled \$2,306,596.

Contributions are subject to certain limitations.

Participants may contribute amounts representing distributions from other qualified plans (rollover) and may direct the investment of contributions into various investment options offered by the Plan, subject to IRS limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contributions and (b) the Plan's earnings (losses) and forfeitures and is charged with an allocation of administrative expense paid by participants. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled are the benefits that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Vesting: Participants are immediately vested in employer matching contributions and their voluntary contributions, plus actual earnings thereon. Vesting in participants' discretionary non-elective accounts is based on years of continuous service. Effective January 1, 2015, the Plan switched to the elapsed time method for purposes of determining eligibility and vesting. A participant is vested in their discretionary contributions as follows:

Years of Service	Percentage Vested
0-1	0%
2	20%
3	40%
4	60%
5	80%
6 or more	100%

Payment of Benefits: Payment of benefits is determined based on the participant's account balance. Upon termination, if the vested account balance does not exceed \$5,000, the Plan will distribute the vested portion in a lump-sum payment as soon as practicable following the date of termination. If the vested account balance exceeds \$5,000, the Plan permits the distribution as of any date following termination of employment with the employer at the election of the participant. Upon termination of service due to death, disability or retirement, a participant will receive a cash distribution in the form of a lump-sum amount equal to the value of the participant's vested interest in their account. Amounts between \$1,000 and \$5,000 where the participant does not elect a benefit are rolled into an Individual Retirement Account. Benefits are recorded when paid.

Hardship withdrawals are allowed up to the amount of the participant's vested account resulting from elective deferral contributions and matching contributions, as well as discretionary contributions.

Investment Options: Participants may direct both employee and employer contributions to be invested among various investment options as made available and determined by the Plan Administrator, which are more fully described in the plan literature. The Plan currently offers various mutual funds, pooled separate funds, and collective investment trust funds as investment options for participants. The Plan also offers a fixed income guaranteed account. Participants may change their investment options at any time throughout the year via direct phone or internet access with the recordkeeper.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at rates equal to similar loans from commercial lending institutions. Loan terms may range from one to five years or longer if used to purchase the primary residence of the participant. Principal and interest are paid ratably through payroll deductions.

Forfeitures: As of December 31, 2024 and 2023, forfeitures from nonvested accounts totaled \$2 and \$4,604, respectively. These amounts can be used to reduce employer safe harbor matching contributions or employer discretionary contributions, or to pay reasonable plan expenses. Forfeitures amounting to \$4,922 for the year ended December 31, 2024 were used to reduce plan expenses.

Plan Administration: The Plan is administered by the Plan Sponsor. The Plan Administrator controls and manages the operation and administration of the Plan. Charles Schwab Trust Bank and Principal Trust Company serve as the trustees and recordkeepers of the Plan.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan were prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Notes Receivable from Participants: Participant loans are permitted by the Plan in accordance with its terms. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis of accounting. Related fees are charged directly to the borrowing participant's account and included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Investment Valuation and Income Recognition: Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 3 for further discussion of the investments at contract value. The Plan Administrator determines the Plan's investment valuation policies.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements: The Accounting Standards Codification establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The guidance also establishes a three-level fair value hierarchy that describes the inputs used to measure assets and liabilities.

- Level 1 asset and liability fair values are based on quoted prices in active markets for identical assets and liabilities.
- Level 2 asset and liability fair values are based on observable inputs that include quoted market prices for similar assets or liabilities, quoted market prices that are not in an active market, or other inputs that are observable in the market and can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 assets and liabilities are financial instruments whose value is calculated by the use of pricing models and/or discounted cash flow methodologies, as well as financial instruments for which the determination of fair value requires significant management judgment or estimation.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 compared to December 31, 2023.

- *Mutual Funds* – Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end. Mutual funds are classified as Level 1 measurements.
- *Collective Investment Trust Funds (CITFs)* – Valued at the NAV provided by the administrator of the fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient should not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. While CITFs are not reported on exchanges or other public means, these investments are similar to mutual funds and NAV is the basis for current transactions being published because it is available via investor online reporting. CITFs are classified as Level 2 measurements.
- *Pooled Separate Accounts (PSAs)* – Valued at the NAV provided by the administrator of the fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient should not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. While PSAs are not reported on exchanges or other public means, these investments are similar to mutual funds and NAV is the basis for current transactions being published because it is available via investor online reporting. PSAs are classified as Level 1 measurements.

The Plan Sponsor's financial instruments and other accounts that are subject to fair value measurement and/or disclosure are summarized in Note 3.

Operating Expenses: Expenses of maintaining the Plan are paid by the Plan Sponsor (see Note 5).

Benefit Payments: Benefits are recorded when paid.

Administrative Expenses: The Plan Sponsor pays the Plan's administration expenses, and participants pay withdrawal and loan fees.

Subsequent Events: The Plan Administrator has evaluated subsequent events through July 14, 2025, the date the financial statements were available to be issued.

Gains and losses (realized and unrealized) included in changes in net assets available for plan benefits for the year ended December 31, 2024 are reported under net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

NOTE 4 – RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST

Charles Schwab Trust Bank and Principal Trust Company are the trustees and third-party administrators of the Plan. Therefore, transactions with the trustees qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$17,219 for the year ended December 31, 2024.

The Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. These services constitute exempt party-in-interest transactions under ERISA.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

NOTE 6 – TAX STATUS

Effective November 1, 2022, the Plan canceled its agreement with Principal Trust Company and Principal Life Insurance Company (except for the pooled separate account totaling \$7,266 and \$34,578 as of December 31, 2024 and 2023, respectively) as its trustee and recordkeeper and signed a new agreement with Charles Schwab Trust Bank as its new trustee and recordkeeper. Therefore, the Plan Sponsor has adopted the Schwab Retirement Plan Services Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA, which received a favorable opinion letter from the IRS on September 21, 2020. A favorable determination letter indicates that the form of the Plan is qualified under the applicable requirements of the Internal Revenue Code (IRC) and is exempt from taxation. Although the Plan has been amended since the adoption, the Plan Administrator believes that the Plan was designed and is currently being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax exempt.

US GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

The Plan is required to disclose significant concentrations of credit risk regardless of the degree of such risk. As of December 31, 2024 and 2023, the financial instruments that potentially subject the Plan to a concentration of credit risk consist principally of cash, investments and participant loans.

NOTE 8 – TRUSTEE CERTIFICATION

The investment balances and related investment information included in the financial statements, accompanying notes and supplemental schedule, summarized below, were derived from statements certified by Charles Schwab Trust Bank and Principal Trust Company, the trustees of the Plan, as complete and accurate in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA.
